Accomplice as a Noun

Definitions of "Accomplice" as a noun

According to the [Oxford Dictionary of English](#), “accomplice” as a noun can have the following definitions:

- *A person who joins with another in carrying out some plan (especially an unethical or illegal plan).*
- *A person who helps another commit a crime.*



Synonyms of "Accomplice" as a noun (7 Words)

abetter	One who helps or encourages or incites another.
accessory	Someone who helps another person commit a crime. <i>She was charged as an accessory to murder.</i>
associate	A person who joins with others in some activity or endeavor. <i>A close associate of the Minister.</i>
collaborator	Someone who collaborates with an enemy occupying force. <i>He was a collaborator during the occupation.</i>
<u>confederate</u>	Someone who assists in a plot. <i>Where was his confederate the girl who had stolen Richard's wallet.</i>
fellow conspirator	An informal form of address for a man.
partner in crime	An associate in an activity or endeavor or sphere of common interest.



Usage Examples of "Accomplice" as a noun

- *An accomplice in the murder.*



Associations of "Accomplice" (30 Words)

allegation	Statements affirming or denying certain matters of fact that you are prepared to prove. <i>Allegations that the army was operating a shoot to kill policy.</i>
allege	Claim or assert that someone has done something illegal or wrong, typically without proof. <i>He alleged that he was the victim of a crime.</i>
allied	Joined by treaty or agreement. <i>Allied territories.</i>
<u>amnesty</u>	An undertaking by the authorities to take no action against specified offences during a fixed period. <i>An amnesty for political prisoners.</i>
arrest	Suffer a heart attack. <i>A respiratory arrest.</i>

<u>assassin</u>	A member of a secret order of Muslims (founded in the 12th century) who terrorized and killed Christian Crusaders. <i>His assassins were hunted down like animals.</i>
assassination	Murder of a public figure by surprise attack. <i>A failed assassination attempt.</i>
<u>collusion</u>	Collusion between ostensible opponents in a lawsuit. <i>The armed forces were working in collusion with drug traffickers.</i>
complicity	The fact or condition of being involved with others in an activity that is unlawful or morally wrong. <i>They were accused of complicity in the attempt to overthrow the government.</i>
<u>confederate</u>	A supporter of the Confederate States of America. <i>Some local groups united to form confederate councils.</i>
connivance	Willingness to allow or be secretly involved in an immoral or illegal act. <i>This infringement of the law had taken place with the connivance of officials.</i>
<u>conspiracy</u>	The action of plotting or conspiring. <i>A conspiracy to destroy the government.</i>
conspirator	A person who takes part in a conspiracy. <i>Conspirators had planned to seize the state.</i>
<u>conspire</u>	Make secret plans jointly to commit an unlawful or harmful act. <i>The two companies conspired to cause the value of the stock to fall.</i>
<u>cooperative</u>	A farm, business, or other organization which is owned and run jointly by its members, who share the profits or benefits. <i>We run the agency as a workers cooperative.</i>
<u>crime</u>	An action or activity considered to be evil, shameful, or wrong. <i>It s a crime to keep a creature like Willy in a tank.</i>
entangle	Twist together or entwine into a confusing mass. <i>Fish attempt to swim through the mesh and become entangled.</i>
evidence	Provide evidence for. <i>The evidence that smoking causes lung cancer is very compelling.</i>
fraud	A person or thing intended to deceive others, typically by unjustifiably claiming or being credited with accomplishments or qualities. <i>Prosecutions for social security frauds.</i>
henchman	A faithful follower or political supporter, especially one prepared to engage in crime or violence by way of service. <i>The dictator s henchman.</i>

homicide	The unlawful killing of one person by another. <i>He was charged with homicide.</i>
<u>implicate</u>	Impose, involve, or imply as a necessary accompaniment or result. <i>Viruses are known to be implicated in the development of certain cancers.</i>
include	Allow (someone) to share in an activity or privilege. <i>There were doubts as to whether she was included in the invitation.</i>
<u>involve</u>	Make complex or intricate or complicated. <i>This decision involves many changes.</i>
<u>liability</u>	A thing for which someone is responsible, especially an amount of money owed. <i>Once you contact the card protection scheme your liability for any loss ends.</i>
<u>perpetrate</u>	Perform an act, usually with a negative connotation. <i>A crime has been perpetrated against a sovereign state.</i>
<u>suspicion</u>	An impression that something might be the case. <i>A suspicion of a smile.</i>
<u>testimony</u>	An assertion offering firsthand authentication of a fact. <i>His blackened finger was testimony to the fact that he had played in pain.</i>
<u>united</u>	Characterized by unity; being or joined into a single entity. <i>Presented a united front.</i>
