## Accomplice as a Noun

### Definitions of "Accomplice" as a noun

According to the [Oxford Dictionary of English](#), “accomplice” as a noun can have the following definitions:

- *A person who joins with another in carrying out some plan (especially an unethical or illegal plan).*
- *A person who helps another commit a crime.*



## Synonyms of "Accomplice" as a noun (7 Words)

<b>abetter</b>	One who helps or encourages or incites another.
<b>accessory</b>	Someone who helps another person commit a crime. <i>She was charged as an <b>accessory</b> to murder.</i>
<b>associate</b>	A person who joins with others in some activity or endeavor. <i>A close <b>associate</b> of the Minister.</i>
<b>collaborator</b>	Someone who collaborates with an enemy occupying force. <i>He was a <b>collaborator</b> during the occupation.</i>
<b><a href="#">confederate</a></b>	Someone who assists in a plot. <i>Where was his <b>confederate</b> the girl who had stolen Richard's wallet.</i>
<b>fellow conspirator</b>	An informal form of address for a man.
<b>partner in crime</b>	An associate in an activity or endeavor or sphere of common interest.



## Usage Examples of "Accomplice" as a noun

- *An accomplice in the murder.*



## Associations of "Accomplice" (30 Words)

<b>allegation</b>	Statements affirming or denying certain matters of fact that you are prepared to prove. <i>Allegations that the army was operating a shoot to kill policy.</i>
<b>allege</b>	Claim or assert that someone has done something illegal or wrong, typically without proof. <i>He <b>alleged</b> that he was the victim of a crime.</i>
<b>allied</b>	Joined by treaty or agreement. <i><b>Allied</b> territories.</i>
<b><u>amnesty</u></b>	An undertaking by the authorities to take no action against specified offences during a fixed period. <i>An <b>amnesty</b> for political prisoners.</i>
<b>arrest</b>	Suffer a heart attack. <i>A respiratory <b>arrest</b>.</i>

<b><u>assassin</u></b>	A member of a secret order of Muslims (founded in the 12th century) who terrorized and killed Christian Crusaders. <i>His <b>assassins</b> were hunted down like animals.</i>
<b>assassination</b>	Murder of a public figure by surprise attack. <i>A failed <b>assassination</b> attempt.</i>
<b><u>collusion</u></b>	Collusion between ostensible opponents in a lawsuit. <i>The armed forces were working in <b>collusion</b> with drug traffickers.</i>
<b>complicity</b>	The fact or condition of being involved with others in an activity that is unlawful or morally wrong. <i>They were accused of <b>complicity</b> in the attempt to overthrow the government.</i>
<b><u>confederate</u></b>	A supporter of the Confederate States of America. <i>Some local groups united to form <b>confederate</b> councils.</i>
<b>connivance</b>	Willingness to allow or be secretly involved in an immoral or illegal act. <i>This infringement of the law had taken place with the <b>connivance</b> of officials.</i>
<b><u>conspiracy</u></b>	The action of plotting or conspiring. <i>A <b>conspiracy</b> to destroy the government.</i>
<b>conspirator</b>	A person who takes part in a conspiracy. <i><b>Conspirators</b> had planned to seize the state.</i>
<b><u>conspire</u></b>	Make secret plans jointly to commit an unlawful or harmful act. <i>The two companies <b>conspired</b> to cause the value of the stock to fall.</i>
<b><u>cooperative</u></b>	A farm, business, or other organization which is owned and run jointly by its members, who share the profits or benefits. <i>We run the agency as a workers <b>cooperative</b>.</i>
<b><u>crime</u></b>	An action or activity considered to be evil, shameful, or wrong. <i>It s a <b>crime</b> to keep a creature like Willy in a tank.</i>
<b>entangle</b>	Twist together or entwine into a confusing mass. <i>Fish attempt to swim through the mesh and become <b>entangled</b>.</i>
<b>evidence</b>	Provide evidence for. <i>The <b>evidence</b> that smoking causes lung cancer is very compelling.</i>
<b>fraud</b>	A person or thing intended to deceive others, typically by unjustifiably claiming or being credited with accomplishments or qualities. <i>Prosecutions for social security <b>frauds</b>.</i>
<b>henchman</b>	A faithful follower or political supporter, especially one prepared to engage in crime or violence by way of service. <i>The dictator s <b>henchman</b>.</i>

<b>homicide</b>	The unlawful killing of one person by another. <i>He was charged with <b>homicide</b>.</i>
<b><u>implicate</u></b>	Impose, involve, or imply as a necessary accompaniment or result. <i>Viruses are known to be <b>implicated</b> in the development of certain cancers.</i>
<b>include</b>	Allow (someone) to share in an activity or privilege. <i>There were doubts as to whether she was <b>included</b> in the invitation.</i>
<b><u>involve</u></b>	Make complex or intricate or complicated. <i>This decision <b>involves</b> many changes.</i>
<b><u>liability</u></b>	A thing for which someone is responsible, especially an amount of money owed. <i>Once you contact the card protection scheme your <b>liability</b> for any loss ends.</i>
<b><u>perpetrate</u></b>	Perform an act, usually with a negative connotation. <i>A crime has been <b>perpetrated</b> against a sovereign state.</i>
<b><u>suspicion</u></b>	An impression that something might be the case. <i>A <b>suspicion</b> of a smile.</i>
<b><u>testimony</u></b>	An assertion offering firsthand authentication of a fact. <i>His blackened finger was <b>testimony</b> to the fact that he had played in pain.</i>
<b><u>united</u></b>	Characterized by unity; being or joined into a single entity. <i>Presented a <b>united</b> front.</i>
