| charge | The price charged for some article or service. <i>I have therefore laid down the charge which was placed upon me.</i> |
| claim | An assertion of a right (as to money or property). <i>Each of them was to be rewarded with a farm and a number of mining claims in the land.</i> |

| <u>contention</u> | Heated disagreement. <i>Freud s contention that all dreams were wish fulfilment.</i> |
| <u>declaration</u> | A statement of taxable goods or of dutiable properties. <i>His declaration of innocence.</i> |
| <u>plea</u> | A formal statement by or on behalf of a defendant or prisoner, stating guilt or innocence in response to a charge, offering an allegation of fact, or claiming that a point of law should apply. <i>Her plea of a headache was not entirely false.</i> |
| statement | A fact or assertion offered as evidence that something is true. <i>A tattoo can be more than just a fashion statement it has potential medical value.</i> |
| submission | The action of presenting a proposal, application, or other document for consideration or judgement. <i>They were forced into submission.</i> |
| <u>testimony</u> | An assertion offering firsthand authentication of a fact. <i>According to his own testimony he can t do it.</i> |

| explicit | Of a person stating something in an explicit manner. <i>She made her wishes explicit.</i> |
| fealty | Formal acknowledgement of loyalty to a lord. <i>They owed fealty to the Earl rather than the King.</i> |
| file | Smooth with a file. <i>What progress has the Prime Minister made on the unity file.</i> |
| imprecation | A spoken curse. <i>He suffered the imprecations of the mob.</i> |
| invective | Insulting, abusive, or highly critical language. <i>He let out a stream of invective.</i> |
| malediction | A magical word or phrase uttered with the intention of bringing about evil; a curse. <i>He muttered maledictions to himself as he trod the stone passages.</i> |
| manifesto | A public declaration of intentions (as issued by a political party or government). <i>A manifesto for gay liberation.</i> |
| oath | A commitment to tell the truth especially in a court of law to lie under oath is to become subject to prosecution for perjury. <i>Each took the oath and then gave evidence.</i> |
| perforce | By necessity; by force of circumstance. <i>Amateurs perforce have to settle for less expensive solutions.</i> |
| pledge | Bind or secure by a pledge. <i>The Prime Minister pledged that there would be no increase in VAT.</i> |
| proclaim | Declare formally; declare someone to be something; of titles. <i>His high intelligent forehead proclaimed a strength of mind that was almost tangible.</i> |
| profess | Practice as a profession teach or claim to be knowledgeable about. <i>He had professed his love for her only to walk away.</i> |
| promise | Make a promise or commitment. <i>I'll bring it straight back she promised.</i> |
| salutation | Word of greeting used to begin a letter. <i>He raised his glass in salutation.</i> |
| salute | Make a formal salute to. <i>A terrible stench saluted our nostrils.</i> |

| statutory | Prescribed or authorized by or punishable under a statute. <i>The statutory Christmas phone call to his mother.</i> |
| swear | An offensive word used especially to express anger a swear word. <i>Before God I swear I am innocent.</i> |
| troth | Faith or loyalty when pledged in a solemn agreement or undertaking. <i>A token of troth.</i> |
| vassalage | The state of a serf. |
| vow | Dedicate to a deity by a vow. <i>I vowed myself to this enterprise.</i> |
