### Definitions of "Affidavit" as a noun

- *Written declaration made under oath; a written statement sworn to be true before someone legally authorized to administer an oath.*
- *A written statement confirmed by oath or affirmation, for use as evidence in court.*

### Synonyms of "Affidavit" as a noun (11 Words)

<b>allegation</b>	(law) a formal accusation against somebody (often in a court of law). <i>An <b>allegation</b> of malpractice.</i>
<b>attestation</b>	A declaration that something exists or is the case. <i>Their vocabulary is no <b>attestation</b> to your value as a parent.</i>
<b>avowal</b>	A statement asserting the existence or the truth of something.
<b>charge</b>	The price charged for some article or service. <i>I have therefore laid down the <b>charge</b> which was placed upon me.</i>
<b>claim</b>	An assertion of a right (as to money or property). <i>Each of them was to be rewarded with a farm and a number of mining <b>claims</b> in the land.</i>

<b><u>contention</u></b>	Heated disagreement. <i>Freud s <b>contention</b> that all dreams were wish fulfilment.</i>
<b><u>declaration</u></b>	A statement of taxable goods or of dutiable properties. <i>His <b>declaration</b> of innocence.</i>
<b><u>plea</u></b>	A formal statement by or on behalf of a defendant or prisoner, stating guilt or innocence in response to a charge, offering an allegation of fact, or claiming that a point of law should apply. <i>Her <b>plea</b> of a headache was not entirely false.</i>
<b>statement</b>	A fact or assertion offered as evidence that something is true. <i>A tattoo can be more than just a fashion <b>statement</b> it has potential medical value.</i>
<b>submission</b>	The action of presenting a proposal, application, or other document for consideration or judgement. <i>They were forced into <b>submission</b>.</i>
<b><u>testimony</u></b>	An assertion offering firsthand authentication of a fact. <i>According to his own <b>testimony</b> he can t do it.</i>

<b><u>affirm</u></b>	To declare or affirm solemnly and formally as true. <i>The referendum <b>affirmed</b> the republic s right to secede.</i>
<b>anathematize</b>	Curse; condemn. <i>He <b>anathematized</b> them as bloody scroungers.</i>
<b>avow</b>	To declare or affirm solemnly and formally as true. <i>He <b>avowed</b> his change of faith.</i>
<b>betroth</b>	Give to in marriage. <i>In no time I shall be <b>betrothed</b> to Isabel.</i>
<b>billingsgate</b>	Foul-mouthed or obscene abuse.
<b>blaspheme</b>	Utter obscenities or profanities. <i><b>Blaspheme</b> God.</i>
<b>consecrate</b>	Appoint to a clerical posts. <i>A life <b>consecrated</b> to science.</i>
<b><u>document</u></b>	Support or accompany with documentation. <i>Teaching resources that are <b>documented</b> clearly and comprehensively.</i>

<b>engagement</b>	Contact by fitting together. <i>The war's most significant <b>engagements</b> were fought to keep these sea lanes open.</i>
<b>explicit</b>	Of a person stating something in an explicit manner. <i>She made her wishes <b>explicit</b>.</i>
<b>fealty</b>	Formal acknowledgement of loyalty to a lord. <i>They owed <b>fealty</b> to the Earl rather than the King.</i>
<b>file</b>	Smooth with a file. <i>What progress has the Prime Minister made on the unity <b>file</b>.</i>
<b>imprecation</b>	A spoken curse. <i>He suffered the <b>imprecations</b> of the mob.</i>
<b>invective</b>	Insulting, abusive, or highly critical language. <i>He let out a stream of <b>invective</b>.</i>
<b>malediction</b>	A magical word or phrase uttered with the intention of bringing about evil; a curse. <i>He muttered <b>maledictions</b> to himself as he trod the stone passages.</i>
<b>manifesto</b>	A public declaration of intentions (as issued by a political party or government). <i>A <b>manifesto</b> for gay liberation.</i>
<b>oath</b>	A commitment to tell the truth especially in a court of law to lie under oath is to become subject to prosecution for perjury. <i>Each took the <b>oath</b> and then gave evidence.</i>
<b>perforce</b>	By necessity; by force of circumstance. <i>Amateurs <b>perforce</b> have to settle for less expensive solutions.</i>
<b>pledge</b>	Bind or secure by a pledge. <i>The Prime Minister <b>pledged</b> that there would be no increase in VAT.</i>
<b>proclaim</b>	Declare formally; declare someone to be something; of titles. <i>His high intelligent forehead <b>proclaimed</b> a strength of mind that was almost tangible.</i>
<b>profess</b>	Practice as a profession teach or claim to be knowledgeable about. <i>He had <b>professed</b> his love for her only to walk away.</i>
<b>promise</b>	Make a promise or commitment. <i>I'll bring it straight back she <b>promised</b>.</i>
<b>salutation</b>	Word of greeting used to begin a letter. <i>He raised his glass in <b>salutation</b>.</i>
<b>salute</b>	Make a formal salute to. <i>A terrible stench <b>saluted</b> our nostrils.</i>

<b>statutory</b>	Prescribed or authorized by or punishable under a statute. <i>The <b>statutory</b> Christmas phone call to his mother.</i>
<b>swear</b>	An offensive word used especially to express anger a swear word. <i>Before God I <b>swear</b> I am innocent.</i>
<b>troth</b>	Faith or loyalty when pledged in a solemn agreement or undertaking. <i>A token of <b>troth</b>.</i>
<b>vassalage</b>	The state of a serf.
<b>vow</b>	Dedicate to a deity by a vow. <i>I <b>vowed</b> myself to this enterprise.</i>
<b>welcome</b>	Bid welcome to greet upon arrival. <i>Made the children feel <b>welcome</b>.</i>
