Alias as a Noun

Definitions of "Alias" as a noun

According to the [Oxford Dictionary of English](#), “alias” as a noun can have the following definitions:

- *A name that has been assumed temporarily.*
- *An alternative name or label that refers to a file, command, address, or other item, and can be used to locate or access it.*
- *Each of a set of signal frequencies which, when sampled at a given uniform rate, would give the same set of sampled values, and thus might be incorrectly substituted for one another when reconstructing the original signal.*
- *A false or assumed identity.*

Synonyms of "Alias" as a noun (5 Words)

false name A language unit by which a person or thing is known.

incognito An assumed or false identity.
*She is locked in her **incognito**.*

nickname A familiar or humorous name given to a person or thing instead of or as well as the real name.
*The **nickname** for the U S Constitution is Old Ironsides.*

pseudonym A fictitious name used when the person performs a particular social role.
*I wrote under the **pseudonym** of Evelyn Hervey.*

A person's nickname.
sobriquet *She was a vast and haughty person who answered to the **sobriquet** Duchesse.*

- *A spy operating under the alias Barsad.*

Alias as an Adverb

Definitions of "Alias" as an adverb

According to the [Oxford Dictionary of English](#), "alias" as an adverb can have the following definitions:

- *Used to indicate that a named person is also known or more familiar under another specified name.*
- *As known or named at another time or place.*

Synonyms of "Alias" as an adverb (5 Words)

a.k.a. As known or named at another time or place.
also called In addition.
also known as In addition.
otherwise In a different way.
*She thought **otherwise**.*
otherwise known as In other respects or ways.

Usage Examples of "Alias" as an adverb

- *Mr. Smith, alias Mr. Lafayette.*
- *Eric Blair, alias George Orwell.*

Associations of "Alias" (30 Words)

alphabetically	In alphabetical order. <i>Books are now arranged alphabetically by author.</i>
cognomen	The name used to identify the members of a family (as distinguished from each member's given name).
criminal	Bringing or deserving severe rebuke or censure. <i>They are charged with conspiracy to commit criminal damage.</i>
crook	A long staff with one end being hook shaped. <i>Some pretty crook things went on there.</i>
dub	The new sounds added by dubbing. <i>Prewaxed thread has dramatically eased the process of dubbing.</i>
<u>epithet</u>	An epithet used as a term of abuse. <i>People jeered and hurled racial epithets.</i>
factitious	Not produced by natural forces. <i>A largely factitious national identity.</i>
fake	Not genuine; imitation or counterfeit. <i>He faked the signature.</i>
<u>faux</u>	Not genuine or real; being an imitation of the genuine article. <i>Their faux concern for the well being of the voters didn't fool many.</i>
feigned	Not genuine. <i>Her eyes widened with feigned shock.</i>
felon	A person who has committed a felony. <i>The felon undermining hand of dark corruption.</i>
fraud	A person who makes deceitful pretenses. <i>He was convicted of fraud.</i>
given	(of a document) signed and dated. <i>At a couture house attentive service is a given.</i>
illegal	Prohibited by law or by official or accepted rules. <i>An illegal chess move.</i>

illegality	The state of being contrary to or forbidden by law, especially criminal law. <i>Proceedings will be required to establish the illegality of the act.</i>
incognito	With your identity concealed. <i>She is locked in her incognito.</i>
malefactor	A person who commits a crime or some other wrong.
<u>moniker</u>	A familiar name for a person (often a shortened version of a person's given name). <i>His real moniker is Dave Kennedy.</i>
<u>name</u>	Of the Speaker mention a Member of Parliament by name as disobedient to the chair and thereby subject to a ban from the House. <i>They studied all the great names in the history of France.</i>
patronymic	Of or derived from a personal or family name. <i>A patronymic derived from the name of their original lordship.</i>
<u>perpetrate</u>	Perform an act, usually with a negative connotation. <i>Perpetrate a crime.</i>
phony	A person who professes beliefs and opinions that he or she does not hold in order to conceal his or her real feelings or motives.
<u>pseudonym</u>	A fictitious name used when the person performs a particular social role. <i>I wrote under the pseudonym of Evelyn Hervey.</i>
rob	Take something away by force or without the consent of the owner. <i>Someone had robbed my jacket.</i>
simulated	Not genuine or real; being an imitation of the genuine article. <i>She howled in simulated anguish.</i>
sobriquet	A person's nickname. <i>She was a vast and haughty person who answered to the sobriquet Duchesse.</i>
spurious	Born out of wedlock. <i>A spurious work of art.</i>
surname	Give a surname to. <i>Simeon of the pillar by surname Stylites.</i>
unlawful	Having no legally established claim. <i>Unlawful love.</i>
