- *An amount added or deducted on the basis of qualifying circumstances.*
- *A sum of money paid regularly to a person to meet needs or expenses.*
- *A permissible difference; allowing some freedom to move within limits.*
- *A sum granted as reimbursement for expenses.*

- *An amount of money that can be earned or received free of tax.*

adjustment	The process of adapting to something (such as environmental conditions). <i>For many couples there may need to be a period of adjustment.</i>
allocation	The act of distributing by allotting or apportioning; distribution according to a plan. <i>Ticket allocation.</i>
allotment	A share set aside for a specific purpose. <i>The allotment of equity securities.</i>
allowance account	A permissible difference; allowing some freedom to move within limits.

annuity	Income from capital investment paid in a series of regular payments. <i>An annuity scheme.</i>
benefit	A payment made by the state or an insurance scheme to someone entitled to receive it. <i>The social season was highlighted by debutante balls and charity benefits.</i>
concession	The act of conceding or yielding. <i>Tax concessions.</i>
consideration	A payment or reward. <i>Companies should show more consideration for their employees.</i>
contribution	A gift or payment to a common fund or collection. <i>The agency is mainly financed from voluntary contributions.</i>
decrease	The amount by which something decreases. <i>There was a decrease in his temperature as the fever subsided.</i>
deduction	Reasoning from the general to the particular (or from cause to effect). <i>The detective must uncover the murderer by deduction from facts.</i>
discount	Interest on an annual basis deducted in advance on a loan. <i>We introduced a standard level of discount for everyone.</i>
expenses	Amounts paid for goods and services that may be currently tax deductible (as opposed to capital expenditures). <i>He kept a careful record of his expenses at the meeting.</i>
grant	A right or privilege that has been granted. <i>A research grant.</i>
handout	A quantity of financial or other material aid given to a person or organization. <i>Dependence on central government handouts.</i>
helping	An individual quantity of food or drink taken as part of a meal. <i>There will be enough for six helpings.</i>
keep	The financial means whereby one lives. <i>The Society are paying for your keep.</i>
leeway	The sideways drift of a ship to leeward of the desired course. <i>The leeway is only about 2.</i>
limit	Final or latest limiting point. <i>There are limits on the amount you can bet.</i>
lot	A plot of land assigned for sale or for a particular use. <i>An inefficient lot our Council.</i>

maintenance	Means of maintenance of a family or group. <i>Crucial conditions for the maintenance of democratic government.</i>
margin	A line ruled on paper to mark off a margin. <i>He jotted a note in the margin.</i>
payment	The act of paying money. <i>A suit with a velvet collar that I got as payment for being in the show.</i>
pension	A regular payment to a person that is intended to allow them to subsist without working. <i>The company pension scheme.</i>
permitted amount	A legal document giving official permission to do something.
permitted quantity	Large game fish; found in waters of the West Indies.
pocket money	A supply of money.
<u>portion</u>	Something determined in relation to something that includes it. <i>Success that was her portion.</i>
quota	A limited quantity of a particular product which under official controls can be produced, exported, or imported. <i>All the salesmen met their quota for the month.</i>
ration	A fixed amount of a commodity officially allowed to each person during a time of shortage, as in wartime. <i>Holidaymakers who like a generous ration of activity.</i>
rebate	A rectangular groove made to hold two pieces together. <i>You will be entitled to a 20 per cent rebate off each standard fare.</i>
reduction	The act of reducing complexity. <i>The reaction is limited to reduction to the hydrocarbon.</i>
refund	The act of returning money received previously. <i>You may be allowed to claim a refund of the tax.</i>
remittance	A sum of money sent in payment or as a gift. <i>Remittance may be made by credit card.</i>
repayment	Payment of a debt or obligation. <i>Minimum monthly repayments.</i>
share	A sharp steel wedge that cuts loose the top layer of soil. <i>She s done more than her fair share of globetrotting.</i>
<u>slice</u>	A wound made by cutting. <i>A slice of bread.</i>
<u>stipend</u>	A sum of money allotted on a regular basis; usually for some specific purpose.

<u>subsidy</u>	A sum of money granted to support an undertaking held to be in the public interest. <i>She was anxious about her Arts Council subsidy.</i>
<u>subsistence</u>	The state of remaining in force or effect. <i>Farming is a hard means of subsistence.</i>
sum of money	A quantity of money.
tolerance	The capacity to endure continued subjection to something such as a drug or environmental conditions without adverse reaction. <i>The tolerance of corruption.</i>
<u>upkeep</u>	The process of keeping something in good condition. <i>Payments for the children s upkeep.</i>
valuation account	An appraisal of the value of something.
valuation reserve	An appraisal of the value of something.
weighting	An allocated proportion of something. <i>Each score is then multiplied by the appropriate weighting giving a weighted score.</i>

acquisition	The act of contracting or assuming or acquiring possession of something. <i>The company intends to grow within itself rather than by acquisition.</i>
annuitant	The recipient of an annuity.
cash	Exchange for cash. <i>There is a desperate shortage of hard cash.</i>
compensation	The action or process of awarding compensation. <i>Send your CV and current compensation to Executive Search Consultant.</i>
contribution	A voluntary gift (as of money or service or ideas) made to some worthwhile cause. <i>He expected his contribution to be repaid with interest.</i>
deserved	Properly deserved. <i>A deserved standing ovation.</i>
earn	Earn on some commercial or business transaction earn as salary or wages. <i>She earns a lot in her new job.</i>
earned	Gained or acquired; especially through merit or as a result of effort or action. <i>An earned run in baseball.</i>
gain	Rise in rate or price. <i>Shares showed gains of up to 21 per cent.</i>
grantor	A person or institution that makes a grant or conveyance. <i>Conveyed from grantor to grantee.</i>
gratuity	A relatively small amount of money given for services rendered (as by a waiter). <i>An end of contract gratuity of 20 of the total pay received.</i>
halve	Divide by two divide into halves. <i>Halve the aubergine lengthways.</i>

have	Have sex with. <i>Have throw or make a party.</i>
<u>income</u>	Money received, especially on a regular basis, for work or through investments. <i>Figures showed an overall increase in income this year.</i>
money	Wealth reckoned in terms of money. <i>He changed his money into francs.</i>
procure	Obtain (someone) as a prostitute for another person. <i>He procured extra cigarettes even though they were rationed.</i>
property	Shares or investments in property. <i>Self confidence is not an endearing property.</i>
purchase	Something acquired by purchase. <i>The victory was purchased by the death of Rhiwallon.</i>
<u>revenue</u>	The department of the civil service collecting state revenue. <i>When the revenue makes a demand for tax that demand is implicitly backed by the powers of the state.</i>
riches	An abundance of material possessions and resources. <i>The riches of the Serbian oral tradition.</i>
<u>scholarship</u>	Profound scholarly knowledge. <i>The intellectual dishonesty has nothing to do with lack of scholarship.</i>
<u>stipend</u>	A fixed regular sum paid as a salary or as expenses to a clergyman, teacher, or public official.
sumptuary	Relating to or denoting laws that limit private expenditure on food and personal items. <i>Sumptuary laws discouraging construction of large houses on small plots.</i>
tolerance	A disposition to allow freedom of choice and behavior. <i>250 parts in his cars were made to tolerances of one thousandth of an inch.</i>
valuation	An estimation of the worth of something, especially one carried out by a professional valuer. <i>The valuation of this property is much too high.</i>
vat	Place or treat in a vat. <i>The grapes are vatted for between 15 and 21 days and then aged in small barrels.</i>
wangle	Manage to obtain (something) by persuading or cleverly manipulating someone. <i>I wangled an invitation to her party.</i>
