## **Amendment as a Noun**

### **Definitions of "Amendment" as a noun**

According to the [Oxford Dictionary of English](#), “amendment” as a noun can have the following definitions:

- *The act of amending or correcting.*
- *A minor change or addition designed to improve a text, piece of legislation, etc.*
- *An article added to the US Constitution.*
- *A statement that is added to or revises or improves a proposal or document (a bill or constitution etc.*
- *Something which is added to soil in order to improve its texture or fertility.*



## Synonyms of "Amendment" as a noun (7 Words)

- adaptation** A written work (as a novel) that has been recast in a new form.  
*Living in groups is an **adaptation** to increase the efficiency of hunting.*
- adjustment** The process of adapting to something (such as environmental conditions).  
*I ve made a few **adjustments** to my diet.*
- alteration** An event that occurs when something passes from one state or phase to another.  
***Alterations** had to be made.*
- change** Money given in exchange for the same sum in larger units.  
*The **change** of government had no impact on the economy.*
- modification** A change made.  
*The parts supplied should fit with little or no **modification**.*
- qualification** The qualification stage of a sporting event.  
*I left school at 15 with no **qualifications**.*

**revision**

The act of revising or altering (involving reconsideration and modification).  
*A **revision** of the Hegelian concept of history.*



## Usage Examples of "Amendment" as a noun

- *An amendment to existing bail laws.*
- *You can add some soil-texturizing amendments to improve soil drainage.*
- *The First Amendment.*



## Associations of "Amendment" (30 Words)

### amend

Make amendments to.

***Amend** your soil with peat moss or compost.*

### authority

The confidence resulting from personal expertise.

*He has the **authority** to issue warrants.*

### constitution

The constitution written at the Constitutional Convention in Philadelphia in 1787 and subsequently ratified by the original thirteen states.

*The **constitution** of a PTA group last year.*

<b><u>constitutional</u></b>	Constitutional in the structure of something especially your physical makeup. <i>She went out for a <b>constitutional</b>.</i>
<b>decriminalize</b>	Make legal. <i>A battle to <b>decriminalize</b> cannabis.</i>
<b>enable</b>	Make (something) possible. <i>Each of them has wheels to <b>enable</b> easy transportation.</i>
<b>enabling</b>	Providing legal power or sanction. <i>An <b>enabling</b> resolution.</i>
<b>enact</b>	Put into practice (an idea or suggestion). <i>Walkers stopped to watch aware that some tragedy was being <b>enacted</b>.</i>
<b>enactment</b>	An instance of acting something out. <i><b>Enactments</b> covering food safety.</i>
<b>enforcement</b>	The act of compelling observance of or compliance with a law, rule, or obligation. <i>The strict <b>enforcement</b> of environmental regulations.</i>
<b>extraterritorial</b>	(of a law or decree) valid outside a country's territory. <i><b>Extraterritorial</b> industrial zones.</i>
<b>jurisdiction</b>	(law) the right and power to interpret and apply the law. <i>The English court had no <b>jurisdiction</b> over the defendants.</i>
<b>jurisprudence</b>	The collection of rules imposed by authority. <i>American <b>jurisprudence</b>.</i>
<b><u>law</u></b>	An individual rule as part of a system of law. <i>They were taken to court for breaking the <b>law</b>.</i>
<b><u>lawful</u></b>	Of a child born within a lawful marriage. <i>The true and <b>lawful</b> king.</i>
<b>legal</b>	Relating to theological legalism. <i>A <b>legal</b> pass receiver.</i>
<b>legality</b>	The quality or state of being in accordance with the law. <i>Documentation testifying to the <b>legality</b> of the arms sale.</i>
<b>legalize</b>	Make legal. <i>The Swiss parliament <b>legalized</b> cannabis.</i>
<b>legislation</b>	The process of making or enacting laws. <i>It will require <b>legislation</b> to change this situation.</i>
<b>legitimate</b>	Show or affirm to be just and legitimate. <i>The <b>legitimate</b> theatre.</i>

<b>legitimately</b>	In a way that can be defended with logic or justification; fairly. <i>A <b>legitimately</b> elected government.</i>
<b>licit</b>	Not forbidden; lawful. <i>Usage patterns differ between <b>licit</b> and <b>illicit</b> drugs.</i>
<b>ordinance</b>	A religious rite. <i>His strict observance of religious <b>ordinances</b> was no doubt quickened by the remorse he felt.</i>
<b>parliamentary</b>	Relating to or having the nature of a parliament. <i><b>Parliamentary</b> law.</i>
<b>polygamy</b>	A pattern of mating in which an animal has more than one mate.
<b>reenact</b>	Enact again. <i>Congress <b>reenacted</b> the law.</i>
<b><u>reformation</u></b>	Rescuing from error and returning to a rightful course. <i>The <b>reformation</b> of the Senate.</i>
<b>regulation</b>	In accordance with regulations of the correct type. <i>The <b>regulation</b> of financial markets.</i>
<b>rule</b>	A rule describing or prescribing a linguistic practice. <i>The tenth House <b>ruled</b> by Saturn and associated with Capricorn.</i>
<b>statutory</b>	Prescribed or authorized by or punishable under a statute. <i>The <b>statutory</b> Christmas phone call to his mother.</i>
