## Associations of "Appellate" (30 Words)

<b>assessor</b>	An official who evaluates property for the purpose of taxing it. <i>The expert <b>assessor</b> recommended that the applicant have sole custody.</i>
<b>attempt</b>	Make an effort or attempt. <i>Troops shot civilians who <b>attempted</b> to flee.</i>
<b>bailiff</b>	An officer of the court who is employed to execute writs and processes and make arrests etc.
<b>chancery</b>	A public record office.
<b>court</b>	A room in which a lawcourt sits. <i>Everyone in the <b>court</b> knew he was going down innocent or guilty.</i>
<b>courtroom</b>	A room in which a lawcourt sits. <i>A bitter <b>courtroom</b> battle.</i>
<b>disbar</b>	Exclude (someone) from something. <i>The corrupt lawyer was <b>disbarred</b>.</i>

<b>federal</b>	Any federal law enforcement officer. <i>The health ministry has sole <b>federal</b> responsibility for healthcare.</i>
<b>filibuster</b>	Obstruct proposed legislation with a filibuster. <i>He was one of four Tories who <b>filibustered</b> for more than 30 minutes each to derail the free parking plan.</i>
<b>flop</b>	With a flopping sound. <i>The show <b>flopped</b> in London.</i>
<b>judge</b>	Put on trial or hear a case and sit as the judge at the trial of. <i>He is due to appear before a <b>judge</b> and jury on Monday.</i>
<b>judicature</b>	An assembly (including one or more judges) to conduct judicial business. <i>The constitutional principle that the legislature is separate from the <b>judicature</b>.</i>
<b>judicial</b>	Expressing careful judgment. <i>A <b>judicial</b> system.</i>
<b>judiciary</b>	The system of law courts that administer justice and constitute the judicial branch of government. <i>The independence of the <b>judiciary</b>.</i>
<b>jurisdiction</b>	The extent of the power to make legal decisions and judgements. <i>The English court had no <b>jurisdiction</b> over the defendants.</i>
<b>juror</b>	A member of a jury.
<b>jury</b>	Judge (an art or craft exhibition or exhibit). <i>The <b>jury</b> returned unanimous guilty verdicts.</i>
<b>lawgiver</b>	A maker of laws; someone who gives a code of laws. <i>The monarch was supreme executive <b>lawgiver</b> judge and warrior.</i>
<b>lawyer</b>	Practise law work as a lawyer. <i>There is always a danger that the deal will be <b>lawyered</b> to death.</i>
<b>legality</b>	Obligations imposed by law. <i>Documentation testifying to the <b>legality</b> of the arms sale.</i>
<b>litigation</b>	A legal proceeding in a court; a judicial contest to determine and enforce legal rights. <i>The company wishes to avoid <b>litigation</b>.</i>
<b>magistracy</b>	The office or authority of a magistrate. <i>He twice ran for a <b>magistracy</b> in his home town.</i>
<b>magistrate</b>	A civil officer who administers the law, especially one who conducts a court that deals with minor offences and holds preliminary hearings for more serious ones.
<b>proceeding</b>	The institution of a sequence of steps by which legal judgments are invoked.



<b>ruin</b>	Fall into ruin. <i>The <b>ruin</b> and heartbreak wrought by alcohol divorce and violence.</i>
<b>sheriff</b>	(in Scotland) a judge.
<b>testimony</b>	Evidence or proof of something. <i>The <b>testimony</b> of an eyewitness.</i>
<b>trial</b>	Of a horse dog or other animal compete in trials. <i>He cracked his ankle the week before the final <b>trial</b>.</i>
<b>tribunal</b>	A body established to settle certain types of dispute. <i>An international war crimes <b>tribunal</b>.</i>
<b>verdict</b>	The findings of a jury on issues of fact submitted to it for decision; can be used in formulating a judgment. <i>The jury returned a <b>verdict</b> of not guilty.</i>
