Definitions of "Arbiter" as a noun

- *Someone chosen to judge and decide a disputed issue.*
- *Someone with the power to settle matters at will.*
- *A person who settles a dispute or has ultimate authority in a matter.*
- *A person whose views or actions have influence in a particular sphere.*



Synonyms of "Arbiter" as a noun (12 Words)

arbitrator	An independent person or body officially appointed to settle a dispute. <i>The facts of the case are put to an independent arbitrator.</i>
authority	(usually plural) persons who exercise (administrative) control over others. <i>She spoke with authority.</i>
controller	A mechanism that controls the operation of a machine. <i>A temperature controller.</i>
<u>critic</u>	A person who expresses an unfavourable opinion of something. <i>A theatre critic.</i>
determiner	A person or thing that determines or decides something.
director	Member of a board of directors. <i>The sales director.</i>
expert	A person who is very knowledgeable about or skilful in a particular area. <i>A financial expert.</i>
governor	The head of a public institution. <i>The governor of the Bank of England.</i>
<u>judge</u>	A person who decides the results of a competition. <i>She was a good judge of character.</i>
master	Someone who holds a master's degree from academic institution. <i>One of the old masters.</i>
pundit	Someone who has been admitted to membership in a scholarly field. <i>Political pundits were tipping him for promotion.</i>
umpire	An official at a baseball game. <i>An umpire was appointed to settle the tax case.</i>

Usage Examples of "Arbiter" as a noun

- An arbiter of taste.
- The critic was considered to be an arbiter of modern literature.
- She was the final arbiter on all matters of fashion.
- The Secretary of State is the final arbiter.

Associations of "Arbiter" (30 Words)

adjudge	Declare to be. <i>The defaulter was adjudged to pay the whole amount.</i>

adjudicate	Make a formal judgement on a disputed matter. <i>The father adjudicated when the sons were quarreling over their inheritance.</i>
arbitrate	(of an independent person or body) reach an authoritative judgement or settlement. <i>The board has the power to arbitrate in disputes.</i>
<u>arbitration</u>	The use of an arbitrator to settle a dispute. <i>Tayside Regional Council called for arbitration to settle the dispute.</i>
assessor	A person who is knowledgeable in a particular field and is called upon for advice, typically by a judge or committee of inquiry. <i>The assessor interviews the candidates and observes them actually using the language.</i>
call	A direction in a square dance given by the caller. <i>A call to all sides to remain calm and refrain from violence.</i>
choose	Pick out select or choose from a number of alternatives. <i>I always choose the fish over the meat courses in this restaurant.</i>
commandment	A divine rule, especially one of the Ten Commandments. <i>She had followed her mother's commandments for long enough.</i>
<u>conclude</u>	Decide by reasoning; draw or come to a conclusion. <i>The committee concluded the meeting.</i>
conclusion	The last section of a communication. <i>In conclusion I want to say.</i>
decide	Cause to decide. <i>The judge decided the case in favor of the plaintiff.</i>
decision	The ability or tendency to make decisions quickly decisiveness. <i>A decision unfavorable to the opposition.</i>
definitive	A definitive postage stamp. <i>A definitive verdict.</i>
<u>determination</u>	A position or opinion or judgment reached after consideration. <i>His determination showed in his every movement.</i>
determine	Find out learn or determine with certainty usually by making an inquiry or other effort. <i>He determined on a withdrawal of his forces.</i>
deterministic	An inevitable consequence of antecedent sufficient causes. <i>A deterministic theory.</i>
irrevocable	Incapable of being retracted or revoked- Shakespeare. <i>An irrevocable step.</i>

judge	Judge tentatively or form an estimate of quantities or time. <i>It is hard to judge whether such opposition is justified.</i>
judgement	(law) the determination by a court of competent jurisdiction on matters submitted to it. <i>County court judgements against individuals in debt.</i>
legislate	Provide or prepare for (an occurrence). <i>We cannot legislate how people spend their free time.</i>
linesman	A person who installs or repairs electrical or telephone lines.
persuasiveness	The power to induce the taking of a course of action or the embracing of a point of view by means of argument or entreaty.
referee	Be a referee or umpire in a sports competition. <i>He refereed two of the first round group matches.</i>
resolve	Cause (a symptom or condition) to heal or subside. <i>He resolved never to drink again.</i>
resolved	Determined. <i>Constance was resolved not to cry.</i>
ruling	Currently exercising authority or influence. <i>The ruling coalition.</i>
select	Pick out select or choose from a number of alternatives. <i>He joined his select team of young Intelligence operatives.</i>
supervisor	A person who directs and oversees the work of a postgraduate research student.
tribunal	An assembly (including one or more judges) to conduct judicial business. <i>An international war crimes tribunal.</i>
umpire	Be a referee or umpire in a sports competition. <i>He umpired the World Cup final.</i>
