Argument as a Noun

Definitions of "Argument" as a noun

According to the [Oxford Dictionary of English](#), “argument” as a noun can have the following definitions:

- *A contentious speech act; a dispute where there is strong disagreement.*
- *A fact or assertion offered as evidence that something is true.*
- *A discussion in which reasons are advanced for and against some proposition or proposal.*
- *Any of the noun phrases in a clause that are related directly to the verb, typically the subject, direct object, and indirect object.*
- *A reference or value that is passed to a function, procedure, subroutine, command, or program.*
- *A summary of the subject or plot of a literary work or play or movie.*
- *An exchange of diverging or opposite views, typically a heated or angry one.*
- *(computer science) a reference or value that is passed to a function, procedure, subroutine, command, or program.*

- An independent variable associated with a function or proposition and determining its value. For example, in the expression $y = F(x_1, x_2)$, the arguments of the function F are x_1 and x_2 , and the value is y .
- A reason or set of reasons given in support of an idea, action or theory.
- A summary of the subject matter of a book.
- A variable in a logical or mathematical expression whose value determines the dependent variable; if $f(x)=y$, x is the independent variable.
- A course of reasoning aimed at demonstrating a truth or falsehood; the methodical process of logical reasoning.

altercation

A noisy argument or disagreement, especially in public.
*I had an **altercation** with the ticket collector.*

arguing

A contentious speech act; a dispute where there is strong disagreement.

argumentation	A discussion in which reasons are advanced for and against some proposition or proposal. <i>Lines of argumentation used to support his thesis.</i>
case	An agreed summary of the facts relating to a legal case drawn up for review or decision on a point of law by a higher court. <i>That was not the case.</i>
clash	A loud jarring sound, as of metal objects being struck together. <i>A clash of tweeds and a striped shirt.</i>
<u>contention</u>	An assertion, especially one maintained in argument. <i>Freud s contention that all dreams were wish fulfilment.</i>
contestation	An occasion on which a winner is selected from among two or more contestants. <i>A self conscious contestation of the government.</i>
contretemps	A minor dispute or disagreement. <i>He tried to smooth over his contretemps with the policeman.</i>
<u>controversy</u>	A contentious speech act; a dispute where there is strong disagreement. <i>The announcement ended a protracted controversy.</i>
debate	A formal discussion on a particular matter in a public meeting or legislative assembly, in which opposing arguments are put forward and which usually ends with a vote. <i>The national debate on abortion.</i>
difference of opinion	The quality of being unlike or dissimilar.
<u>disagreement</u>	Lack of consensus or approval. <i>Disagreement between the results of the two assessments.</i>
disceptation	Disputation, debate, discussion; an instance of this.
disputation	Formal academic debate. <i>A lengthy disputation about the rights and wrongs of a particular request.</i>
dispute	Coming into conflict with. <i>He had a dispute with his wife.</i>
dissension	Disagreement that leads to discord. <i>These issues caused bitter dissension in the party.</i>
exchange of views	The act of giving something in return for something received.
<u>feud</u>	A bitter quarrel between two parties. <i>His long standing feud with Universal Pictures.</i>

fight	The inclination or ability to fight or struggle. <i>There was fighting in the streets.</i>
line	In football hockey etc the goal line. <i>They attacked the enemy's line.</i>
line of reasoning	A short personal letter.
logic	Logical operations collectively. <i>There seemed to be a lack of logic in his remarks.</i>
<u>parameter</u>	A reference or value that is passed to a function, procedure, subroutine, command, or program. <i>The parameters within which the media work.</i>
<u>quarrel</u>	A reason for disagreement with a person, group, or principle. <i>She made the mistake of picking a quarrel with John.</i>
<u>reasoning</u>	The action of thinking about something in a logical, sensible way. <i>He explained the reasoning behind his decision at a media conference.</i>
squabble	A quarrel about petty points. <i>Family squabbles.</i>
statement	A formal account of events given by a witness, defendant, or other party to the police or in a court of law. <i>Do you agree with this statement.</i>
subject matter	The subject matter of a conversation or discussion.
theme	The first major constituent of a clause, indicating the subject matter, typically being the subject but optionally other constituents, as in 'smitten he is not'. <i>An Irish theme pub.</i>
tilt	A combat between two mounted knights tilting against each other with blunted lances. <i>The tower had a pronounced tilt.</i>
topic	A matter dealt with in a text, discourse, or conversation; a subject. <i>Sleep deprivation became a frequent topic of conversation.</i>
war of words	An active struggle between competing entities.
<u>wrangle</u>	A dispute or argument, typically one that is long and complicated. <i>An insurance wrangle is holding up compensation payments.</i>



Usage Examples of "Argument" as a noun

- *The argument over foreign aid goes on and on.*
- *They were involved in a violent argument.*
- *It was a strong argument that his hypothesis was true.*

Associations of "Argument" (30 Words)

argue	Exchange or express diverging or opposite views, typically in a heated or angry way. <i>The evidence argues for your claim.</i>
bicker	(of a flame or light) flash, gleam, or flicker. <i>Couples who bicker over who gets what from the divorce.</i>
confute	Prove to be false. <i>Restorers who sought to confute this view were accused of ignorance.</i>
<u>contention</u>	A point asserted as part of an argument. <i>The captured territory was the main area of contention between the two countries.</i>
contentiousness	An inclination to be quarrelsome and contentious.
<u>contradict</u>	Be in contradiction with. <i>He did not contradict what he said last week.</i>
<u>controversial</u>	Marked by or capable of arousing controversy. <i>Rushdie's controversial book.</i>
<u>controversy</u>	Prolonged public disagreement or heated discussion. <i>The design of the building has caused controversy.</i>

controvert	Argue about (something). <i>Subsequent work from the same laboratory controverted these results.</i>
<u>debatable</u>	Capable of being disproved. <i>It is debatable whether the country is coming out of recession.</i>
<u>denial</u>	(psychiatry) a defense mechanism that denies painful thoughts. <i>The denial of insurance to people with certain medical conditions.</i>
<u>deny</u>	Deny formally an allegation of fact by the opposing party in a legal suit. <i>The servants are ordered to deny him.</i>
discussion	A detailed treatment of a topic in speech or writing. <i>See Appendix One for a more detailed discussion.</i>
disproof	The act of determining that something is false. <i>Rex was living disproof of the youth preserving powers imputed to life in the college.</i>
disputable	Open to argument or debate. <i>Whether it can be described as art criticism may be disputable.</i>
disputation	Debate or argument. <i>The founding father of logical disputation.</i>
dispute	Coming into conflict with. <i>The accusations are not disputed.</i>
<u>enthuse</u>	Utter with enthusiasm. <i>They both enthused over my new look.</i>
gainsay	Speak against or oppose (someone). <i>None could gainsay her.</i>
hassel	Norwegian chemist noted for his research on organic molecules (1897-1981).
impugn	Dispute the truth, validity, or honesty of (a statement or motive); call into question. <i>The father does not impugn her capacity as a good mother.</i>
interlocutor	The performer in the middle of a minstrel line who engages the others in talk.
<u>objection</u>	An expression or feeling of disapproval or opposition; a reason for disagreeing. <i>They have raised no objections to the latest plans.</i>
polemical	Of or involving strongly critical or disputatious writing or speech. <i>A polemical essay.</i>

rebut	Drive back or repel (a person or attack). <i>He had to rebut charges of acting for the convenience of his political friends.</i>
rebuttal	A pleading by the defendant in reply to a plaintiff's surrejoinder.
refutable	Able to be refuted.
refutation	Any evidence that helps to establish the falsity of something. <i>Scientific theory is always tentative open to refutation.</i>
refute	Prove (a statement or theory) to be wrong or false; disprove. <i>A spokesman totally refuted the allegation of bias.</i>
wrangle	Have a long, complicated dispute or argument. <i>The horses were wrangled early.</i>
