### Definitions of "Article" as a noun

- *A separate clause or paragraph of a legal document or agreement, typically one outlining a single rule or regulation.*
- *Nonfictional prose forming an independent part of a publication.*
- *One of a class of artifacts.*
- *A piece of writing included with others in a newspaper, magazine, or other publication.*
- *The terms on which crew members take service on a ship.*
- *The definite or indefinite article.*
- *A period of training with a firm as a solicitor, architect, surveyor, or accountant.*
- *A determiner that may indicate the specificity of reference of a noun phrase.*
- *A particular item or object.*
- *A separate section of a legal document (as a statute or contract or will).*

<b>account</b>	A short account of the news. <i>She turned her writing skills to good <b>account</b>.</i>
<b>analysis</b>	The identification and measurement of the chemical constituents of a substance or specimen. <i>Samples are sent to the laboratory for <b>analysis</b>.</i>
<b>artefact</b>	Something observed in a scientific investigation or experiment that is not naturally present but occurs as a result of the preparative or investigative procedure. <i>Gold and silver <b>artefacts</b>.</i>
<b>bit</b>	The cutting part of a drill usually pointed and threaded and is replaceable in a brace or bitstock or drill press. <i>Miranda could go off and do her theatrical <b>bit</b>.</i>
<b><u>clause</u></b>	(grammar) an expression including a subject and predicate functioning as a part of a complex sentence.

<b><u>column</u></b>	Anything that approximates the shape of a column or tower. <i>Detail your expenses in the left hand <b>column</b>.</i>
<b>commentary</b>	An expression of opinions or offering of explanations about an event or situation. <i>A <b>commentary</b> on the Old Testament.</i>
<b>commodity</b>	Articles of commerce. <i><b>Commodity</b> markets.</i>
<b><u>composition</u></b>	A sum paid in lieu of a larger debt. <i>Chopin's most romantic <b>compositions</b>.</i>
<b><u>discourse</u></b>	A formal discussion of a topic in speech or writing. <i>An imagined <b>discourse</b> between two people.</i>
<b>disquisition</b>	An elaborate analytical or explanatory essay or discussion. <i>Nothing can kill a radio show quicker than a <b>disquisition</b> on intertextual analysis.</i>
<b>division</b>	A group of organisms forming a subdivision of a larger category. <i>Two infantry <b>divisions</b> were held in reserve.</i>
<b>essay</b>	A short piece of writing on a particular subject. <i>A misjudged <b>essay</b> in job preservation.</i>
<b>feature</b>	A newspaper or magazine article or a broadcast programme devoted to the treatment of a particular topic, typically at length. <i>A dark haired man with strong regular <b>features</b>.</i>
<b>heading</b>	A horizontal passage made in preparation for building a tunnel. <i>The <b>heading</b> seemed to have little to do with the text.</i>
<b>item</b>	An entry in an account. <i>They reduced the price on many <b>items</b>.</i>
<b>object</b>	A thing external to the thinking mind or subject. <i>Small <b>objects</b> such as shells.</i>
<b>paper</b>	The physical object that is the product of a newspaper publisher. <i>He read his <b>newspaper</b> at breakfast.</i>
<b>paragraph</b>	A distinct section of a piece of writing, usually dealing with a single theme and indicated by a new line, indentation, or numbering. <i>The concluding <b>paragraph</b>.</i>
<b>part</b>	A melody or other constituent of harmony assigned to a particular voice or instrument in a musical work. <i>Those of you who jet off to foreign <b>parts</b> for your holidays.</i>
<b><u>passage</u></b>	A narrow way allowing access between buildings or to different rooms within a building a passageway. <i>I booked a <b>passage</b> on the next ship.</i>

<b>piece</b>	Game equipment consisting of an object used in playing certain board games. <i>She bought a lovely <b>piece</b> of china.</i>
<b>piece of merchandise</b>	A portion of a natural object.
<b>piece of writing</b>	An instance of some kind.
<b>point</b>	A decimal point. <i>A power <b>point</b>.</i>
<b>portion</b>	The part or share of an estate given or descending by law to an heir. <i>A <b>portion</b> of ice cream.</i>
<b>product</b>	Commercially manufactured articles, especially recordings, viewed collectively. <i>The <b>product</b> of 2 and 3 is 6.</i>
<b>report</b>	An employee who reports to another employee. <i>His father signed his <b>report</b> card.</i>
<b>review</b>	Practice intended to polish performance or refresh the memory. <i>All areas of the company will come under <b>review</b>.</i>
<b>section</b>	A separation by cutting. <i>The brass <b>section</b>.</i>
<b>segment</b>	The part of a line included between two points. <i>Finished the final <b>segment</b> of the road.</i>
<b>story</b>	A plot or storyline. <i>Having such information is useful but it is not the whole <b>story</b>.</i>
<b>study</b>	A room used for reading and writing and studying. <i>The <b>study</b> of English.</i>
<b>subdivision</b>	A section of a section; a part of a part; i.e., a part of something already divided. <i>Such an arrangement offers the possibility of <b>subdivision</b> into a series of identical spaces.</i>
<b>subsection</b>	A section of a section; a part of a part; i.e., a part of something already divided. <i>Each chapter has a different theme and numerous <b>subsections</b>.</i>
<b>thing</b>	Used to express one's disapproval of or contempt for something. <i>Reading isn't my <b>thing</b>.</i>
<b>tract</b>	An indefinitely large extent of something. <i>It took courage to privatize vast <b>tracts</b> of nationalized industry.</i>

**treatise**

A written work dealing formally and systematically with a subject.  
*His **treatise** on Scottish political theory.*

**unit**

The smallest measure of investment in a unit trust.  
*Fifty **units** of electricity.*

<b>comment</b>	A written explanation or commentary. <i>He <b>commented</b> the paper of his colleague.</i>
<b>contributor</b>	A causal factor in the existence or occurrence of something. <i>Hunt was the largest <b>contributor</b> of hymns to these collections.</i>
<b>define</b>	Mark out the boundary or limits of. <i>The dictionary <b>defines</b> it as a type of pasture.</i>
<b><u>descriptive</u></b>	Serving or seeking to describe. <i><b>Descriptive</b> grammar.</i>
<b><u>dictum</u></b>	An authoritative declaration. <i>The old <b>dictum</b> might is right.</i>
<b>gazette</b>	Announce or publish something in an official gazette. <i>A <b>gazetted</b> holiday.</i>
<b><u>journal</u></b>	Write in a journal or diary. <i>While abroad he had kept a <b>journal</b>.</i>
<b>lexicographer</b>	A person who compiles dictionaries.
<b>magazine</b>	A business firm that publishes magazines. <i>He works for a <b>magazine</b>.</i>
<b><u>maxim</u></b>	English inventor (born in the United States) who invented the Maxim gun that was used in World War I (1840-1916). <i>The <b>maxim</b> that actions speak louder than words.</i>
<b>mention</b>	Make mention of. <i>He is still regularly <b>mentioned</b> as a possible secretary of state.</i>
<b>newspaper</b>	The organization responsible for producing a particular newspaper. <i>She left her muddy boots on a piece of <b>newspaper</b>.</i>
<b>notation</b>	A note or annotation. <i>Algebraic <b>notation</b>.</i>
<b>obituary</b>	A notice of someone's death; usually includes a short biography. <i>It is premature to write the <b>obituary</b> of British science.</i>
<b>publisher</b>	The proprietor of a newspaper. <i>A commercial music <b>publisher</b>.</i>
<b>quotation</b>	A passage or expression that is quoted or cited. <i>A <b>quotation</b> from Bartok's Fourth String Quartet.</i>
<b><u>quote</u></b>	A passage or expression that is quoted or cited. <i><b>Quotes</b> for North Sea Brent were rising.</i>
<b>reader</b>	A proofreader. <i>A meter <b>reader</b>.</i>

<b>readership</b>	The audience reached by written communications (books or magazines or newspapers etc). <i>The magazine has a <b>readership</b> of just 65 000.</i>
<b>reference</b>	A short note recognizing a source of information or of a quoted passage. <i>He made <b>reference</b> to the enormous power of the mass media.</i>
<b>remark</b>	Notice or comment. <i>The judges <b>remarked</b> on the high standard of the entries.</i>
<b>reporting</b>	The news as presented by reporters for newspapers or radio or television.
<b>sentence</b>	Pronounce a sentence on somebody in a court of law. <i>He was under <b>sentence</b> of death.</i>
<b>writing</b>	Handwriting. <i>The doctor's <b>writing</b> was illegible.</i>
