Past Tense	attorned
Present Participle	attorning
Past Participle	attorned

Conjugate Attorn

Attorn in Present Simple (Indefinite) Tense

Singular Plural

I **attorn** We **attorn**
You **attorn** You **attorn**
He/She/It **attorns** They **attorn**

Attorn in Present Continuous (Progressive) Tense

Singular Plural

I **am attorning** We **are attorning**
You **are attorning** You **are attorning**
He/She/It **is attorning** They **are attorning**

Attorn in Present Perfect Tense

Singular Plural

I **have attorned** We **have attorned**
You **have attorned** You **have attorned**
He/She/It **has attorned** They **have attorned**

Attorn in Present Perfect Continuous Tense

Singular Plural

I **have been attorning** We **have been attorning**
You **have been attorning** You **have been attorning**
He/She/It **has been attorning** They **have been attorning**

Attorn in Past Simple (Indefinite) Tense

Singular Plural

I **attorned** We **attorned**
You **attorned** You **attorned**
He/She/It **attorned** They **attorned**

Attorn in Past Continuous (Progressive) Tense

Singular

Plural

I was attorning We were attorning
You were attorning You were attorning
He/She/It was attorning They were attorning

Attorn in Past Perfect Tense

Singular

Plural

I had attorned We had attorned
You had attorned You had attorned
He/She/It had attorned They had attorned

Attorn in Past Perfect Continuous Tense

Singular

Plural

I had been attorning We had been attorning
You had been attorning You had been attorning
He/She/It had been attorning They had been attorning

Attorn in Future Simple (Indefinite) Tense

Singular

Plural

I will attorn We will attorn
You will attorn You will attorn
He/She/It will attorn They will attorn

Attorn in Future Continuous (Progressive) Tense

Singular

Plural

I will be attorning We will be attorning
You will be attorning You will be attorning
He/She/It will be attorning They will be attorning

Attorn in Future Perfect Tense

Singular

Plural

I will have attorned

We will have attorned

You will have attorned

You will have attorned

He/She/It will have attorned **They will have attorned**

Attorn in Future Perfect Continuous Tense

Singular

Plural

I will have been attorning

We will have been attorning

You will have been attorning

You will have been attorning

He/She/It will have been attorning **They will have been attorning**
