## Bail as a Noun

### Definitions of "Bail" as a noun

According to the [Oxford Dictionary of English](#), “bail” as a noun can have the following definitions:

- *(criminal law) money that must be forfeited by the bondsman if an accused person fails to appear in court for trial.*
- *The legal system that allows an accused person to be temporarily released from custody (usually on condition that a sum of money guarantees their appearance at trial.*
- *Money paid by or for someone in order to secure their release on bail.*
- *Money that must be forfeited by the bondsman if an accused person fails to appear in court for trial.*
- *The temporary release of an accused person awaiting trial, sometimes on condition that a sum of money is lodged to guarantee their appearance in court.*



## Synonyms of "Bail" as a noun (8 Words)

<b>assurance</b>	Certainty about something. <i>He gave an <b>assurance</b> that work would begin on Monday.</i>
<b>bail bond</b>	Money that must be forfeited by the bondsman if an accused person fails to appear in court for trial.
<b>bond</b>	Money that must be forfeited by the bondsman if an accused person fails to appear in court for trial. <i>He stooped over the trussed man and tested his <b>bonds</b>.</i>
<b><u>collateral</u></b>	A person having the same ancestor as another but through a different line. <i>She put her house up as <b>collateral</b> for the bank loan.</i>
<b>indemnification</b>	A sum of money paid in compensation for loss or injury. <i>Whistleblower protection is <b>indemnification</b> for individuals who are dismissed as a result of reporting a violation.</i>



**indemnity**

Legal exemption from liability for damages.  
*No **indemnity** will be given for loss of cash.*

**security**

Procedures followed or measures taken to ensure the security of a state or organization.  
*Job **security**.*

**surety**

A person who takes responsibility for another's performance of an undertaking, for example their appearing in court or paying a debt.  
*The **surety** of my impending fatherhood.*



**Usage Examples of "Bail" as a noun**

- *He has been released on bail.*
- *The judge set bail at \$10,000.*
- *They feared the financier would be tempted to forfeit the £10 million bail and flee.*
- *He is out on bail.*



## Associations of "Bail" (30 Words)

<b>abduct</b>	Take (someone) away illegally by force or deception; kidnap. <i>The posterior rectus muscle which <b>abducts</b> the eye.</i>
<b>agent</b>	Any agent or representative of a federal agency or bureau. <i>A trained intelligence <b>agent</b>.</i>
<u><a href="#">amnesty</a></u>	A period during which offenders are exempt from punishment. <i>An <b>amnesty</b> for political prisoners.</i>
<u><a href="#">amortize</a></u>	Reduce or pay off (a debt) with regular payments. <i>Eighty per cent of the proceeds has been used to <b>amortize</b> the public debt.</i>
<b>arrest</b>	Attract and fix. <i>I have a warrant for your <b>arrest</b>.</i>

<b><u>collateral</u></b>	Denoting inadvertent casualties and destruction in civilian areas in the course of military operations. <i>The <b>collateral</b> meanings of a word.</i>
<b><u>crisis</u></b>	The turning point of a disease when an important change takes place, indicating either recovery or death. <i>The current economic <b>crisis</b>.</i>
<b>extort</b>	Get or cause to become in a difficult or laborious manner. <i>They <b>extorted</b> money from the executive by threatening to reveal his past to the company boss.</i>
<b>fine</b>	Characterized by elegance or refinement or accomplishment. <i>Batiste is a cotton fabric with a <b>fine</b> weave.</i>
<b>funding</b>	The action or practice of providing funding. <i><b>Funding</b> bodies for research and curriculum development.</i>
<b>guarantor</b>	A person or thing that gives or acts as a guarantee. <i>The role of the police as <b>guarantors</b> of public order.</i>
<b>hijacker</b>	A person who takes over an organization or activity and uses it for a different purpose. <i>A <b>hijacker</b> of arms shipments.</i>
<b>hostage</b>	A prisoner who is held by one party to insure that another party will meet specified terms. <i>Three <b>hostages</b> were released but only after their families paid an estimated 200 000 to the guerrillas.</i>
<b><u>imprison</u></b>	Put or keep in prison or a place like a prison. <i>He was <b>imprisoned</b> three times for his activities.</i>
<b>jail</b>	Put someone in jail. <i>He spent 15 years in <b>jail</b>.</i>
<b><u>kidnap</u></b>	The action of kidnapping someone. <i>They were arrested for robbery and <b>kidnap</b>.</i>
<b>kidnapping</b>	The unlawful act of capturing and carrying away a person against their will and holding them in false imprisonment. <i>The recent <b>kidnapping</b> of a Dutch industrialist.</i>
<b>lender</b>	Someone who lends money or gives credit in business matters. <i>A mortgage <b>lender</b>.</i>
<b><u>loan</u></b>	Lend (a sum of money or item of property). <i>The computer was <b>loaned</b> to us by the theatre.</i>
<b>money</b>	Sums of money. <i>The college is very short of <b>money</b>.</i>



<b><u>owe</u></b>	Owe something especially money to. <i>They have denied they <b>owe</b> money to the company.</i>
<b>paying</b>	For which money is paid. <i>A <b>paying</b> job.</i>
<b>ransom</b>	The holding or freeing of a captive in return for payment of a ransom. <i>He was demanding millions of pounds in <b>ransom</b>.</i>
<b>renter</b>	Someone who pays rent to use land or a building or a car that is owned by someone else.
<b>repayment</b>	The act of returning money received previously. <i>Minimum monthly <b>repayments</b>.</i>
<b>rescue</b>	Recovery or preservation from loss or danger. <i><b>Rescue</b> prisoners.</i>
<b>robbery</b>	The action of taking property unlawfully from a person or place by force or threat of force. <i>He was involved in drugs extortion and <b>robbery</b>.</i>
<b>surety</b>	Something clearly established. <i>The <b>surety</b> of my impending fatherhood.</i>
<b><u>warden</u></b>	The head of certain schools, colleges, or other institutions. <i>An air raid <b>warden</b>.</i>
