- *A person judged by a court to be insolvent, whose property is taken and disposed of for the benefit of their creditors.*
- *Someone who has insufficient assets to cover their debts.*

**insolvent** An insolvent person.

### **Definitions of "Bankrupt" as a verb**

- *Reduce to bankruptcy.*
- *Reduce (a person or organization) to bankruptcy.*





## Synonyms of "Bankrupt" as a verb (13 Words)

<b>break</b>	Become fractured break or crack on the surface only. <i>Break a circuit.</i>
<b>bring someone to their knees</b>	Cause to happen or to occur as a consequence.
<b>bring to ruin</b>	Go or come after and bring or take back.
<b>cause to go bankrupt</b>	Cause to do; cause to act in a specified manner.
<b>impoverish</b>	Make poor. <i>The wars had <b>impoverished</b> him.</i>
<b>make bankrupt</b>	Make by shaping or bringing together constituents.
<b>make insolvent</b>	Prepare for eating by applying heat.
<b>reduce to destitution</b>	Reduce in size; reduce physically.
<b>reduce to penury</b>	Reduce in size; reduce physically.
<b>ruin</b>	Reduce to ruins. <i>A noisy motorway has <b>ruined</b> village life.</i>
<b><u>smash</u></b>	Reduce to bankruptcy. <i>The death of her son <b>smashed</b> her.</i>
<b>wipe out</b>	Rub with a circular motion.



## Usage Examples of "Bankrupt" as a verb

- *The strike nearly bankrupted the union.*



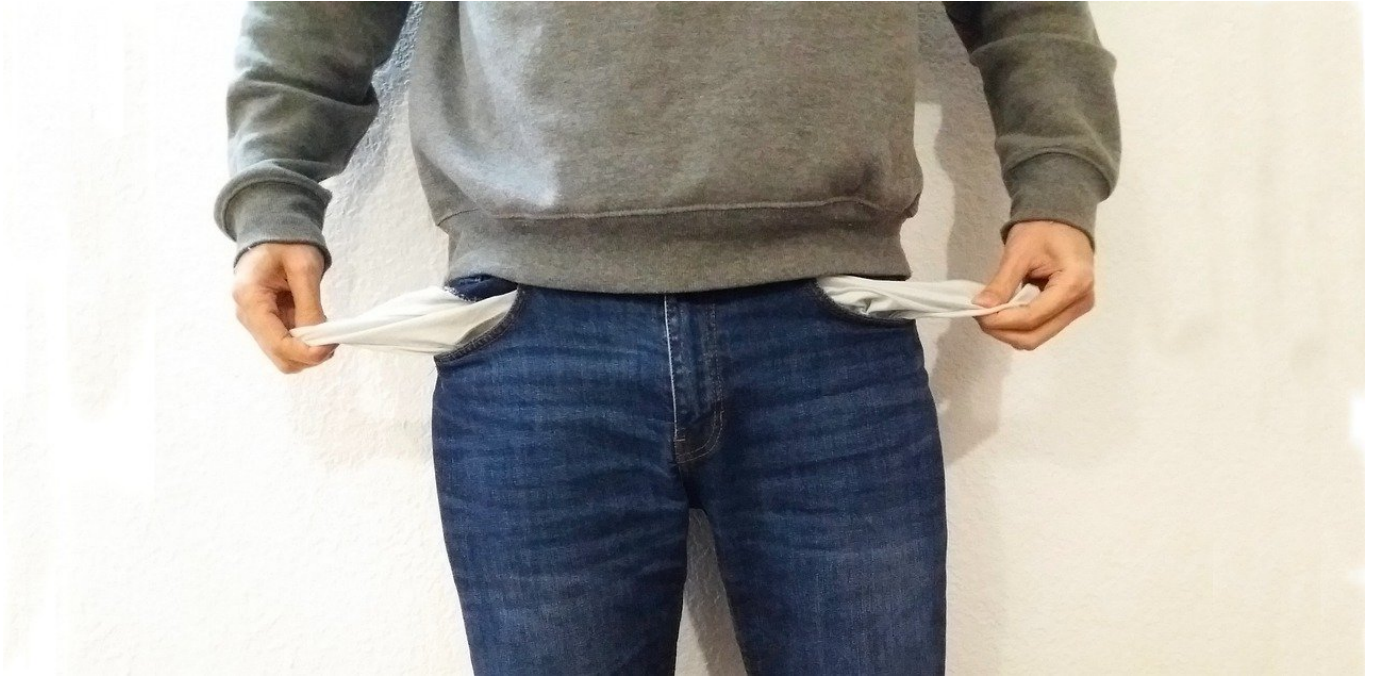


## Bankrupt as an Adjective

### Definitions of "Bankrupt" as an adjective

According to the [Oxford Dictionary of English](#), "bankrupt" as an adjective can have the following definitions:

- *Completely lacking in a particular good quality.*
- *Impoverished or depleted.*
- *(of a person or organization) declared in law as unable to pay their debts.*
- *Financially ruined.*



## Synonyms of "Bankrupt" as an adjective (11 Words)

- bankrupted** Financially ruined.
- bare of** Just barely adequate or within a lower limit.
- belly-up** Financially ruined.
- bereft of** Sorrowful through loss or deprivation.
- deprived of** Marked by deprivation especially of the necessities of life or healthful environmental influences.
- destitute of** Poor enough to need help from others.
- devoid of** Completely wanting or lacking.
- empty of** Emptied of emotion.
- exhausted of** Drained physically.
- insolvent** Unable to meet or discharge financial obligations.  
*An **insolvent** estate.*
- vacant of** Without an occupant or incumbent.





## Usage Examples of "Bankrupt" as an adjective

- *A bankrupt company.*
- *Their cause is morally bankrupt.*
- *A bankrupt country with no natural resources.*
- *His father went bankrupt and the family had to sell their home.*





## Associations of "Bankrupt" (30 Words)

- account** Keep an account of.  
*I began buying things on **account**.*
- assignee** The party to whom something is assigned (e.g., someone to whom a right or property is legally transferred).
- bankruptcy** The state of being bankrupt.  
*Many companies were facing **bankruptcy**.*
- beholden** Under a moral obligation to someone.  
*I don't like to be **beholden** to anybody.*

<b>bookkeeping</b>	The activity or occupation of keeping records of the financial affairs of a business. <i>I got in a financial muddle because I didn't keep my <b>bookkeeping</b> up to date.</i>
<b>borrow</b>	Take and use (a book) from a library for a fixed period of time. <i>He had <b>borrowed</b> a car from one of his colleagues.</i>
<b>cheque</b>	Withdraw money by writing a check. <i>They presented him with a <b>cheque</b> for 4 000.</i>
<b>closedown</b>	Termination of operations.
<b>credit</b>	The quality of being believed or credited. <i>The bank refused to extend their <b>credit</b>.</i>
<b>creditor</b>	A person to whom money is owed by a debtor; someone to whom an obligation exists. <i><b>Creditor</b> banks.</i>
<b>debt</b>	The state of owing something (especially money). <i>I paid off my <b>debts</b>.</i>
<b>debtor</b>	A person, country, or organization that owes money. <i><b>Debtor</b> countries.</i>
<b>default</b>	Declare a party to have defaulted and give judgement against that party. <i>All my life envy has been my <b>default</b> emotion.</i>
<b>defunct</b>	No longer in force or use; inactive. <i>The will of a <b>defunct</b> aunt.</i>
<b>due</b>	A payment that is due e.g. as the price of membership. <i>He thought it was his <b>due</b>.</i>
<b>expired</b>	Having come to an end or become void after passage of a period of time. <i>An <b>expired</b> passport.</i>
<b>extinction</b>	Reduction to zero in the intensity of light or other radiation as it passes through a medium, due to absorption, reflection, or scattering. <i>A private debt <b>extinction</b> fund.</i>
<b>fiduciary</b>	A trustee. <i><b>Fiduciary</b> estates.</i>
<b>indebted</b>	Under a legal obligation to someone. <i>I am <b>indebted</b> to her for her help in indexing my book.</i>
<b>inoperative</b>	Not working or taking effect. <i>An <b>inoperative</b> law.</i>
<b>insolvency</b>	The state of being insolvent. <i>The club was facing <b>insolvency</b>.</i>



<b>insolvent</b>	An insolvent person. <i>The company became <b>insolvent</b>.</i>
<b>ledger</b>	Fish using a ledger. <i>The total balance of the purchases <b>ledger</b>.</i>
<b>liquidation</b>	The conversion of assets into cash (i.e. by selling them). <i>The company went into <b>liquidation</b>.</i>
<u>owe</u>	Owe something especially money to. <i>I <b>owe</b> you for the taxi.</i>
<b>poor</b>	Lacking in quality or substances. <i>They enquired after <b>poor</b> Dorothy s broken hip.</i>
<u>repay</u>	Make repayment for or return something. <i>Most of his fortune had been spent <b>repaying</b> creditors.</i>
<b>struggling</b>	Engaged in a struggle to overcome especially poverty or obscurity. <i><b>Struggling</b> artists.</i>
<b>usurious</b>	Relating to or characterized by usury; extortionate. <i><b>Usurious</b> interest rate.</i>
<u>vault</u>	A chamber beneath a church or in a graveyard used for burials. <i>A Gothic ribbed <b>vault</b>.</i>
