### Definitions of "Belongings" as a noun

## Synonyms of "Belongings" as a noun (11 Words)

<b>accoutrements</b>	Clothing that is worn or carried, but not part of your main clothing.
<b>appurtenances</b>	A supplementary component that improves capability.
<b>chattels</b>	Personal as opposed to real property; any tangible movable property (furniture or domestic animals or a car etc).
<b>effects</b>	Property of a personal character that is portable but not used in business. <i>She left some of her personal <b>effects</b> in the house.</i>
<b><u>goods</u></b>	Merchandise or possessions. <i>The team proved on Friday that they are the <b>goods</b>.</i>
<b>goods and chattels</b>	Personal as opposed to real property; any tangible movable property (furniture or domestic animals or a car etc).

<b>holding</b>	Something owned; any tangible or intangible possession that is owned by someone. <i>Commercial property <b>holdings</b>.</i>
<b>personal effects</b>	A short newspaper article about a particular person or group.
<b>personal possessions</b>	A short newspaper article about a particular person or group.
<b>possessions</b>	(sport) the act of controlling the ball (or puck). <i>They took possession of the ball on their own goal line.</i>
<b>property</b>	Shares or investments in property. <i>The stolen <b>property</b> was not recovered.</i>







## Usage Examples of "Belongings" as a noun

- *She didn't have much baggage with her as most of her belongings had been sent ahead by sea.*



## Associations of "Belongings" (30 Words)

<b>acquisition</b>	The act of contracting or assuming or acquiring possession of something. <i>The company intends to grow within itself rather than by <b>acquisition</b>.</i>
<b>asset</b>	An item of property owned by a person or company, regarded as having value and available to meet debts, commitments, or legacies. <i>Quick reflexes were his chief <b>assets</b>.</i>

<b>assets</b>	Anything of material value or usefulness that is owned by a person or company.
<b><u>belonging</u></b>	Happiness felt in a secure relationship. <i>We feel a real sense of <b>belonging</b>.</i>
<b>chattel</b>	An item of property other than freehold land including tangible goods chattels personal and leasehold interests chattels real.
<b>confiscation</b>	The action of taking or seizing someone's property with authority; seizure. <i>A court ordered the <b>confiscation</b> of her property.</i>
<b>expropriate</b>	Dispossess (someone) of property. <i>Their assets were <b>expropriated</b> by the government.</i>
<b>foreclosure</b>	The action of taking possession of a mortgaged property when the mortgagor fails to keep up their mortgage payments. <i>Assistance for mortgage borrowers facing <b>foreclosure</b>.</i>
<b>forfeited</b>	Surrendered as a penalty.
<b>forfeiture</b>	The loss or giving up of something as a penalty for wrongdoing. <i>Magistrates ordered the <b>forfeiture</b> of his computer.</i>
<b>holding</b>	The act of retaining something. <i>Commercial property <b>holdings</b>.</i>
<b><u>inalienable</u></b>	Not subject to being taken away from or given away by the possessor. <i>The shareholders have the <b>inalienable</b> right to dismiss directors.</i>
<b><u>inherit</u></b>	Receive from a predecessor. <i>She <b>inherits</b> all her clothes from her older sisters.</i>
<b><u>landed</u></b>	Consisting of or relating to land owned through inheritance. <i>The <b>landed</b> aristocracy.</i>
<b>landholder</b>	A person who owns land, especially one who either makes their living from it or rents it out to others.
<b>landlady</b>	A woman who rents out land, a building, or accommodation.
<b><u>loot</u></b>	Private property taken from an enemy in war. <i>Ten thousand quid is a lot of <b>loot</b>.</i>
<b>losses</b>	Something lost (especially money lost at gambling).
<b>misappropriate</b>	Appropriate (as property entrusted to one's care) fraudulently to one's own use. <i>The report revealed that department officials had <b>misappropriated</b> funds.</i>
<b>pillage</b>	Rob a (place) using violence, especially in wartime. <i>Rebellious peasants intent on <b>pillage</b>.</i>

<b>possessor</b>	A person who owns something. <i>His father was the <b>possessor</b> of a considerable fortune.</i>
<b>prize</b>	Denoting something for which a prize is awarded. <i>The berries were <b>prized</b> for their healing properties.</i>
<b>property</b>	Shares or investments in property. <i>The president was concerned about the <b>property</b> across from the White House.</i>
<b>realtor</b>	A person who acts as an agent for the sale and purchase of buildings and land; an estate agent.
<b>speculator</b>	Someone who risks losses for the possibility of considerable gains. <i>Financial <b>speculators</b> exploiting small changes in markets to make money.</i>
<b>steal</b>	Steal a base. <i>He finished with eight points four <b>steals</b> and seven assists.</i>
<b>take</b>	Take into one's possession. <i>He <b>takes</b> the corners with no concern for his own safety.</i>
<b><u>unpack</u></b>	Remove from its packing. <i>You can <b>unpack</b> specified files and directories.</i>
<b>valueless</b>	Having no value; worthless. <i>Cherished but <b>valueless</b> heirlooms.</i>
