<b>abidance</b>	Acting according to certain accepted standards.
<b><u>accordance</u></b>	Conformity or agreement. <i>There is good <b>accordance</b> between the values.</i>
<b>alphabet</b>	A character set that includes letters and is used to write a language. <i>DNA s 4 letter <b>alphabet</b>.</i>
<b><u>assuring</u></b>	Giving confidence.
<b>compliance</b>	The state or fact of according with or meeting rules or standards. <i>The appalling <b>compliance</b> with government views shown by the commission.</i>
<b>concordance</b>	Make a concordance of a text. <i>His works are extremely well known and have been <b>concordanced</b>.</i>
<b><u>conform</u></b>	Adapt or conform oneself to new or different conditions. <i>The pressure to <b>conform</b>.</i>
<b><u>deference</u></b>	A courteous expression (by word or deed) of esteem or regard. <i>He addressed her with the <b>deference</b> due to age.</i>
<b>dictionary</b>	A set of words or other text strings made for use in applications such as spellcheckers. <i>A <b>dictionary</b> of quotations.</i>
<b>diphthong</b>	A digraph representing the sound of a diphthong or single vowel as in feat.
<b><u>equity</u></b>	A branch of law that developed alongside common law and is concerned with fairness and justice, formerly administered in special courts. <i>He owns 62 of the group s <b>equity</b>.</i>
<b>etymology</b>	The origin of a word and the historical development of its meaning. <i>The <b>etymology</b> of the word devil.</i>
<b>follow</b>	Follow with the eyes or the mind. <i>They <b>follow</b> their March show with four UK dates next month.</i>

<b>grammar</b>	A grammar school. <i>It was not bad <b>grammar</b> just dialect.</i>
<b>impartiality</b>	Equal treatment of all rivals or disputants; fairness. <i>Entries had to be submitted under a pseudonym to ensure <b>impartiality</b> in the judging process.</i>
<u><b>justice</b></u>	A public official authorized to decide questions brought before a court of justice. <i>The <b>justice</b> of his case.</i>
<b>neutrality</b>	The condition of being chemically or electrically neutral. <i>The clinical <b>neutrality</b> of the description.</i>
<u><b>obedience</b></u>	Behavior intended to please your parents. <i>Their children were never very strong on <b>obedience</b>.</i>
<u><b>obey</b></u>	Behave in accordance with (a general principle, natural law, etc). <i>The officer was convicted for refusing to <b>obey</b> orders.</i>
<u><b>objectivity</b></u>	Judgment based on observable phenomena and uninfluenced by emotions or personal prejudices. <i>The piece lacked any <b>objectivity</b>.</i>
<u><b>observance</b></u>	Respect; deference. <i>The tramp gave them no <b>observance</b>.</i>
<b>orthography</b>	The conventional spelling system of a language. <i>A spoken language which has as yet no sanctioned <b>orthography</b>.</i>
<u><b>socialization</b></u>	The activity of mixing socially with others. <i>The <b>socialization</b> of medical services.</i>
<u><b>spelling</b></u>	The process or activity of writing or naming the letters of a word. <i>The <b>spelling</b> of his name was influenced by French.</i>
<b>submission</b>	A proposition or argument presented by counsel to a judge or jury. <i>Several of his <b>submissions</b> were rejected by publishers.</i>
<u><b>syntax</b></u>	The branch of linguistics that deals with syntax. <i>Generative <b>syntax</b>.</i>
<b>typo</b>	A typographical error.
<b>vocabulary</b>	The system of techniques or symbols serving as a means of expression (as in arts or crafts). <i>The Sanskrit <b>vocabulary</b>.</i>
<b>vowel</b>	A letter representing a vowel sound such as a e i o u.
<b>word</b>	A secret word or phrase known only to a restricted group. <i>Don't believe a <b>word</b> of it.</i>
