<u>embargo</u>	Seize (a ship or goods) for state service. <i>All of these countries have been embargoed by the US.</i>
endorsement	Formal and explicit approval. <i>The entertainer made millions from Pepsi endorsements.</i>
imprimatur	A person's authoritative approval. <i>The original LP enjoyed the imprimatur of the composer.</i>
<u>license</u>	Excessive freedom; lack of due restraint- Will Durant- Edmund Burke. <i>I am licensed to practice law in this state.</i>
ok	An expression of agreement normally occurring at the beginning of a sentence. <i>Things are okay.</i>
okay	In a satisfactory or adequate manner. <i>She'll do okay on her own.</i>
permissible	That may be permitted especially as according to rule. <i>A kind of speculation that was permissible in cosmology but inadmissible in medicine.</i>
permission	Approval to do something. <i>Permissions to reproduce copyright material.</i>
<u>permit</u>	A legal document giving official permission to do something. <i>He would not permit anybody access to the library.</i>

ratification	The action of signing or giving formal consent to a treaty, contract, or agreement, making it officially valid. <i>Ratification of the treaty raised problems in several member states.</i>
ratify	Approve and express assent, responsibility, or obligation. <i>Both countries were due to ratify the treaty by the end of the year.</i>
sanction	Give religious sanction to such as through on oath. <i>A range of sanctions aimed at deterring insider abuse.</i>
stipulate	Specify as a condition or requirement in a contract or agreement; make an express demand or provision in an agreement. <i>The will stipulates that she can live in the house for the rest of her life.</i>
<u>treaty</u>	A formally concluded and ratified agreement between states. <i>The two Presidents signed a ten year treaty of solidarity.</i>
unanimously	Of one mind; without dissent. <i>We voted unanimously.</i>
validation	The action of making or declaring something legally or officially acceptable. <i>The technique requires validation in controlled trials.</i>
verification	(law) an affidavit attached to a statement confirming the truth of that statement. <i>The verification of official documents.</i>
<u>yes</u>	An affirmative. <i>I was hoping for a yes.</i>
