

<u>aver</u>	To declare or affirm solemnly and formally as true. <i>He <b>aver</b>red that he was innocent of the allegations.</i>
avow	Assert or confess openly. He <b>avow</b> ed that he had voted Labour in every election.
challenge	Issue a challenge to. A certain number of jurors may be <b>challenge</b> d.

<u>compete</u>	Compete for something engage in a contest measure oneself against others. No one can <b>compete</b> with his physical provess.
<u>contest</u>	Oppose (an action or theory) as mistaken or wrong. She declared her intention to <b>contest</b> the presidency.
<u>cope</u>	(of a machine or system) have the capacity to deal successfully with. <i>The roads are barely adequate to</i> <b>cope</b> <i>with the present traffic.</i>
cope with	Come to terms with.
deal	Succeed in doing, achieving, or producing (something) with the limited or inadequate means available. <i>Many of the men are <b>deal</b>ing drugs.</i>
deal with	Direct the course of; manage or control.
debate	Have an argument about something. MPs <b>debate</b> d the issue in the Commons.
<u>declare</u>	Declare to be. Do you have anything to <b>declare</b> .
face	Cover the surface of something with a layer of a different material. If you were suddenly <b>face</b> d with an emergency would you know how to cope.



<u>fence</u>	Enclose or separate an area with a fence. <i>We <b>fence</b>d in our yard.</i>
fight	Be engaged in a fight carry on a fight. The country is still <b>fight</b> ing a civil war.
get by	Go or come after and bring or take back.
grapple	Succeed in doing, achieving, or producing (something) with the limited or inadequate means available. The two men <b>grapple</b> d with each other for several minutes.
grapple with	Come to terms with.
hold	Contain or hold have within. This theory still <b>hold</b> s.
<u>insist</u>	Beg persistently and urgently. I must <b>insist</b> .
maintain	Maintain for use and service. The need to <b>maintain</b> close links between industry and schools.
make do	Add up to.
make out	Reach a destination, either real or abstract.
manage	Be the manager of a sports team or a performer. Catherine <b>manage</b> d on five hours sleep a night.
pit oneself against	Remove the pits from.
<u>plead</u>	Make an allegation in an action or other legal proceeding especially answer the previous pleading of the other party by denying facts therein stated or by alleging new facts. <i>She <b>plead</b>ed not guilty.</i>
<u>postulate</u>	Take as a given assume as a postulate or axiom. His theory <b>postulate</b> d a rotatory movement for hurricanes.
profess	Practice as a profession teach or claim to be knowledgeable about. He had <b>profess</b> ed his love for her only to walk away.
pronounce	Speak pronounce or utter in a certain way. She <b>pronounce</b> s French words in a funny way.
repugn	To affect a person with repugnance or aversion Also without object to cause repugnance.
state	Put before. Judges must give both sides an equal opportunity to <b>state</b> their case.



struggle	Strive to achieve or attain something in the face of difficulty or resistance. <i>Before she could <b>struggle</b> he lifted her up.</i>
take on	Take on a certain form attribute or aspect.
vie	Compete for something; engage in a contest; measure oneself against others. The athletes were vying for a place in the British team.

# Associations of "Contend" (30 Words)

argue	Exchange or express diverging or opposite views, typically in a heated or angry way. <i>I tried to <b>argue</b> him out of it.</i>
assertion	A declaration that is made emphatically (as if no supporting evidence were necessary. <i>The assertion of his legal rights.</i>
<u>athlete</u>	A person who takes part in competitive track and field events (athletics). <i>He had the broad shouldered build of a natural <b>athlete</b>.</i>
<u>battle</u>	Battle or contend against in or as if in a battle. <i>He died in <b>battle</b>.</i>
bellicose	Demonstrating aggression and willingness to fight. A mood of <b>bellicose</b> jingoism.
challenger	A person who engages in a contest. <i>Heroic <b>challenger</b>s of authority.</i>
claim	Ask for legally or make a legal claim to as of debts for example. Each of them was to be rewarded with a farm and a number of mining <b>claims</b> in the land.
<u>compete</u>	Compete for something engage in a contest measure oneself against others. <i>No one can <b>compete</b> with his physical prowess.</i>



competition	The activity or condition of striving to gain or win something by defeating or establishing superiority over others. The <b>competition</b> for university places is greater than ever this year.
competitor	An organization or country engaged in commercial or economic competition with others. <i>Two competitors were banned for taking drugs.</i>
conflict	Be in conflict. Bewildered by her own inner <b>conflict</b> she could only stand there feeling vulnerable.
<u>contender</u>	A person or group competing with others to achieve something. A presidential <b>contender</b> .
<u>contention</u>	A contentious speech act; a dispute where there is strong disagreement. <i>The teams were in fierce contention for first place.</i>
<u>contentious</u>	(of a person) given to provoking argument. The socio economic plan had been the subject of <b>contentious</b> debate.
<u>contest</u>	An occasion on which a winner is selected from among two or more contestants. <i>They contested the outcome of the race.</i>
<u>discord</u>	A harsh mixture of sounds. The music faded in <b>discord</b> .
<u>enemy</u>	A personal enemy. <i>He viewed lawyers as the real <b>enemy</b>.</i>
objector	A person who expresses opposition to or disagreement with something. <i>Objectors</i> to the housing plans.
opponent	Characterized by active hostility. <b>Opponent</b> or opposing armies.
oppose	Be against; express opposition to. We <b>oppose</b> the ban on abortion.
<u>overtake</u>	Catch up with and possibly overtake. <i>He overtook in the face of oncoming traffic.</i>
<u>postulate</u>	Take as a given assume as a postulate or axiom. Perhaps the <b>postulate</b> of Babylonian influence on Greek astronomy is incorrect.
protester	A person who dissents from some established policy. The decision was hailed by <b>protester</b> s against the closure as a triumph.
rival	Be the rival of be in competition with. She has no <b>rival</b> s as a female rock singer.



<u>rivalry</u>	Competition for the same objective or for superiority in the same field. <i>There always has been intense <b>rivalry</b> between the clubs.</i>
strive	Attempt by employing effort. We must <b>strive</b> to secure steady growth.
struggle	Make one's way with difficulty. Before she could <b>struggle</b> he lifted her up.
unseat	Remove (a government or person in authority) from power. The Republicans are trying to <b>unseat</b> the liberal Democrat.
vie	Compete for something; engage in a contest; measure oneself against others. The athletes were vying for a place in the British team.
wrangling	Engagement in a long, complicated dispute or argument. <i>Weeks of political <b>wrangling</b>.</i>
