Associations of "Contradicting" (30 Words)

abnegation	Renunciation of your own interests in favor of the interests of others. <i>Abnegation of the Holy Trinity.</i>
belie	Represent falsely. <i>The quality of the music seems to belie the criticism.</i>
conflicting	In disagreement- John Morley. <i>Conflicting opinions.</i>
contravene	Offend against the prohibition or order of (a law, treaty, or code of conduct). <i>The Privy Council held that the prosecution contravened the rights of the individual.</i>
contravention	Coming into conflict with. <i>There were repeated raids by one side upon the other in contravention of treaty terms.</i>
controvert	Be resistant to. <i>The views in the article have been controverted.</i>
deny	Deny formally an allegation of fact by the opposing party in a legal suit. <i>Both firms deny any responsibility for the tragedy.</i>
disavow	Refuse to acknowledge; disclaim knowledge of; responsibility for, or association with. <i>Her husband disavowed her after 30 years of marriage and six children.</i>
disavowal	Denial of any connection with or knowledge of. <i>His disavowal of his previous writings.</i>
disclaim	Make a disclaimer about. <i>The school disclaimed any responsibility for his death.</i>
disown	Refuse to acknowledge or maintain any connection with. <i>Lovell s rich family had disowned him because of his marriage.</i>
dispute	Take exception to. <i>The estate disputes that it is responsible for the embankment.</i>

impugn	Dispute the truth, validity, or honesty of (a statement or motive); call into question. <i>The father does not impugn her capacity as a good mother.</i>
inadmissible	Not to be allowed or tolerated. <i>Inadmissible evidence.</i>
misrepresent	Give a false or misleading account of the nature of. <i>This statement misrepresents my intentions.</i>
negate	Make ineffective by counterbalancing the effect of. <i>This action will negate the effect of my efforts.</i>
neutralize	Make (something) ineffective by applying an opposite force or effect. <i>The double agent was neutralized.</i>
no	Quantifier used with either mass nouns or plural count nouns for indicating a complete or almost complete lack or zero quantity of. <i>Did it with no help.</i>
nullify	Show to be invalid. <i>Insulin can block the release of the hormone and thereby nullify the effects of training.</i>
objection	The act of protesting; a public (often organized) manifestation of dissent. <i>They have raised no objections to the latest plans.</i>
oppose	Actively resist (a person or system). <i>A workers movement opposed the regime.</i>
rebut	Claim or prove that (evidence or an accusation) is false. <i>He had to rebut charges of acting for the convenience of his political friends.</i>
rebuttal	(law) a pleading by the defendant in reply to a plaintiff's surrejoinder.
refutation	The action of proving a statement or theory to be wrong or false. <i>His refutation of the charges was short and persuasive.</i>
refute	Deny or contradict (a statement or accusation). <i>These claims have not been convincingly refuted.</i>
reject	Reject with contempt. <i>The journal rejected the student s paper.</i>
renounce	Leave (a job, post, or position) voluntarily. <i>They renounced the armed struggle.</i>
repudiate	Cast off. <i>She has repudiated policies associated with previous party leaders.</i>
rescind	Revoke, cancel, or repeal (a law, order, or agreement). <i>The government eventually rescinded the directive.</i>

resist

Resist immunologically the introduction of some foreign tissue or organ.
*The trees **resisted** her.*
