## Associations of "Convicted" (30 Words)

<b>accused</b>	A defendant in a criminal proceeding. <i>The <b>accused</b> was ordered to stand trial on a number of charges.</i>
<b>apprehend</b>	Get the meaning of something. <i>He is a man that <b>apprehends</b> death no more dreadfully but as a drunken sleep.</i>
<b>capture</b>	A person or thing that has been captured. <i>Black cannot <b>capture</b> the knight.</i>
<b><u>confession</u></b>	The religious body or Church sharing a confession of faith. <i>Leading figures from every Christian <b>confession</b>.</i>
<b><u>conviction</u></b>	A final judgment of guilty in a criminal case and the punishment that is imposed. <i>His <b>conviction</b> that the death was no accident was stronger.</i>
<b>criminal</b>	Involving or being or having the nature of a crime. <i>A <b>criminal</b> offense.</i>
<b><u>culprit</u></b>	A person who is responsible for a crime or other misdeed. <i>The car's front nearside door had been smashed in but the <b>culprits</b> had fled.</i>
<b><u>delinquent</u></b>	A delinquent person. <i>Derelect or <b>delinquent</b> in his duty.</i>
<b>felon</b>	A person who has committed a felony. <i>The <b>felon</b> undermining hand of dark corruption.</i>
<b>guilty</b>	Justly chargeable with a particular fault or error. <i><b>Guilty</b> of murder.</i>
<b>impenitent</b>	Impervious to moral persuasion. <i><b>Impenitent</b> elitists.</i>
<b>indictment</b>	A formal charge or accusation of a serious crime. <i>These rapidly escalating crime figures are an <b>indictment</b> of our society.</i>

<b>inmate</b>	A person serving a sentence in a jail or prison. <i>Inmates of the Louisiana State Penitentiary.</i>
<b>intern</b>	Serve as an intern. <i>During WW II Japanese were <b>interned</b> in camps in the West.</i>
<b>murderer</b>	A person who commits murder. <i>Convicted <b>murderers</b>.</i>
<b>offender</b>	A person who commits an illegal act. <i>You can't get away from sex these days and the TV is the worst <b>offender</b>.</i>
<b>parole</b>	Release a criminal from detention and place him on parole. <i>He committed a burglary while on <b>parole</b>.</i>
<b>penance</b>	Impose a penance on. <i>He had done public <b>penance</b> for those hasty words.</i>
<b>penitence</b>	The action of feeling or showing sorrow and regret for having done wrong; repentance. <i>A public display of <b>penitence</b>.</i>
<b>penitent</b>	A person who repents their sins and (in the Christian Church) seeks forgiveness from God. <i>A <b>penitent</b> expression.</i>
<b>penitential</b>	Relating to or expressing penitence or penance. <i><b>Penitential</b> tears.</i>
<b>penitentiary</b>	Used for punishment or reform of criminals or wrongdoers. <i><b>Penitentiary</b> institutions.</i>
<b>perpetrator</b>	Someone who perpetrates wrongdoing. <i>The <b>perpetrators</b> of this horrific crime must be brought to justice.</i>
<b>prison</b>	Imprison. <i>He died in <b>prison</b>.</i>
<b>prisoner</b>	A person who is confined especially a prisoner of war. <i>200 rebels were taken <b>prisoner</b>.</i>
<b>repent</b>	Feel remorse for; feel sorry for; be contrite about. <i>Marian came to <b>repent</b> her hasty judgement.</i>
<b>repentance</b>	Remorse for your past conduct. <i>Each person who turns to God in genuine <b>repentance</b> and faith will be saved.</i>
<b>repentant</b>	Expressing or feeling sincere regret and remorse; remorseful. <i>He is truly <b>repentant</b> for his incredible naivety and stupidity.</i>
<b>sinner</b>	A person who sins (without repenting). <i>God forgives repentant <b>sinner</b>s.</i>

**unrepentant** Not penitent or remorseful.  
*He was **unrepentant** and said that his comments were completely accurate.*
