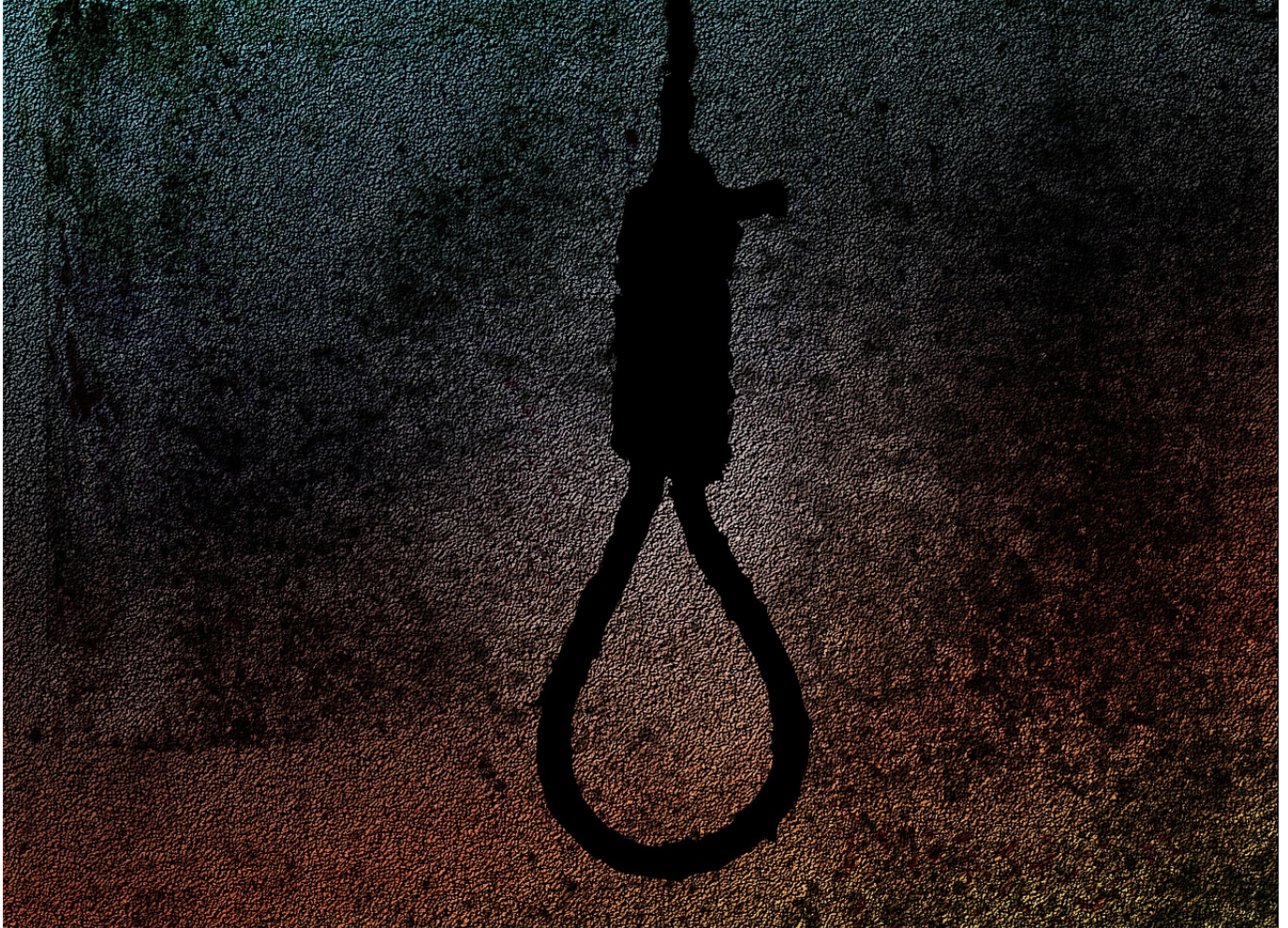

## Conviction as a Noun

### Definitions of "Conviction" as a noun

According to the [Oxford Dictionary of English](#), “conviction” as a noun can have the following definitions:

- *The quality of showing that one is firmly convinced of what one believes or says.*
- *An unshakable belief in something without need for proof or evidence.*
- *(criminal law) a final judgment of guilty in a criminal case and the punishment that is imposed.*
- *A final judgment of guilty in a criminal case and the punishment that is imposed.*
- *A formal declaration by the verdict of a jury or the decision of a judge in a court of law that someone is guilty of a criminal offence.*
- *A firmly held belief or opinion.*



## Synonyms of "Conviction" as a noun (21 Words)

<b>article of faith</b>	A determiner that may indicate the specificity of reference of a noun phrase.
<b>assurance</b>	A statement intended to inspire confidence. <i><b>Assurance</b> of faith depends on our trust in God.</i>
<b>belief</b>	Something one accepts as true or real; a firmly held opinion. <i>The medieval system of fervent religious <b>belief</b>.</i>
<b><u>certainty</u></b>	The state of being certain. <i>He was expected to be a <b>certainty</b> for a gold medal.</i>
<b>certitude</b>	Something that someone firmly believes is true. <i>The question may never be answered with <b>certitude</b>.</i>

<b>condemnation</b>	The act of condemning (as land forfeited for public use) or judging to be unfit for use (as a food product or an unsafe building). <i>There was strong international <b>condemnation</b> of the attack.</i>
<b>confidence</b>	A state of confident hopefulness that events will be favorable. <i>I have <b>confidence</b> in our team.</i>
<b>declaration of guilt</b>	The highest bid becomes the contract setting the number of tricks that the bidder must make.
<b>idea</b>	The content of cognition; the main thing you are thinking about. <i>I took a job with the <b>idea</b> of getting some money together.</i>
<b>judgement</b>	The act of judging or assessing a person or situation or event. <i>The events of last week are a <b>judgement</b> on us for our sinful ways.</i>
<b>judgment of conviction</b>	An opinion formed by judging something.
<b>opinion</b>	A belief or sentiment shared by most people; the voice of the people. <i>My <b>opinion</b> differs from yours.</i>
<b>persuasion</b>	The action or process of persuading someone or of being persuaded to do or believe something. <i>Half a dozen gents of British <b>persuasion</b>.</i>
<b>position</b>	A condition or position in which you find yourself. <i>The party's <b>position</b> on abortion.</i>
<b>positiveness</b>	The quality of being encouraging or promising of a successful outcome.
<b>pronouncement of guilt</b>	An authoritative declaration.
<b>sentence</b>	The punishment assigned to a defendant found guilty by a court, or fixed by law for a particular offence. <i>Slander of an official carried an eight year prison <b>sentence</b>.</i>
<b>stance</b>	Standing posture. <i>She altered her <b>stance</b> resting all her weight on one leg.</i>
<b>sureness</b>	The quality of being steady and unfailing. <i><b>Sureness</b> of hand.</i>
<b>thought</b>	The organized beliefs of a period or group or individual. <i>I asked him if he had any <b>thoughts</b> on how it had happened.</i>
<b>view</b>	Purpose the phrase with a view to means with the intention of or for the purpose of. <i>He tried to get a better <b>view</b> of it.</i>



### **Usage Examples of "Conviction" as a noun**

- *His conviction that the death was no accident was stronger.*
- *She takes pride in stating her political convictions.*
- *She had a previous conviction for a similar offence.*
- *The conviction came as no surprise.*
- *She had been speaking for some five minutes with force and conviction.*



## Associations of "Conviction" (30 Words)

<b><u>acquittal</u></b>	A judgment of not guilty. <i>The women felt their chances of <b>acquittal</b> were poor.</i>
<b><u>arraign</u></b>	Call before a court to answer an indictment. <i>Her sister was <b>arraigned</b> on charges of attempted murder.</i>
<b>captivity</b>	The state of being a slave. <i>He was held in <b>captivity</b> until he died.</i>
<b>capture</b>	A person or thing that has been captured. <i>The militia <b>captured</b> the castle.</i>
<b>committal</b>	The official act of consigning a person to confinement (as in a prison or mental hospital). <i><b>Committal</b> proceedings.</i>

<b>condemnation</b>	(criminal law) a final judgment of guilty in a criminal case and the punishment that is imposed. <i>His uncompromising <b>condemnation</b> of racism.</i>
<b>convict</b>	A person who has been convicted of a criminal offense. <i>Twelve people were <b>convicted</b> for their part in an attempted coup.</i>
<b>criminal</b>	Guilty of crime or serious offense. <i><b>Criminal</b> abuse.</i>
<b>culprit</b>	A person who is responsible for a crime or other misdeed. <i>Low level ozone pollution is the real <b>culprit</b>.</i>
<b>detention</b>	A punishment in which a student must stay at school after others have gone home. <i>His <b>detention</b> was politically motivated.</i>
<b>dungeon</b>	Imprison someone in a dungeon.
<b>felon</b>	A person who has committed a felony. <i>The <b>felon</b> undermining hand of dark corruption.</i>
<b>felony</b>	A crime regarded in the US and many other judicial systems as more serious than a misdemeanour. <i>An accusation of <b>felony</b>.</i>
<b>guilty</b>	Justly chargeable with a particular fault or error. <i>She was <b>guilty</b> of a serious error of judgement.</i>
<b>imprisonment</b>	The act of confining someone in a prison (or as if in a prison). <i>The <b>imprisonment</b> of captured soldiers.</i>
<b>incarcerate</b>	Lock up or confine, in or as in a jail. <i>Many are <b>incarcerated</b> for property offences.</i>
<b>indictment</b>	A formal charge or accusation of a serious crime. <i>An <b>indictment</b> for conspiracy.</i>
<b>inmate</b>	A patient who is residing in the hospital where he is being treated. <i><b>Inmates</b> of the Louisiana State Penitentiary.</i>
<b>jail</b>	Put someone in jail. <i>A <b>jail</b> sentence.</i>
<b>misbehave</b>	(of a machine) fail to function correctly. <i>Josh <b>misbehaved</b> pushing his food off the table.</i>
<b>murderer</b>	A person who commits murder. <i>Convicted <b>murderers</b>.</i>
<b>offender</b>	A person or thing that does something wrong or causes problems. <i>An institution for young <b>offenders</b>.</i>

<b>parole</b>	Release a criminal from detention and place him on parole. <i>A good many French officers had been living on <b>parole</b> in Melrose.</i>
<b>penitentiary</b>	(in the Roman Catholic Church) a priest appointed to administer penance. <i><b>Penitentiary</b> institutions.</i>
<b>perjury</b>	The offence of wilfully telling an untruth or making a misrepresentation under oath. <i>He claimed two witnesses at his trial had committed <b>perjury</b>.</i>
<b>perpetrator</b>	Someone who perpetrates wrongdoing. <i>The <b>perpetrators</b> of this horrific crime must be brought to justice.</i>
<b>prison</b>	A prisonlike situation a place of seeming confinement. <i>Both men were sent to <b>prison</b>.</i>
<b>prisoner</b>	A person who is confined especially a prisoner of war. <i>A <b>prisoner</b> serving a life sentence.</i>
<b>sinner</b>	A person who sins (without repenting). <i>God forgives repentant <b>sinner</b>s.</i>
<b>turpitude</b>	Depraved or wicked behaviour or character. <i>Acts of moral <b>turpitude</b>.</i>
