## Default as a Noun

### Definitions of "Default" as a noun

According to the [Oxford Dictionary of English](#), “default” as a noun can have the following definitions:

- *Failure to fulfil an obligation, especially to repay a loan or appear in a law court.*
- *An option that is selected automatically unless an alternative is specified.*
- *Something that is usual or standard.*
- *A preselected option adopted by a computer program or other mechanism when no alternative is specified by the user or programmer.*
- *Act of failing to meet a financial obligation.*
- *Loss due to not showing up.*
- *Loss resulting from failure of a debt to be paid.*



## Synonyms of "Default" as a noun (12 Words)

- default option** Act of failing to meet a financial obligation.
- failure to pay** A person with a record of failing; someone who loses consistently.
- nonpayment** Act of failing to meet a financial obligation.  
*He was indicted for **nonpayment**.*
- nonremittal** Loss resulting from failure of a debt to be paid.
- normal** A line at right angles to a given line or surface.  
*The view is along the **normal** to the surface.*
- ordinary** Any of the simplest principal charges used in coats of arms (especially chief, pale, bend, fess, bar, chevron, cross, saltire).  
*Not out of the **ordinary**.*
- regular** A soldier in the regular army.  
*The absence of four first team **regulars**.*

<b>routine</b>	A set sequence of steps, part of larger computer program. <i>I settled down into a <b>routine</b> of work and sleep.</i>
<b>set</b>	The descent of a heavenly body below the horizon. <i>Before the <b>set</b> of sun.</i>
<b>standard</b>	A tree or shrub that grows on an erect stem of full height. <i>They live by the <b>standards</b> of their community.</i>
<u><a href="#">stock</a></u>	A portion of a company's stock as held by an individual or group as an investment. <i>Geographically separate <b>stocks</b> of some species are recognized.</i>
<u><a href="#">usual</a></u>	The thing which is typically done or present. <i>My <b>usual</b> please she said to the barman.</i>



### Usage Examples of "Default" as a noun

- *All my life, envy has been my default emotion.*
- *The company will have to restructure its debts to avoid default.*
- *The deteriorating economy pushed defaults to almost \$20 billion.*

- *He lost the game by default.*
- *Default settings.*
- *SSRIs have become the default for adults with depression.*
- *The default is fifty lines.*



## Default as a Verb

### Definitions of "Default" as a verb

According to the [Oxford Dictionary of English](#), "default" as a verb can have the following definitions:

- *(of a computer program or other mechanism) revert automatically to (a preselected option).*
- *Fail to pay up.*
- *Fail to fulfil an obligation, especially to repay a loan or to appear in a law court.*

- *Declare (a party) to have defaulted and give judgement against that party.*



### Synonyms of "Default" as a verb (9 Words)

<b>back out</b>	Give support or one's approval to.
<b>backslide</b>	Drop to a lower level, as in one's morals or standards. <i>There are many things that can cause slimmers to <b>backslide</b>.</i>
<b>backtrack</b>	Pursue, trace, or monitor. <i>Marilyn <b>backtracked</b> and went down into the basement.</i>
<b>default on</b>	Fail to pay up.
<b>fail to honour</b>	Fall short in what is expected.
<b>fail to pay</b>	Fall short in what is expected.
<b>not pay</b>	Convey, as of a compliment, regards, attention, etc.; bestow.
<b>renege</b>	Fail to fulfill a promise or obligation. <i>There s one of them anyhow that didn t <b>renege</b> him.</i>

**revert**

Reply or respond to someone.

*We texted both Farah and Shirish but neither of them **reverted**.*



**Usage Examples of "Default" as a verb**

- *The dealer could repossess the goods if the customer defaulted.*
- *When you start a fresh letter the system will default to its own style.*
- *Some had defaulted on student loans.*
- *Two semi-finalists were defaulted.*



## Associations of "Default" (30 Words)

<b>accrue</b>	Make provision for (a charge) at the end of a financial period for work that has been done but not yet invoiced. <i>They <b>accrue</b> entitlements to holiday pay.</i>
<b>amortize</b>	Liquidate gradually. <i>Eighty per cent of the proceeds has been used to <b>amortize</b> the public debt.</i>
<b>belie</b>	Be in contradiction with. <i>His lively alert manner <b>belied</b> his years.</i>
<b>contradict</b>	Be in contradiction with. <i>He did not <b>contradict</b> what he said last week.</i>
<b>creditor</b>	A person or company to whom money is owing. <i><b>Creditor</b> banks.</i>
<b>debenture</b>	A certificate or voucher acknowledging a debt.

<b>debt</b>	The state of owing something (especially money). <i>He is badly in <b>debt</b>.</i>
<b>deny</b>	Deny formally an allegation of fact by the opposing party in a legal suit. <i>Both firms <b>deny</b> any responsibility for the tragedy.</i>
<b>disavow</b>	Deny any responsibility or support for. <i>Her husband <b>disavowed</b> her after 30 years of marriage and six children.</i>
<b>disbursement</b>	A payment, especially one made by a solicitor to a third party and then claimed back from the client. <i>The bill includes unpaid professional <b>disbursements</b>.</i>
<b>holder</b>	A smallholder. <i>An umbrella <b>holder</b>.</i>
<b>liquidation</b>	The act of exterminating. <i>The company went into <b>liquidation</b>.</i>
<b>loan</b>	Lend (a sum of money or item of property). <i><b>Loan</b> me some money.</i>
<b>misrepresent</b>	Represent falsely. <i>You are <b>misrepresenting</b> the views of the government.</i>
<b>moneylender</b>	Someone who lends money at excessive rates of interest.
<b>moratorium</b>	A temporary prohibition of an activity. <i>A <b>moratorium</b> on the use of drift nets.</i>
<b>negate</b>	Deny the truth of. <i>Alcohol <b>negates</b> the effects of the drug.</i>
<b>negation</b>	A proposition that is true if and only if another proposition is false. <i>The <b>negation</b> of A is briefly not A.</i>
<b>neutralize</b>	Make ineffective by counterbalancing the effect of. <i>Counter intelligence programmes designed to <b>neutralize</b> individuals.</i>
<b>nullify</b>	Make legally null and void; invalidate. <i>Judges were unwilling to <b>nullify</b> government decisions.</i>
<b>owe</b>	Owe something especially money to. <i>I <b>owe</b> it to him to explain what s happened.</i>
<b>owing</b>	Owed as a debt. <i>No rent was <b>owing</b>.</i>
<b>refinance</b>	Finance (something) again, typically with new loans at a lower rate of interest. <i>Companies must <b>refinance</b> 20 billion of warrants and bonds.</i>
<b>repayment</b>	The act of returning money received previously. <i>Minimum monthly <b>repayments</b>.</i>



<b>rescind</b>	Cancel officially. <i>The government eventually <b>rescinded</b> the directive.</i>
<b><u>undesirable</u></b>	One whose presence is undesirable. <i>Rounding up vagrants and drunks and other <b>undesirables</b>.</i>
<b>unpaid</b>	Without payment. <i><b>Unpaid</b> bills.</i>
<b>usury</b>	An exorbitant or unlawful rate of interest. <i>The medieval prohibition on <b>usury</b>.</i>
<b><u>veto</u></b>	A rejection by right of veto. <i>The royal power of <b>veto</b>.</i>
<b><u>wages</u></b>	A recompense for worthy acts or retribution for wrongdoing. <i>The <b>wages</b> of sin is death.</i>
