| <u>decree</u> | The issuing of a decree. <i>Presidential decrees.</i> |
| <u>dictate</u> | A guiding principle. <i>The dictates of reason.</i> |
| <u>dictum</u> | A formal pronouncement from an authoritative source. <i>The old dictum might is right.</i> |
| direction | Something that provides direction or advice as to a decision or course of action. <i>The campaign s lack of direction.</i> |
| <u>directive</u> | A pronouncement encouraging or banning some activity. <i>A new EC directive.</i> |
| <u>dogma</u> | A doctrine or code of beliefs accepted as authoritative. <i>The rejection of political dogma.</i> |
| guideline | A general rule, principle, or piece of advice. <i>The organization has issued guidelines for people working with prisoners.</i> |
| injunction | (law) a judicial remedy issued in order to prohibit a party from doing or continuing to do a certain activity. <i>Injunction were formerly obtained by writ but now by a judicial order.</i> |
| instruction | A direction or order. <i>He issued instructions to the sheriff.</i> |
| ism | A distinctive practice, system, or philosophy, typically a political ideology or an artistic movement. <i>He loathed isms and any form of dogma.</i> |
| <u>law</u> | Systems of law as a subject of study or as the basis of the legal profession. <i>He d never been in trouble with the law in his life.</i> |

| mandate | The commission that is given to a government and its policies through an electoral victory. <i>The last mandate of Trudeau from 1980 to 1984 was a remarkable chapter in Canadian history.</i> |
| order | An institution founded by a monarch along the lines of a medieval crusading monastic order for the purpose of honouring meritorious conduct. <i>We shall consider these questions in the inverse order of their presentation.</i> |
| ordinance | A statute enacted by a city government. <i>His strict observance of religious ordinances was no doubt quickened by the remorse he felt.</i> |
| philosophy | A particular system of philosophical thought. <i>The philosophy of science.</i> |
| prescription | An instruction written by a medical practitioner that authorizes a patient to be issued with a medicine or treatment. <i>The unnecessary prescription of antibiotics.</i> |
| principle | A basic truth or law or assumption. <i>The principles of internal combustion engines.</i> |
| rule | A rule describing or prescribing a linguistic practice. <i>Such accidents are the exception rather than the rule.</i> |
| school of thought | The period of instruction in a school; the time period when school is in session. |
| set of beliefs | Any electronic equipment that receives or transmits radio or tv signals. |
| statute | A written law passed by a legislative body. <i>Immunities granted to trade unions by statute.</i> |
| teaching | Ideas or principles taught by an authority. <i>The teachings of the Koran.</i> |
| tenet | A religious doctrine that is proclaimed as true without proof. <i>The tenets of classical liberalism.</i> |

| missionary | Relating to or characteristic of a missionary or a religious mission. <i>Our taxi driver shared a sense of missionary zeal with us.</i> |
| philosophy | A belief (or system of beliefs) accepted as authoritative by some group or school. <i>The philosophy of science.</i> |
| positivism | A humanistic religious system founded on positivism. |
| pragmatist | An adherent of philosophical pragmatism. <i>American pragmatists have influenced a great deal of recent philosophy of many types.</i> |
| <u>preach</u> | Give moral advice to someone in a pompously self-righteous way. <i>He preached the word of God.</i> |
