<a href="#">anecdote</a>	An account regarded as unreliable or hearsay. <i>His wife s death has long been the subject of rumour and <b>anecdote</b>.</i>
<a href="#">cue</a>	Sports implement consisting of a tapering rod used to strike a cue ball in pool or billiards. <i>Ros and Guil <b>cued</b> by Hamlet also bow deeply.</i>
<a href="#">elicit</a>	Derive by reason. <i>I tried to <b>elicit</b> a smile from Joanna.</i>
<a href="#">enkindle</a>	Call forth (emotions, feelings, and responses). <i>The glare from its <b>enkindled</b> roof illumined its innermost recesses.</i>
<a href="#">evocative</a>	Serving to bring to mind- Wilder Hobson. <i>The building s cramped interiors are highly <b>evocative</b> of past centuries.</i>
<a href="#">hint</a>	Drop a hint intimate by a hint. <i>He has given no <b>hint</b> of his views.</i>
<a href="#">implore</a>	Beg earnestly for. <i>Please don t talk that way Ellen <b>implored</b>.</i>
<a href="#">invoke</a>	Summon into action or bring into existence, often as if by magic. <i>She <b>invoked</b> his help against this attack.</i>
<a href="#">memoir</a>	The proceedings of a learned society. <i>An important <b>memoir</b> on Carboniferous crustacea.</i>
<a href="#">mindful</a>	Bearing in mind; attentive to. <i>Tune in to your body and be <b>mindful</b>.</i>
<a href="#">mnemonic</a>	A device (such as a rhyme or acronym) used to aid recall. <i>The usual <b>mnemonic</b> for star types is O Be A Fine Girl Kiss Me.</i>
<a href="#">nostalgic</a>	A nostalgic person. <i>He remained <b>nostalgic</b> about the good old days.</i>
<a href="#">petition</a>	Present a petition to an authority in respect of a particular cause. <i>The islanders <b>petitioned</b> the government to help them leave St Kilda.</i>

<b><u>propose</u></b>	Propose or intend. <i>He <b>proposed</b> to attend the meeting.</i>
<b>propound</b>	Put forward, as of an idea. <i>He began to <b>propound</b> the idea of a social monarchy as an alternative to Franco.</i>
<b>reawaken</b>	(with reference to a feeling or state) emerge or cause to emerge again; awaken again. <i>A sense of community started to <b>reawaken</b> in the 1970s.</i>
<b>recall</b>	An act or instance of officially recalling someone or something. <i><b>Recall</b> the defective auto tires.</i>
<b>recollect</b>	Recall knowledge from memory have a recollection. <i>He could not quite <b>recollect</b> the reason.</i>
<b><u>recollection</u></b>	The action or faculty of remembering or recollecting something. <i>To the best of my <b>recollection</b> no one ever had a bad word to say about him.</i>
<b>remember</b>	Show appreciation to. <i>I can't <b>remember</b> saying any such thing.</i>
<b>remembrance</b>	A recognition of meritorious service. <i>A flash of <b>remembrance</b> passed between them.</i>
<b>remind</b>	Cause (someone) to remember someone or something. <i>The barman <b>reminded</b> them that singing was not permitted.</i>
<b>reminiscence</b>	A characteristic of one thing that is suggestive of another. <i>His first works are too full of <b>reminiscences</b> of earlier poetry.</i>
<b><u>reminiscent</u></b>	Absorbed in or suggesting absorption in memories. <i>Her robes were vaguely <b>reminiscent</b> of military dress.</i>
<b><u>stasis</u></b>	An abnormal state in which the normal flow of a liquid (such as blood) is slowed or stopped. <i>Long periods of <b>stasis</b>.</i>
<b><u>suggest</u></b>	Suggest the necessity of an intervention in medicine. <i>Finds of lead coffins <b>suggested</b> a cemetery north of the river.</i>
<b><u>summon</u></b>	Ask to come. <i>If the person <b>summoned</b> does not appear he may be arrested.</i>
<b><u>theorize</u></b>	Form a theory or theories about something. <i>He <b>theorized</b> that the atolls marked the sites of vanished volcanoes.</i>
<b>waken</b>	Stop sleeping. <i>She knew he would <b>waken</b> in an hour or so.</i>

**writ**

A form of written command in the name of a court or other legal authority to act or abstain from acting in a particular way.
