acts	A New Testament book describing the development of the early church from Christ's Ascension to Paul's sojourn at Rome.
agenda	A plan of things to be done or problems to be addressed. <i>The question of nuclear weapons had been removed from the agenda.</i>
assembly	A group of people elected to make laws or decisions for a particular country or region. <i>A decree guaranteeing freedom of assembly.</i>
authorization	The action of authorizing. <i>Horowitz handed him the authorization signed by Evans.</i>
bailiff	An officer of the court who is employed to execute writs and processes and make arrests etc.
bicameral	Composed of two legislative bodies. <i>The bicameral heart of a fish.</i>
bipartisan	Involving the agreement or cooperation of two political parties that usually oppose each other's policies. <i>Bipartisan support.</i>
bureaucracy	The officials in a bureaucracy considered as a group or hierarchy. <i>The unnecessary bureaucracy in local government.</i>
caucus	Of a voter attend an electoral caucus especially on behalf of a particular candidate. <i>Mr Kerry attended the morning caucus in the Old Senate Chamber where his fellow Democrats selected the new minority leadership.</i>
committee	In the UK the whole House of Commons when sitting as a committee. <i>The housing committee.</i>
congress	(often in names) a political society or organization. <i>Sexual congress.</i>

congressional	Belonging or relating to a national legislative body, especially that of the US. <i>The document surfaced in a congressional hearing last year.</i>
enactment	A legal document codifying the result of deliberations of a committee or society or legislative body. <i>Enactments covering food safety.</i>
federal	Any federal law enforcement officer. <i>Federal courts.</i>
judiciary	The judicial authorities of a country; judges collectively. <i>The independence of the judiciary.</i>
juridical	Of or relating to the law or jurisprudence. <i>Clear words are a matter of practical rather than juridical significance.</i>
lawful	Of a child born within a lawful marriage. <i>Lawful methods of dissent.</i>
legal	Having legal efficacy or force. <i>The European legal system.</i>
legality	The quality or state of being in accordance with the law. <i>Documentation testifying to the legality of the arms sale.</i>
legislator	A person who makes laws; a member of a legislative body. <i>24 incumbent legislators lost their seats.</i>
legislature	The legislative body of a country or state. <i>The Nevada state legislature passed a law to prohibit dumping of nuclear waste.</i>
legitimate	Make an illegitimate child legitimate declare the legitimacy of someone. <i>A legitimate male heir.</i>
legitimately	In a lawfully recognized manner. <i>Consumers could legitimately claim to have been misled.</i>
licit	Authorized, sanctioned by, or in accordance with law. <i>Usage patterns differ between licit and illicit drugs.</i>
parliament	The members of Parliament between one dissolution and the next. <i>The Russian parliament.</i>
policy	Written contract or certificate of insurance. <i>You should have read the small print on your policy.</i>
polity	The form of government of a social organization. <i>A vision of a plural Arab polity.</i>
right	A blow given with the right fist. <i>The right time to act.</i>
