### Synonyms of "Forcibly" as an adverb (16 Words)

<b>aggressively</b>	In a manner resulting from or betraying aggression. <i>He resisted violently and continued to behave <b>aggressively</b> in the police car.</i>
<b>by force</b>	So as to pass a given point.
<b>compulsorily</b>	In a way that is required by law or a rule. <i>Every dog that is neutered is <b>compulsorily</b> vaccinated against rabies.</i>
<b>dynamically</b>	Used in relation to web pages that update frequently or are generated according to an individual’s search terms. <i>This situation can change <b>dynamically</b> on the timescale of minutes.</i>

<b>eagerly</b>	Used to emphasize a strong desire to do or have something. <i>Original illustrations are <b>eagerly</b> sought by collectors.</i>
<b>energetically</b>	In an energetic manner. <i>He <b>energetically</b> pursued his business activities.</i>
<b>forcefully</b>	Using considerable physical strength or violence. <i>He <b>forcefully</b> shoved her back into the wall.</i>
<b>heartily</b>	In a hearty manner. <i>Yes the children chorused <b>heartily</b>.</i>
<b>potently</b>	In a manner having a powerful influence. <i>Clytemnestra's ghost crying in the night for vengeance remained most <b>potently</b> in the audience's mind.</i>
<b>powerfully</b>	In a manner having a powerful influence. <i>A <b>powerfully</b> moving human drama.</i>
<b>strenuously</b>	With great effort and determination. <i>She campaigned <b>strenuously</b> for cheaper fares.</i>
<b>under coercion</b>	Down to defeat, death, or ruin.
<b>under compulsion</b>	Down below.
<b>under protest</b>	Below the horizon.
<b>vigorously</b>	Forcefully. <i>He defended his ideas <b>vigorously</b>.</i>
<b>zealously</b>	With great energy or enthusiasm in pursuit of a cause or objective. <i>He laboured <b>zealously</b> for the promotion of education.</i>

## Usage Examples of "Forcibly" as an adverb

- They argued forcibly against the proposal.
- No one will be forcibly evicted.

## Associations of "Forcibly" (30 Words)

<b>abduction</b>	Moving of a body part away from the central axis of the body. <i><b>Abductions</b> by armed men in plain clothes.</i>
<b>blackmail</b>	Money demanded by a person or group engaged in blackmail. <i>He had <b>blackmailed</b> her into sailing with him.</i>
<b>captivity</b>	The state of being a slave-Shakespeare. <i>So every bondman in his own hand bears the power to cancel his <b>captivity</b>.</i>

<b>coercion</b>	Using force to cause something to occur. <i>Our problem cannot be solved by any form of <b>coercion</b> but only by agreement.</i>
<b>compel</b>	Necessitate or exact. <i>His striking appearance <b>compelled</b> attention.</i>
<b>compelling</b>	Not able to be resisted; overwhelming. <i>There is <b>compelling</b> evidence that the recession is ending.</i>
<b>compulsion</b>	An urge to do or say something that might be better left undone or unsaid. <i>Her <b>compulsion</b> to wash her hands repeatedly.</i>
<b>compulsory</b>	Required by rule. <i>It was <b>compulsory</b> to attend mass.</i>
<b>confinement</b>	The act of restraining of a person's liberty by confining them. <i>He was immediately released from his <b>confinement</b>.</i>
<b>conscription</b>	Compulsory enlistment for state service, typically into the armed forces. <i><b>Conscription</b> was extended to married men.</i>
<b>constrain</b>	Compel to behave in a certain way. <i>Duty <b>constrains</b> one to act often contrary to one's desires or inclinations.</i>
<b>disarmament</b>	The reduction or withdrawal of military forces and weapons. <i>The <b>disarmament</b> of the aggressor nations must be complete.</i>
<b>dispossess</b>	Deprive (someone) of land, property, or other possessions. <i>A champion of the poor and the <b>dispossessed</b>.</i>
<b>duress</b>	Compulsory force or threat. <i>Confessed under <b>duress</b>.</i>
<b>enforced</b>	Forced or compelled or put in force. <i><b>Enforced</b> obedience.</i>
<b>enslavement</b>	The state of being a slave—Shakespeare. <i>The <b>enslavement</b> of millions of Africans.</i>
<b>fixation</b>	The process by which some plants and microorganisms assimilate nitrogen or carbon dioxide. <i><b>Fixation</b> at the oral phase might result in dependence on others.</i>
<b>force</b>	Force into or from an action or state either physically or metaphorically. <i>She <b>forced</b> her diet fads on him.</i>
<b>forced</b>	Forced or compelled. <i>A <b>forced</b> landing.</i>
<b>imprisonment</b>	Putting someone in prison or in jail as lawful punishment. <i>The <b>imprisonment</b> of captured soldiers.</i>

<b>mandatory</b>	Required by law or mandate; compulsory. <i>Attendance is <b>mandatory</b>.</i>
<b><u>must</u></b>	Something that should not be overlooked or missed. <i>You <b>must</b> show your ID card.</i>
<b>obligate</b>	Bind by an obligation; cause to be indebted. <i><b>Obligate</b> money.</i>
<b>obligatory</b>	Morally or legally constraining or binding. <i>He made all the <b>obligatory</b> apologies.</i>
<b><u>obsession</u></b>	An idea or thought that continually preoccupies or intrudes on a person's mind. <i>He was in the grip of an <b>obsession</b> he was powerless to resist.</i>
<b>required</b>	Required by rule. <i>The corset the garment that ensured the <b>required</b> female shape.</i>
<b>sequester</b>	Take legal possession of (assets) until a debt has been paid or other claims have been met. <i>In November 1956 the property was <b>sequestered</b> by the authorities.</i>
<b><u>servitude</u></b>	The subjection of property to an easement. <i>You ve got thousands of years of peasant <b>servitude</b> to make up for.</i>
