## Synonyms of "Implements" as a verb (8 Words)

<b>apply</b>	Apply to a surface. <i>Normal rules <b>apply</b>.</i>
<b>carry out</b>	Transmit or serve as the medium for transmission.
<b>enforce</b>	Ensure observance of laws and rules. <i>There is no outside agency to <b>enforce</b> cooperation between the players.</i>
<b>follow out</b>	Grasp the meaning.
<b>follow through</b>	Work in a specific place, with a specific subject, or in a specific function.
<b>follow up</b>	Follow with the eyes or the mind.
<b>go through with</b>	Progress by being changed.
<b>put through</b>	Put into a certain place or abstract location.

## Associations of "Implements" (30 Words)

<b>administration</b>	The action of dispensing, giving, or applying something. <i>The inhabitants of the island voted to remain under French <b>administration</b>.</i>
<b>advocacy</b>	Active support of an idea or cause etc.; especially the act of pleading or arguing for something. <i>His outspoken <b>advocacy</b> of the agreement has won no friends.</i>
<b>agenda</b>	The underlying intentions or motives of a particular person or group. <i>He vowed to put jobs at the top of his <b>agenda</b>.</i>
<b>antitrust</b>	Of laws and regulations; designed to protect trade and commerce from unfair business practices.
<b>apply</b>	Apply oneself to. <i>You need to <b>apply</b> to the local authority for a grant.</i>
<b>autarchy</b>	A political system governed by a single individual.



<b>authorities</b>	The organization that is the governing authority of a political unit. <i>The matter was referred to higher <b>authorities</b>.</i>
<b>bureau</b>	An office or department for transacting particular business. <i>The London <b>bureau</b> of the Washington Post.</i>
<b>chairman</b>	The permanent or long-term president of a committee, company, or other organization. <i>The party <b>chairman</b>.</i>
<b>charter</b>	Grant a charter to. <i>He described the act as a <b>charter</b> for vandals.</i>
<b>decree</b>	The issuing of a decree. <i>The president <b>decreeed</b> that the military was to be streamlined.</i>
<b>deregulation</b>	The act of freeing from regulation (especially from governmental regulations). <i>Banks were allowed to grant mortgages following financial <b>deregulation</b>.</i>
<b>enforce</b>	Ensure observance of laws and rules. <i>There is no outside agency to <b>enforce</b> cooperation between the players.</i>
<b>enforcement</b>	The act of enforcing; ensuring observance of or obedience to. <i>The strict <b>enforcement</b> of environmental regulations.</i>
<b>expansionist</b>	Of or involving or guided by expansionism. <i>The imperial government became increasingly bent on <b>expansionist</b> policies.</i>
<b>extraterritorial</b>	Situated outside a country's territory. <i>Foreign embassies have <b>extraterritorial</b> rights.</i>
<b>fed</b>	Any federal law enforcement officer.
<b>federal</b>	Any federal law enforcement officer. <i><b>Federal</b> courts.</i>
<b>government</b>	Government the system or form by which a community or other political unit is governed. <i>Successive Labour <b>governments</b>.</i>
<b>impose</b>	Impose and collect. <i>Sanctions <b>imposed</b> on South Africa.</i>
<b>jurisdiction</b>	The extent of the power to make legal decisions and judgements. <i>In some <b>jurisdictions</b> there is a mandatory death sentence for murder.</i>
<b>law</b>	The branch of philosophy concerned with the law and the principles that lead courts to make the decisions they do. <i><b>Law</b> students.</i>

<b>legislation</b>	Law enacted by a legislative body. <i>It will require <b>legislation</b> to change this situation.</i>
<b>legislative</b>	Having the power to make laws. <i>The country s supreme <b>legislative</b> body.</i>
<b>militarism</b>	The belief that a country should maintain a strong military capability and be prepared to use it aggressively to defend or promote national interests. <i>The need for liberal democratic reforms to avoid a revival of <b>militarism</b>.</i>
<b>organization</b>	The way in which the elements of a whole are arranged. <i>A research <b>organization</b>.</i>
<b>policy</b>	A course or principle of action adopted or proposed by an organization or individual. <i>You should have read the small print on your <b>policy</b>.</i>
<b>polity</b>	A form or process of civil government or constitution. <i>We was innocent of stratagems and <b>polity</b>.</i>
<b>protocol</b>	Rules determining the format and transmission of data. <i>Safety <b>protocols</b>.</i>
<b>refund</b>	A repayment of a sum of money. <i>If you re not delighted with your purchase we guarantee to <b>refund</b> your money in full.</i>
