## Synonyms of "Injustice" as a noun (21 Words)

<b>affront</b>	An action or remark that causes outrage or offence. <i>The sackings were an <b>affront</b> to justice.</i>
<b>atrocities</b>	The quality of being shockingly cruel and inhumane. <i>A textbook which detailed war atrocities.</i>
<b>corruption</b>	Dishonest or fraudulent conduct by those in power, typically involving bribery. <i>The journalist who wants to expose <b>corruption</b> in high places.</i>
<b>crime</b>	An act punishable by law; usually considered an evil act. <i><b>Crimes</b> of the heart.</i>
<b>disgrace</b>	A state of dishonor. <i>He left the army in <b>disgrace</b>.</i>
<b>evil</b>	That which causes harm or destruction or misfortune- Shakespeare. <i>The <b>evil</b> that men do lives after them the good is oft interred with their bones.</i>
<b>grievance</b>	A complaint about a (real or imaginary) wrong that causes resentment and is grounds for action. <i>A website which enabled staff to air their <b>grievances</b>.</i>
<b>inequity</b>	Lack of fairness or justice. <i>Policies aimed at redressing racial <b>inequity</b>.</i>
<b>iniquity</b>	Morally objectionable behavior. <i>A den of <b>iniquity</b>.</i>
<b>injury</b>	Damage to a person's feelings. <i>She suffered an <b>injury</b> to her back.</i>
<b>misdeed</b>	Improper or wicked or immoral behavior. <i>His past <b>misdeeds</b> were forgiven.</i>
<b>monstrosity</b>	A thing, especially a building, which is very large and unsightly. <i>Had my tone of reason in the face of <b>monstrosity</b> finally registered.</i>
<b>offence</b>	A thing that constitutes a violation of what is judged to be right or natural. <i>Reductions in strategic <b>offence</b> arsenals.</i>
<b>outrage</b>	An action or event causing outrage. <i>The decision was an <b>outrage</b>.</i>
<b>scandal</b>	The outrage or anger caused by a scandalous action or event. <i>It s a <b>scandal</b> that many older patients are dismissed as untreatable.</i>
<b>shabbiness</b>	An unjust act.

<b><u>sin</u></b>	An immoral act considered to be a transgression against divine law. <i>He committed the unforgivable <b>sin</b> of <b>refusing</b> to give interviews.</i>
<b>unfairness</b>	Partiality that is not fair or equitable. <i>The multiple <b>unfairnesses</b> the elderly face.</i>
<b>unjustness</b>	The practice of being unjust or unfair.
<b><u>villainy</u></b>	The quality of evil by virtue of villainous behavior. <i>The <b>villainy</b> of professional racketeers.</i>
<b>wrong</b>	Any harm or injury resulting from a violation of a legal right. <i>I was trying to teach my children right from <b>wrong</b>.</i>

## Associations of "Injustice" (30 Words)

<b>bias</b>	Cause to be biased. <i>A <b>bias</b> fold.</i>
<b>biased</b>	Unfairly prejudiced for or against someone or something. <i>We will not tolerate this <b>biased</b> media coverage.</i>
<b>bigot</b>	A person who is obstinately or unreasonably attached to a belief, opinion, or faction, especially one who is prejudiced against or antagonistic towards a person or people on the basis of their membership of a particular group. <i>A racist <b>bigot</b>.</i>
<b>bigoted</b>	Blindly and obstinately attached to some creed or opinion and intolerant toward others. <i>A <b>bigoted</b> group of reactionaries.</i>
<b>countryman</b>	A man who lives in the country and has country ways. <i>They trust a fellow <b>countryman</b>.</i>
<b>discriminate</b>	Distinguish. <i>Existing employment policies <b>discriminate</b> against women.</i>
<b>discriminatory</b>	Containing or implying a slight or showing prejudice. <i><b>Discriminatory</b> attitudes and practices.</i>
<b>dispossession</b>	Freeing from evil spirits. <i>The global impact of poverty and <b>dispossession</b>.</i>
<b>eviction</b>	The action of expelling someone from a property; expulsion. <i>The forced <b>eviction</b> of residents.</i>
<b>fractional</b>	Small or tiny in amount. <i>There was a <b>fractional</b> hesitation before he said yes.</i>
<b>fragmentary</b>	Consisting of small disconnected or incomplete parts. <i><b>Fragmentary</b> remains.</i>
<b>grievance</b>	An official statement of a complaint over something believed to be wrong or unfair. <i>Three pilots have filed <b>grievances</b> against the company.</i>
<b>illiberal</b>	Not generous; mean. <i><b>Illiberal</b> and anti democratic policies.</i>
<b>inequality</b>	A symbolic expression of the fact that two quantities are not equal. <i>The <b>inequality</b> of the ground hindered their footing.</i>
<b>iniquity</b>	An unjust act. <i>A den of <b>iniquity</b>.</i>

<b><u>intolerance</u></b>	Impatience with annoyances. <i>He may have a food <b>intolerance</b> to dairy products.</i>
<b><u>intolerant</u></b>	Unable to be given (a medicine or other treatment) or to eat (a food) without adverse effects. <i>He s recently been diagnosed as gluten <b>intolerant</b>.</i>
<b>invidious</b>	Containing or implying a slight or showing prejudice. <i><b>Invidious</b> comparisons.</i>
<b><u>partial</u></b>	Having a liking for. <i>A <b>partial</b> monopoly.</i>
<b>partiality</b>	Unfair bias in favour of one person or thing; favouritism. <i>An attack on the <b>partiality</b> of judges.</i>
<b>prejudice</b>	Give rise to prejudice in someone make biased. <i><b>Prejudice</b> resulting from delay in the institution of the proceedings.</i>
<b>prejudiced</b>	Being biased or having a belief or attitude formed beforehand. <i>A <b>prejudiced</b> judge.</i>
<b>prepossess</b>	Possess beforehand. <i>The idea of his failure <b>prepossesses</b> him.</i>
<b>racism</b>	Prejudice, discrimination, or antagonism by an individual, community, or institution against a person or people on the basis of their membership of a particular racial or ethnic group, typically one that is a minority or marginalized. <i>A programme to combat <b>racism</b>.</i>
<b><u>sexist</u></b>	A person with sexist views. <i><b>Sexists</b> have no place in our modern political campaigns.</i>
<b><u>subjective</u></b>	The subjective case. <i>There is always the danger of making a <b>subjective</b> judgement.</i>
<b>unfair</b>	Not following the rules of a game or sport. <i>It was an <b>unfair</b> trial.</i>
<b><u>unfavorable</u></b>	Not encouraging or approving or pleasing. <i>An <b>unfavorable</b> comparison.</i>
<b>wreckage</b>	The remaining parts of something that has been wrecked. <i>Firemen had to cut him free from the <b>wreckage</b> of the car.</i>
<b><u>wrongly</u></b>	In an inaccurate manner. <i>Henry <b>wrongly</b> claimed 39 000 of taxpayers money.</i>
