<b>be firm</b>	Have life, be alive.

<b>brook no refusal</b>	Put up with something or somebody unpleasant.
<b>call for</b>	Demand payment of (a loan.
<b>claim</b>	Lay claim to as of an idea. <i>Mr Smith <b>claims</b> special tax exemptions because he is a foreign resident.</i>
<b>command</b>	Be in command of. <i>They <b>command</b> a majority in Parliament.</i>
<b><u>contend</u></b>	Succeed in doing, achieving, or producing (something) with the limited or inadequate means available. <i>He <b>contends</b> that the judge was wrong.</i>
<b><u>declare</u></b>	Declare to be. <i>The president had <b>declared</b> for denuclearization of Europe.</i>
<b>demand</b>	Require; need. <i>Where is she he <b>demanded</b>.</i>
<b><u>dictate</u></b>	Control or decisively affect; determine. <i>He <b>dictated</b> a report to his secretary.</i>
<b>emphasize</b>	Give special importance or value to (something) in speaking or writing. <i>They <b>emphasize</b> the need for daily one to one contact between parent and child.</i>
<b><u>exact</u></b>	Inflict (revenge) on someone. <i>He <b>exacted</b> promises that another Watergate would never be allowed to happen.</i>
<b>hold</b>	Hold the attention of. <i>She <b>holds</b> a Master s degree from Harvard.</i>
<b>hold on</b>	Protect against a challenge or attack.
<b>hold out</b>	Have as a major characteristic.
<b>hold out for</b>	Resist or confront with resistance.
<b>importune</b>	Harass (someone) persistently for or to do something. <i>I <b>importune</b> you to help them.</i>
<b>impose</b>	Impose and collect. <i>Sanctions <b>imposed</b> on South Africa.</i>
<b>insist on</b>	Be emphatic or resolute and refuse to budge.

<b>maintain</b>	Maintain for use and service. <i>He had persistently <b>maintained</b> that he would not stand against his old friend.</i>
<b>make a condition of</b>	Undergo fabrication or creation.
<b>make a stand</b>	Undergo fabrication or creation.
<b>not take no for an answer</b>	Accept or undergo, often unwillingly.
<b>press for</b>	Exert oneself continuously, vigorously, or obtrusively to gain an end or engage in a crusade for a certain cause or person; be an advocate for.
<b><u>proclaim</u></b>	Say something emphatically; declare. <i>He had a rolling gait that <b>proclaimed</b> him a man of the sea.</i>
<b>pronounce</b>	Pronounce judgment on. <i>The Secretary of State will shortly <b>pronounce</b> on alternative measures.</i>
<b>propound</b>	Put forward, as of an idea. <i>He began to <b>propound</b> the idea of a social monarchy as an alternative to Franco.</i>
<b><u>protest</u></b>	Utter words of protest. <i>Doctors and patients <b>protested</b> against plans to cut services at the hospital.</i>
<b>push for</b>	Strive and make an effort to reach a goal.
<b>reiterate</b>	To say, state, or perform again. <i>He <b>reiterated</b> the points made in his earlier speech.</i>
<b><u>repeat</u></b>	Repeat an earlier theme of a composition. <i>Mark had to <b>repeat</b> first and second grades.</i>
<b>request</b>	Express the need or desire for. <i>The letter <b>requested</b> him to report to London.</i>
<b>require</b>	Require as useful just or proper. <i>Three patients <b>required</b> operations.</i>
<b>show determination</b>	Provide evidence for.
<b>stand firm</b>	Be in effect; be or remain in force.
<b>stand one's ground</b>	Be in some specified state or condition.
<b>stand up for oneself</b>	Remain inactive or immobile.
<b>state</b>	Express in words. <i><b>State</b> your opinion.</i>

<b>stipulate</b>	Make an oral contract or agreement in the verbal form of question and answer that is necessary to give it legal force. <i>They <b>stipulated</b> to release all the prisoners.</i>
<b>stress</b>	To stress single out as important. <i>I want it done very very neatly she <b>stressed</b>.</i>
<b>swear</b>	To declare or affirm solemnly and formally as true. <i>They were reluctant to <b>swear</b> allegiance.</i>
<b>take a firm stand</b>	Interpret something in a certain way; convey a particular meaning or impression.
<b><u>VOW</u></b>	Make a vow promise. <i>I <b>vowed</b> myself to this enterprise.</i>

<b>advocate</b>	Publicly recommend or support. <i>The doctor <b>advocated</b> a smoking ban in the entire house.</i>
<b><u>affirmation</u></b>	A solemn declaration that serves the same purpose as an oath (if an oath is objectionable to the person on religious or ethical grounds). <i>The lack of one or both parents <b>affirmation</b> leaves some children emotionally crippled.</i>
<b>arguable</b>	Able to be argued or asserted. <i>It was <b>arguable</b> that the bank had no authority to honour the cheques.</i>
<b>argue</b>	Present reasons and arguments. <i>I tried to <b>argue</b> him out of it.</i>
<b><u>assert</u></b>	Assert to be true. <i>He <b>asserted</b> his innocence.</i>
<b>asserting</b>	Relating to the use of or having the nature of a declaration.
<b>assertion</b>	A declaration that is made emphatically (as if no supporting evidence were necessary). <i>His <b>assertion</b> that his father had deserted the family.</i>
<b>claim</b>	Lay claim to as of an idea. <i>The premiums are reduced by fifty per cent if you don't <b>claim</b> on the policy.</i>
<b><u>contend</u></b>	Maintain or assert. <i>Factions within the government were <b>contending</b> for the succession to the presidency.</i>
<b><u>declaration</u></b>	A statement that is emphatic and explicit (spoken or written). <i>A <b>declaration</b> of independence.</i>
<b>declaratory</b>	Having the function of declaring or explaining something. <i>A <b>declaratory</b> ruling in favour of the applicants.</i>
<b>demand</b>	The act of demanding. <i>A <b>demand</b> for specialists.</i>
<b>demur</b>	Enter a demurrer. <i>Normally she would have accepted the challenge but she <b>demurred</b>.</i>

<b>deny</b>	Deny oneself something restrain especially from indulging in some pleasure. <i>Both firms <b>deny</b> any responsibility for the tragedy.</i>
<b>disprove</b>	Prove that (something) is false. <i>The physicist <b>disproved</b> his colleagues theories.</i>
<b>dispute</b>	Have a disagreement over something. <i>The estate <b>disputes</b> that it is responsible for the embankment.</i>
<b>exaction</b>	A sum of money exacted from someone. <i><b>Exaction</b> of tribute.</i>
<b>gainsay</b>	Deny or contradict (a fact or statement). <i>None could <b>gainsay</b> her.</i>
<b>importunate</b>	Expressing earnest entreaty. <i>An <b>importunate</b> job applicant.</i>
<b>importune</b>	Harass (someone) persistently for or to do something. <i>The president would <b>importune</b> them to try harder.</i>
<b>inadmissible</b>	Not to be allowed or tolerated. <i>An <b>inadmissible</b> interference in the affairs of the Church.</i>
<b>ingratitude</b>	A discreditable lack of gratitude. <i>He returned his daughter s care with <b>ingratitude</b> and unkindness.</i>
<b>insistent</b>	Demanding attention. <i>The bluejay s <b>insistent</b> cry.</i>
<b>objection</b>	The act of expressing earnest opposition or protest. <i>They have raised no <b>objections</b> to the latest plans.</i>
<b>persistently</b>	In a persistent manner; continuously. <i>Prices have remained <b>persistently</b> high.</i>
<b>purport</b>	The purpose or intention of something. <i>The letter <b>purports</b> to express people s opinion.</i>
<b>refutable</b>	Able to be refuted.
<b>refute</b>	Prove to be false or incorrect. <i>The speaker <b>refuted</b> his opponent s arguments.</i>
<b>stubborn</b>	Not responding to treatment. <i>Two <b>stubborn</b> young people intent on doing their own thing.</i>
<b>stubbornly</b>	In a way that is difficult to move, remove, or improve. <i>She remained <b>stubbornly</b> in the same position.</i>
