Issue in Present Simple (Indefinite) Tense

Singular Plural

I **issue** We **issue**
You **issue** You **issue**
He/She/It **issues** They **issue**

Issue in Present Continuous (Progressive) Tense

Singular Plural

I **am issuing** We **are issuing**
You **are issuing** You **are issuing**
He/She/It **is issuing** They **are issuing**

Issue in Present Perfect Tense

Singular Plural

I **have issued** We **have issued**
You **have issued** You **have issued**
He/She/It **has issued** They **have issued**

Issue in Present Perfect Continuous Tense

Singular Plural

I **have been issuing** We **have been issuing**
You **have been issuing** You **have been issuing**
He/She/It **has been issuing** They **have been issuing**

Issue in Past Simple (Indefinite) Tense
