Singular Plural

I **lawyer** We **lawyer**
You **lawyer** You **lawyer**
He/She/It **lawyers** They **lawyer**

Lawyer in Present Continuous (Progressive) Tense

Singular Plural

I **am lawyering** We **are lawyering**
You **are lawyering** You **are lawyering**
He/She/It **is lawyering** They **are lawyering**

Lawyer in Present Perfect Tense

Singular Plural

I **have lawyered** We **have lawyered**
You **have lawyered** You **have lawyered**
He/She/It **has lawyered** They **have lawyered**
