## Letting as a Noun

### Definitions of "Letting" as a noun

According to the [Oxford Dictionary of English](#), “letting” as a noun can have the following definitions:

- *A property that is let or available to be let.*
- *Property that is leased or rented out or let.*
- *The action of renting out a property.*



## Synonyms of "Letting" as a noun (2 Words)

**lease** Property that is leased or rented out or let.  
*A six month **lease** on a shop.*

**rental** A rented house or car.  
*A nominal **rental**.*



## Usage Examples of "Letting" as a noun

- *Large houses were subdivided into multiple **lettings**.*
- *She arranged **lettings**.*
- *The renovation of houses for **letting**.*





## Associations of "Letting" (30 Words)

<b>annuity</b>	A form of insurance or investment entitling the investor to a series of annual sums. <i>His retirement fund was set up to be paid as an <b>annuity</b>.</i>
<b><u>apartment</u></b>	A block of apartments. <i>Self catering holiday <b>apartments</b>.</i>
<b><u>arrears</u></b>	Money that is owed and should have been paid earlier. <i>He was suing the lessee for the <b>arrears</b> of rent.</i>
<b>basement</b>	The oldest formation of rocks underlying a particular area. <i>A <b>basement</b> flat.</i>
<b>building</b>	The occupants of a building. <i>The <b>building</b> of motorways.</i>
<b><u>charter</u></b>	Grant a charter to a city company university or other body. <i>The town received a <b>charter</b> from the Emperor.</i>

<b>condominium</b>	The system of ownership by which condominiums operate in which owners have full title to the individual apartment or house and an undivided interest in the shared parts of the property. <i>Sudan was from 1899 an Anglo Egyptian <b>condominium</b>.</i>
<b>contract</b>	Enter into a contractual arrangement. <i>Glass <b>contracts</b> as it cools.</i>
<b><u>cottage</u></b>	Perform homosexual acts in a public toilet. <i>They said that at some point in their lives they ve <b>cottaged</b> or cruised in parks.</i>
<b>duplex</b>	Having two parts used technically of a device or process duplex adj allowing communication in opposite directions simultaneously. <i>A <b>duplex</b> transaction.</i>
<b>edifice</b>	A complex system of beliefs. <i>The concepts on which the <b>edifice</b> of capitalism was built.</i>
<b>flophouse</b>	A dosshouse. <i>They are living in a <b>flophouse</b> and discovering that the streets are not paved with gold.</i>
<b>hire</b>	Engage or hire for work. <i>Car <b>hire</b> is recommended.</i>
<b>homestead</b>	Land acquired from the United States public lands by filing a record and living on and cultivating it under the homestead law.
<b>house</b>	The people living in a house a household. <i>It was a good Christian <b>household</b>.</i>
<b>landlady</b>	A landlord who is a woman.
<b>landlord</b>	A man who keeps lodgings, a boarding house, or a pub.
<b>lease</b>	Hold under a lease or rental agreement of goods and services. <i>Land was <b>leased</b> from the Duchy of Cornwall.</i>
<b><u>let</u></b>	Used in the imperative to formulate various expressions. <i>This <b>let</b> me in for a big surprise.</i>
<b><u>loan</u></b>	The temporary provision of money (usually at interest). <i>He knew Rab would not <b>loan</b> him money.</i>
<b>mews</b>	A row or street of houses or flats that have been converted from stables or built to look like former stables. <i>An eighteenth century <b>mews</b>.</i>
<b>mortgage</b>	The amount of money borrowed in a mortgage. <i>A heavily <b>mortgaged</b> farm.</i>

<b>negotiate</b>	Try to reach an agreement or compromise by discussion. <i>They <b>negotiated</b> the sale of the house.</i>
<b>payment</b>	An act of requiting; returning in kind. <i>Three interest free monthly <b>payments</b>.</i>
<u><b>proprietor</b></u>	The owner of a business, or a holder of property. <i>By 1640 he was himself the <b>proprietor</b> of a three hundred acre tract.</i>
<b>rent</b>	Hold under a lease or rental agreement of goods and services. <i>Let s <b>rent</b> a car.</i>
<b>rental</b>	Of or relating to rent. <i>A nominal <b>rental</b>.</i>
<b>renter</b>	A male prostitute.
<u><b>tenant</b></u>	Occupy as a tenant. <i>Council house <b>tenants</b>.</i>
<u><b>warden</b></u>	The head of certain schools, colleges, or other institutions. <i>Securely handcuffed to a <b>warden</b> he was taken to Wandsworth Prison.</i>
