I **litigate**

We **litigate**

You **litigate**

You **litigate**

He/She/It **litigates**

They **litigate**

## **Litigate in Present Continuous (Progressive) Tense**

**Singular**

**Plural**

I **am litigating**

We **are litigating**

You **are litigating**

You **are litigating**

He/She/It **is litigating**

They **are litigating**

## **Litigate in Present Perfect Tense**

**Singular**

**Plural**

I **have litigated**

We **have litigated**

You **have litigated**

You **have litigated**

He/She/It **has litigated**

They **have litigated**

## **Litigate in Present Perfect Continuous Tense**

I **have been litigating**

We **have been litigating**

He/She/It **has been litigating**

## **Litigate in Past Continuous (Progressive) Tense**

I **was litigating**      We **were litigating**  
You **were litigating**      You **were litigating**  
He/She/It **was litigating**      They **were litigating**

I **had litigated**      We **had litigated**

He/She/It **had litigated**      They **had litigated**
