Mediator as a Noun

Definitions of "Mediator" as a noun

According to the [Oxford Dictionary of English](#), “mediator” as a noun can have the following definitions:

- *A person who attempts to make people involved in a conflict come to an agreement; a go-between.*
- *A negotiator who acts as a link between parties.*

intercessor	A negotiator who acts as a link between parties. <i>They rejected the notion that an intercessor was needed to appeal to God.</i>
intermediary	A person who acts as a link between people in order to try and bring about an agreement; a mediator. <i>Negotiations took place through an intermediary.</i>
intermediator	A negotiator who acts as a link between parties.
intervenor	(law) a party who interposes in a pending proceeding.
judge	A public officer appointed to decide cases in a law court. <i>She was a good judge of character.</i>
liaison officer	A channel for communication between groups.
middleman	A person who arranges business or political deals between other people. <i>We maintain value for money by cutting out the middleman and selling direct.</i>
moderator	An arbitrator or mediator. <i>The debates will each feature one moderator and a panel of three questioners.</i>
negotiator	A person who conducts negotiations. <i>US trade negotiators.</i>
peacemaker	Someone who tries to bring peace.
reconciler	Someone who tries to bring peace.
referee	An official who watches a game or match closely to ensure that the rules are adhered to and (in some sports) to arbitrate on matters arising from the play. <i>Most journals send the referees reports to the author.</i>
umpire	An official at a baseball game. <i>An umpire was appointed to settle the tax case.</i>



Usage Examples of "Mediator" as a noun

- *The government appointed a mediator to assist in finding a resolution to the dispute.*



Associations of "Mediator" (30 Words)

adjudicator	A person who studies and settles conflicts and disputes. <i>The proposal to close the school will have to go before an adjudicator.</i>
arbitrate	Act between parties with a view to reconciling differences. <i>The board has the power to arbitrate in disputes.</i>
<u>arbitration</u>	The act of deciding as an arbiter; giving authoritative judgment. <i>They submitted their disagreement to arbitration.</i>
arbitrator	Someone chosen to judge and decide a disputed issue. <i>The arbitrator's authority derived from the consent of the disputants.</i>
between	In between. <i>Layers of paper with tar in between.</i>
broker	Act as a broker. <i>Fighting continued despite attempts to broker a ceasefire.</i>

communication	The successful conveying or sharing of ideas and feelings. <i>Satellite communications.</i>
conciliator	A person who acts as a mediator between two disputing people or groups. <i>He was seen as a conciliator who would heal divisions in the party.</i>
disrupt	Make a break in. <i>Flooding disrupted rail services.</i>
intercession	The action of intervening on behalf of another. <i>Prayers of intercession.</i>
intercessor	A person who intervenes on behalf of another, especially by prayer. <i>They rejected the notion that an intercessor was needed to appeal to God.</i>
interfere	Of light or other electromagnetic waveforms interact to produce interference. <i>You promised not to interfere.</i>
interfering	(of a person) tending to interfere in other people's affairs. <i>An interfering old woman.</i>
interject	To insert between other elements. <i>She interjected the odd question here and there.</i>
intermediary	A person who acts as a link between people in order to try and bring about an agreement; a mediator. <i>Negotiations took place through an intermediary.</i>
interposition	The action of interposing someone or something. <i>He owed the preservation of his throne to the miraculous interposition of a stranger who suddenly appeared in his realm.</i>
interrupt	A signal that temporarily stops the execution of a program so that another procedure can be carried out. <i>Please don't interrupt me while I'm on the phone.</i>
intervene	Extend or occur between events. <i>Ludlow took an active part in the events that intervened between the death of Cromwell and the Restoration.</i>
intervention	The act of intervening (as to mediate a dispute, etc). <i>The purpose of intervention is to prevent unnecessary duplication of lawsuits.</i>
intrude	Thrust oneself in as if by force. <i>To intrude political criteria into military decisions risks reducing efficiency.</i>

matchmaker	Someone who arranges (or tries to arrange) marriages for others. <i>An enthusiastic matchmaker who continually tried to pair off the difficult bachelor with unattached ladies.</i>
meddle	Interfere in something that is not one's concern. <i>Don't meddle in my affairs.</i>
meddlesome	Fond of meddling; interfering. <i>Heaven rid him of meddlesome politicians.</i>
mediate	Occupy an intermediate or middle position or form a connecting link or stage between two others. <i>The disease spread by mediate as well as direct contact.</i>
middle	The middle area of the human torso usually in front. <i>The woman was in her middle forties.</i>
negotiator	A person who conducts negotiations. <i>US trade negotiators.</i>
nosy	Pry into something. <i>Nosy neighbours.</i>
pacifier	Anything that serves to pacify.
tamper	A machine or tool for tamping down earth or ballast. <i>Someone tampered with the documents on my desk.</i>
umpire	Be a referee or umpire in a sports competition. <i>He umpired the World Cup final.</i>
