Synonyms of "Misdeed" as a noun (16 Words)

crime	An action or omission which constitutes an offence and is punishable by law. <i>It s a crime to keep a creature like Willy in a tank.</i>
criminal act	Someone who has committed a crime or has been legally convicted of a crime.
error	Part of a statement that is not correct. <i>The crash was caused by human error.</i>
evil deed	The quality of being morally wrong in principle or practice.

felony	A crime regarded in the US and many other judicial systems as more serious than a misdemeanour. <i>An accusation of felony.</i>
misbehavior	Improper or wicked or immoral behavior.
misbehaviour	Improper or wicked or immoral behavior. <i>He had denied all sexual misbehaviour.</i>
<u>misconduct</u>	Bad or dishonest management by persons supposed to act on another's behalf. <i>Smith got a game misconduct for spearing Nick Kypreos.</i>
misdemeanour	A minor wrongdoing. <i>The player can expect a suspension for his latest misdemeanour.</i>
offence	Annoyance or resentment brought about by a perceived insult to or disregard for oneself. <i>He took offence at my question.</i>
peccadillo	A relatively minor fault or sin. <i>The sexual peccadilloes of celebrities aren't necessarily news.</i>
<u>sin</u>	Ratio of the length of the side opposite the given angle to the length of the hypotenuse of a right-angled triangle. <i>A sin in the eyes of God.</i>
transgression	An act that goes against a law, rule, or code of conduct; an offence. <i>Her transgression of genteel etiquette.</i>
<u>violation</u>	Entry to another's property without right or permission. <i>Flagrant violations of normal democratic procedure.</i>
wrong	That which is contrary to the principles of justice or law. <i>I have done you a great wrong.</i>
<u>wrongdoing</u>	Activity that transgresses moral or civil law. <i>Police have denied any wrongdoing.</i>

<u>accusation</u>	A formal charge of wrongdoing brought against a person; the act of imputing blame or guilt. <i>Accusations of bribery.</i>

allegation	A claim or assertion that someone has done something illegal or wrong, typically one made without proof. <i>An allegation of malpractice.</i>
atone	Turn away from sin or do penitence. <i>A human sacrifice to atone for the sin.</i>
commit	Refer a parliamentary or legislative bill to a committee. <i>After the second episode she had to be committed.</i>
confession	The religious body or Church sharing a confession of faith. <i>Confessions of a driving instructor.</i>
criminal	A person who has committed a crime. <i>A criminal court.</i>
distrust	The feeling that someone or something cannot be relied upon. <i>The public s distrust of politicians.</i>
expiate	Make amends for. <i>Their sins must be expiated by sacrifice.</i>
felony	A crime regarded in the US and many other judicial systems as more serious than a misdemeanour. <i>An accusation of felony.</i>
forgive	Stop blaming or grant forgiveness. <i>He had never found it easy to forgive and forget.</i>
infraction	A violation or infringement of a law or agreement.
inmate	A person confined to an institution such as a prison or hospital. <i>Inmates of the Louisiana State Penitentiary.</i>
malfeasance	Wrongful conduct by a public official.
misbehave	(of a machine) fail to function correctly. <i>Josh misbehaved pushing his food off the table.</i>
misbehavior	Improper or wicked or immoral behavior.
misconduct	A penalty assessed against a player for unsportsmanlike conduct. <i>The committee reprimanded two members who were found to have misconducted themselves.</i>
misdemeanor	A crime less serious than a felony.
penitence	Remorse for your past conduct. <i>A public display of penitence.</i>
penitential	Showing or constituting penance. <i>Penitential tears.</i>

perjury	The offence of wilfully telling an untruth or making a misrepresentation under oath. <i>He claimed two witnesses at his trial had committed perjury.</i>
punish	Impose a penalty on inflict punishment on. <i>I have done wrong and I m being punished for it.</i>
punishment	The infliction or imposition of a penalty as retribution for an offence. <i>She assisted her husband to escape punishment for the crime.</i>
recrimination	Mutual accusations. <i>There was a period of bitter recrimination.</i>
repent	View or think of (an action or omission) with deep regret or remorse. <i>The Padre urged his listeners to repent.</i>
sin	Commit a sin violate a law of God or a moral law. <i>I sinned and brought shame down on us.</i>
transgression	The action of going beyond or overstepping some boundary or limit. <i>I ll be keeping an eye out for further transgressions.</i>
trespass	Commit an offence against (a person or a set of rules). <i>There is no excuse for trespassing on railway property.</i>
violation	The crime of forcing a person to submit to sexual intercourse against his or her will. <i>Flagrant violations of normal democratic procedure.</i>
violator	A person who treats something with irreverence or disrespect. <i>Monica is able to name the violators of her body.</i>
violence	An act of aggression (as one against a person who resists). <i>Screen violence.</i>
