<b>deceit</b>	The act of deceiving. <i>Hypocrisy and <b>deceit</b> were anathema to her.</i>
<b>deception</b>	A thing that deceives. <i>Obtaining property by <b>deception</b>.</i>
<b>falsification</b>	Any evidence that helps to establish the falsity of something. <i>An investigation into fraud and the <b>falsification</b> of records.</i>

## Usage Examples of "Misrepresentation" as a noun

- *A gross misrepresentation of the situation.*
- *She is seeking damages on allegations of misrepresentation.*

## Associations of "Misrepresentation" (30 Words)

<b>adverse</b>	Preventing success or development; harmful; unfavourable. <i><b>Adverse</b> circumstances.</i>
<b>belie</b>	Fail to fulfil or justify (a claim or expectation). <i>His lively alert manner <b>belied</b> his years.</i>
<b>contradict</b>	Be in contradiction with. <i>The existing layout of the city <b>contradicted</b> the logic of the new centre.</i>
<b>damaging</b>	Having a detrimental effect on someone or something. <i>New cars are less <b>damaging</b> to the environment.</i>
<b>default</b>	Declare a party to have defaulted and give judgement against that party. <i>The <b>default</b> is fifty lines.</i>
<b>deny</b>	Deny oneself something restrain especially from indulging in some pleasure. <i>The servants are ordered to <b>deny</b> him.</i>
<b>deprecation</b>	A prayer to avert or remove some evil or disaster. A state of unhappiness and low spirits.
<b>despond</b>	<i>The supporters of the Presidential candidate <b>desponded</b> when they learned the early results of the election.</i>
<b>disavow</b>	Refuse to acknowledge; disclaim knowledge of; responsibility for, or association with. <i>Her husband <b>disavowed</b> her after 30 years of marriage and six children.</i>
<b>displease</b>	Make (someone) feel annoyed or dissatisfied. <i>The tone of the letter <b>displeased</b> him.</i>

<b>disprove</b>	Prove to be false. <i>He has given the Department of Transport two months to <b>disprove</b> the allegation.</i>
<b>dissenter</b>	A member of a non-established Church; a Nonconformist.
<b>error</b>	(computer science) the occurrence of an incorrect result produced by a computer. <i>The decisions of the appeal committee disclosed no <b>error</b> of law.</i>
<b>exaggerate</b>	Represent (something) as being larger, better, or worse than it really is. <i>Claims of turmoil within the firm are greatly <b>exaggerated</b>.</i>
<b>inappropriate</b>	Not suitable for a particular occasion etc. <i>There are penalties for <b>inappropriate</b> behaviour.</i>
<b>misinterpret</b>	Interpret (something or someone) wrongly. <i>Don't <b>misinterpret</b> my comments as criticism.</i>
<b>negate</b>	Make ineffective by counterbalancing the effect of. <i>This action will <b>negate</b> the effect of my efforts.</i>
<b>neutralize</b>	Oppose and mitigate the effects of by contrary actions. <i>120 bombs were <b>neutralized</b>.</i>
<b>no</b>	A radioactive transuranic element synthesized by bombarding curium with carbon ions 7 isotopes are known. <i>He was <b>no</b> heavier than a child.</i>
<b>nullify</b>	Make of no use or value; cancel out. <i>Insulin can block the release of the hormone and thereby <b>nullify</b> the effects of training.</i>
<b>objection</b>	The speech act of objecting. <i>His view is open to <b>objection</b>.</i>
<b>opposed</b>	In conflict with or hostile to. <i>Parties <b>opposed</b> to the ruling party.</i>
<b>peccadillo</b>	A relatively minor fault or sin. <i>The sexual <b>peccadilloes</b> of celebrities aren't necessarily news.</i>
<b>prejudicial</b>	Harmful to someone or something; detrimental. <i>The reporter's coverage resulted in <b>prejudicial</b> publicity for the defendant.</i>
<b>rebuttal</b>	(law) a pleading by the defendant in reply to a plaintiff's surrejoinder.
<b>rescind</b>	Cancel officially. <i>The government eventually <b>rescinded</b> the directive.</i>
<b>skeptic</b>	Someone who habitually doubts accepted beliefs.
<b>undesirable</b>	One whose presence is undesirable. <i><b>Undesirable</b> impurities in steel.</i>
