## Negotiable as an Adjective

### Definitions of "Negotiable" as an adjective

According to the [Oxford Dictionary of English](#), “negotiable” as an adjective can have the following definitions:

- *Able to be negotiated or arranged by compromise.*
- *Open to discussion or modification.*
- *(of a route) able to be traversed; passable.*
- *(of a document) able to be transferred or assigned to the legal ownership of another person.*
- *Legally transferable to the ownership of another.*
- *Capable of being passed or negotiated.*



## Synonyms of "Negotiable" as an adjective (13 Words)

<b>assignable</b>	Legally transferable to another person's possession. <i>Your membership is not <b>assignable</b> to any third party.</i>
<b>conveyable</b>	Legally transferable to the ownership of another.
<b>crossable</b>	(of a river or road) allowing safe, easy, or unobstructed access from one side to the other. <i>In places the usually <b>crossable</b> river had become five feet deep.</i>
<b>flexible</b>	Capable of bending easily without breaking. <i>Slim <b>flexible</b> birches.</i>
<b>navigable</b>	(of a website) easy to move around in. <i>A <b>navigable</b> channel.</i>
<b>open to discussion</b>	Ready or willing to receive favorably.
<b>open to modification</b>	Not having been filled.

<b>passable</b>	Just good enough to be acceptable; satisfactory. <i>The road was <b>passable</b> with care.</i>
<b>subject to discussion</b>	Likely to be affected by something.
<b>transferable</b>	Legally transferable to the ownership of another. <b><i>Transferable</i></b> skills.
<b>transferrable</b>	Capable of being moved or conveyed from one place to another.
<b>traversable</b>	Capable of being traversed.
<b>usable as legal tender</b>	Capable of being put to use.



## Usage Examples of "Negotiable" as an adjective

- *Negotiable certificates of deposit.*
- *Negotiable bonds.*
- *Walkways must be accessible and negotiable for all users.*
- *A negotiable road.*
- *The price was not negotiable.*
- *Negotiable demands.*



## Associations of "Negotiable" (30 Words)

### **alienable**

Able to be transferred to new ownership.

*It was in the interest of the public and the landowners to make land freely **alienable**.*

### **arbitration**

The hearing and determination of a dispute by an impartial referee agreed to by both parties (often used to settle disputes between labor and management).

*Binding **arbitration**.*

### **arbitrator**

An independent person or body officially appointed to settle a dispute.

*The facts of the case are put to an independent **arbitrator**.*

### **argue**

Have an argument about something.

*She was too tired to **argue** the point.*

### **argument**

An independent variable associated with a function or proposition and determining its value For example in the expression  $y = F(x)$  the arguments of the function  $F$  are  $x$  and  $x$  and the value is  $y$ .

*The **argument** over foreign aid goes on and on.*

### **bargain**

Come to terms; arrive at an agreement.

*The table was a real **bargain**.*

<b>bargaining</b>	The negotiation of the terms of a transaction or agreement.
<b>chaffer</b>	Wrangle (over a price, terms of an agreement, etc.) <i>I <b>chattered</b> in the bazaars for objects I wanted.</i>
<b>chat</b>	Songbirds having a chattering call. <i>Online <b>chat</b> has been widely accepted by average internet users.</i>
<b>consult</b>	An act of consulting a professional a consultation. <i>They had to <b>consult</b> before arriving at a decision.</i>
<b>contentiousness</b>	An inclination to be quarrelsome and contentious.
<b>debate</b>	Have an argument about something. <i>Members of the society <b>debated</b> for five nights.</i>
<b>dialogue</b>	Provide a film or play with a dialogue. <i>The book consisted of a series of <b>dialogues</b>.</i>
<b>discourse</b>	An address of a religious nature (usually delivered during a church service). <i>An imagined <b>discourse</b> between two people.</i>
<b>discuss</b>	Speak with others about something talk something over in detail have a discussion. <i>They were <b>discussing</b> where to go for a drink.</i>
<b>disputation</b>	A contentious speech act; a dispute where there is strong disagreement. <i>Scholastic <b>disputations</b>.</i>
<b>finalize</b>	Make final; put the last touches on; put into final form. <i>Efforts intensified to <b>finalize</b> plans for post war reconstruction.</i>
<b>forum</b>	A meeting or medium where ideas and views on a particular issue can be exchanged. <i>We hope these pages act as a <b>forum</b> for debate.</i>
<b>haggle</b>	An instance of intense argument (as in bargaining). <i>Let s not <b>haggle</b> over a few dollars.</i>
<b>inexpensive</b>	Relatively low in price or charging low prices. <i>A simple and <b>inexpensive</b> solution.</i>
<b>interlocutor</b>	A person who takes part in a dialogue or conversation.
<b>interlocutory</b>	(of a decree or judgement) given provisionally during the course of a legal action. <i>An <b>interlocutory</b> injunction.</i>
<b>mediate</b>	Connected indirectly through another person or thing involving an intermediate agency. <i>Structures which <b>mediate</b> gender divisions.</i>

<b>negotiate</b>	Succeed in passing through, around, or over. <i>She cautiously <b>negotiated</b> the hairpin bend.</i>
<b>negotiation</b>	The activity or business of negotiating an agreement; coming to terms. <i>A worldwide ban is currently under <b>negotiation</b>.</i>
<b>parley</b>	Hold a conference with the opposing side to discuss terms. <i>A <b>parley</b> is in progress and the invaders may withdraw.</i>
<b>recitative</b>	A vocal passage of narrative text that a singer delivers with natural rhythms of speech. <i>Singing in <b>recitative</b>.</i>
<b>talk</b>	Exchange thoughts talk with. <i>It was no use <b>talking</b> to Anthony.</i>
<b>transferable</b>	Legally transferable to the ownership of another. <i><b>Transferable</b> skills.</i>
<b>wrangling</b>	Engagement in a long, complicated dispute or argument. <i>Weeks of political <b>wrangling</b>.</i>
