### Definitions of "Plea" as a noun

According to the [Oxford Dictionary of English](#), “plea” as a noun can have the following definitions:

- *A request made in an urgent and emotional manner.*
- *A claim that a circumstance means that one should not be blamed for or should not be forced to do something.*
- *A defendant's answer by a factual matter (as distinguished from a demurrer.*
- *An answer indicating why a suit should be dismissed.*
- *A humble request for help from someone in authority.*
- *(law) a defendant's answer by a factual matter (as distinguished from a demurrer.*
- *A formal statement by or on behalf of a defendant or prisoner, stating guilt or innocence in response to a charge, offering an allegation of fact, or claiming that a point of law should apply.*



## Synonyms of "Plea" as a noun (10 Words)

<b>appeal</b>	A serious, urgent, or heartfelt request. <i>His smile was part of his <b>appeal</b> to her.</i>
<b>claim</b>	A demand especially in the phrase. <i>He staked his <b>claim</b>.</i>
<b>defence</b>	The case presented by or on behalf of the party accused of a crime or being sued in a civil lawsuit. <i>He spoke in <b>defence</b> of a disciplined approach.</i>
<b>entreaty</b>	An earnest or humble request. <i>An <b>entreaty</b> to stop the fighting.</i>
<b>explanation</b>	A statement that makes something comprehensible by describing the relevant structure or operation or circumstances etc. <i>The <b>explanation</b> was very simple.</i>
<b>justification</b>	The act of defending or explaining or making excuses for by reasoning. <i>There is no <b>justification</b> for an increase in charges.</i>
<b>petition</b>	Reverent petition to a deity. <i>A divorce <b>petition</b>.</i>
<b>prayer</b>	The act of communicating with a deity (especially as a petition or in adoration or contrition or thanksgiving). <i>The peace of God is ours through <b>prayer</b>.</i>
<b>supplication</b>	The act of communicating with a deity (especially as a petition or in adoration or contrition or thanksgiving). <i>He fell to his knees in <b>supplication</b>.</i>
<b>vindication</b>	The action of clearing someone of blame or suspicion. <i>Democratic <b>vindications</b> of freedom of choice as a basic principle.</i>



## Usage Examples of "Plea" as a noun

- *He changed his plea to not guilty.*
- *Her plea of a headache was not entirely false.*

<b>desperately</b>	In a way that shows despair. <i>He looked around <b>desperately</b>.</i>
<b>entreat</b>	Ask someone earnestly or anxiously to do something. <i>The King I fear hath ill <b>entreated</b> her.</i>
<b>entreaty</b>	An earnest or humble request. <i>An <b>entreaty</b> to stop the fighting.</i>
<b>exhortation</b>	The act of exhorting; an earnest attempt at persuasion. <i><b>Exhortations</b> to consumers to switch off electrical appliances.</i>
<b>implore</b>	Beg earnestly for. <i>I <b>implore</b> mercy.</i>
<b>invitation</b>	The action of inviting someone to go somewhere or to do something. <i>An <b>invitation</b> to lunch.</i>
<b>invocation</b>	An incantation used to invoke a deity or the supernatural. <i>His <b>invocation</b> of the ancient powers of Callanish.</i>
<b>necessary</b>	The basic requirements of life, such as food and warmth. <i>It s not <b>necessary</b> for you to be here.</i>
<b>perforce</b>	By necessity; by force of circumstance. <i>Amateurs <b>perforce</b> have to settle for less expensive solutions.</i>
<b>petition</b>	Write a petition for something to somebody request formally and in writing. <i>A steady stream of <b>petitions</b> to Allah were audible.</i>
<b>plead</b>	Make an allegation in an action or other legal proceeding especially answer the previous pleading of the other party by denying facts therein stated or by alleging new facts. <i>The youth <b>pleaded</b> guilty to murdering the girl.</i>
<b>please</b>	Cause to feel happy and satisfied. <i>She was quiet and eager to <b>please</b>.</i>
<b>pray</b>	Address a deity a prophet a saint or an object of worship say a prayer. <i>After several days of rain we were <b>praying</b> for sun.</i>

<b>prayer</b>	Reverent petition to a deity. <i>500 people were detained as they attended Friday <b>prayers</b>.</i>
<b>request</b>	The verbal act of requesting. <i>A <b>request</b> for information.</i>
<b>solicit</b>	Make a solicitation or entreaty for something request urgently or persistently. <i>The young man was caught <b>soliciting</b> in the park.</i>
<b>solicitation</b>	Request for a sum of money. <i>A <b>solicitation</b> to the king for relief.</i>
<b>suppliant</b>	Making or expressing a plea, especially to someone in power or authority. <i>Their faces were wary and <b>suppliant</b>.</i>
<b>suppliant</b>	Humbly entreating. <i>A <b>suppliant</b> serf before an ill tempered monarch.</i>
<b>supplicate</b>	Make a humble, earnest petition. <i><b>Supplicate</b> for permission.</i>
<b>supplication</b>	The act of communicating with a deity (especially as a petition or in adoration or contrition or thanksgiving). <i>He fell to his knees in <b>supplication</b>.</i>
<b>woo</b>	Seek the favour, support, or custom of. <i>He <b>wooed</b> her with quotes from Shakespeare.</i>
