




### Usage Examples of "Prayers" as a noun

# Associations of "Prayers" (30 Words)

| appeal          | Attractiveness that interests or pleases or stimulates.<br>They have 48 hours to <b>appeal</b> the decision.   |
|-----------------|--|
| <u>beg</u>      | Acquire food or money from someone by begging.<br>A young woman was <b>beg</b> ging in the street.   |
| <u>beseech</u>  | Ask (someone) urgently and fervently to do something; implore; entreat.<br>They earnestly <b>beseech</b> ed his forgiveness.   |
| buddhism        | The teaching of Buddha that life is permeated with suffering caused by desire, that suffering ceases when desire ceases, and that enlightenment obtained through right conduct and wisdom and meditation releases one from desire and suffering and rebirth. |
| calvary         | Any experience that causes intense suffering.  |
| <u>church</u>   | The body of people who attend or belong to a particular local church.<br>Some people go to <b>church</b> every Sunday.   |
| <u>conjure</u>  | Summon into action or bring into existence, often as if by magic.<br>She had forgotten how to <b>conjure</b> up the image of her mother s face.  |
| <u>entreat</u>  | Treat (someone) in a specified manner.<br><i>The King I fear hath ill <b>entreat</b>ed her.</i>  |
| entreaty        | An earnest or humble request.<br>An <b>entreaty</b> to stop the fighting.  |
| implore         | Call upon in supplication; entreat.<br><i>He <b>implore</b>d her to change her mind</i> .  |
| invocation      | A prayer asking God's help as part of a religious service.<br><i>His <b>invocation</b> of the ancient powers of Callanish.</i>   |
| litany          | A litany contained in the Book of Common Prayer.<br>A <b>litany</b> of failures.   |
| majestically    | With impressive beauty or scale.<br>The steep slopes of the valley floor rise <b>majestically</b> skywards.  |
| monk            | United States jazz pianist who was one of the founders of the bebop style (1917-1982.  |
| mosque          | A Muslim place of worship that usually has a minaret.  |
| offertory       | An anthem accompanying the offertory.<br>They donated the money to a collection which was brought up at the<br>offertory.  |
| <u>petition</u> | Reverent petition to a deity.<br>The Act allowed couples to <b>petition</b> for divorce after one year of marriage.  |



| <u>plea</u>         | A defendant's answer by a factual matter (as distinguished from a demurrer.<br><i>He made a dramatic <b>plea</b> for disarmament.</i>   |
|---------------------|---|
| <u>plead</u>        | Make an allegation in an action or other legal proceeding especially answer<br>the previous pleading of the other party by denying facts therein stated or by<br>alleging new facts.<br>I <b>plead</b> ed with him to stop. |
| <u>please</u>       | Used to ask someone to stop doing something of which the speaker disapproves.<br><i>He arranged a fishing trip to <b>please</b> his son.</i>  |
| <u>pray</u>         | Address a prayer to God or another deity.<br><b>Pray</b> to the Lord.   |
| priestess           | A female priest of a non-Christian religion.  |
| <u>solicitation</u> | The act of asking for or trying to obtain something from someone.<br>People objected to receiving telephone <b>solicitation</b> s.  |
| suppliant           | One praying humbly for something.<br>A <b>suppliant</b> sinner seeking forgiveness.   |
| supplicant          | One praying humbly for something.<br>We are equals and not <b>supplicant</b> s begging for work.  |
| supplicate          | Make a humble, earnest petition.<br><i>Supplicate</i> for permission.   |
| supplication        | A humble request for help from someone in authority.<br><i>He fell to his knees in <b>supplication</b>.</i>   |
| <u>synagogue</u>    | (Judaism) the place of worship for a Jewish congregation.   |
| temple              | A thing regarded as holy or likened to a temple especially a person s body.<br>A <b>temple</b> of science.  |
| <u>temporal</u>     | Characteristic of or devoted to the temporal world as opposed to the spiritual world.   |
|                     | <b>Temporal</b> matters of but fleeting moment.   |
