attestation	A declaration that something exists or is the case. <i>Their vocabulary is no attestation to your value as a parent.</i>
authentication	The process or action of verifying the identity of a user or process. <i>User authentication for each device ensures that the individual using the device is recognized by the company.</i>
barometer	An instrument that measures atmospheric pressure. <i>Furniture is a barometer of changing tastes.</i>
certification	A document attesting to the truth of certain stated facts. <i>The certification of teachers.</i>
confirmation	A ceremony held in the synagogue (usually at Pentecost) to admit as adult members of the Jewish community young men and women who have successfully completed a course of study in Judaism. <i>Confirmation of the appointment.</i>
corroboration	Evidence which confirms or supports a statement, theory, or finding; confirmation. <i>There is no independent corroboration for this.</i>
criterion	The ideal in terms of which something can be judged. <i>They award a green label to products that meet certain environmental criteria.</i>
demonstration	A visual presentation showing how something works. <i>Demonstrations against the poll tax.</i>
evidence	The available body of facts or information indicating whether a belief or proposition is true or valid. <i>His trembling was evidence of his fear.</i>
galley	A crescent-shaped seagoing vessel propelled by oars.
galley proof	A large medieval vessel with a single deck propelled by sails and oars with guns at stern and prow; a complement of 1,000 men; used mainly in the Mediterranean for war and trading.
indication	(medicine) a reason to prescribe a drug or perform a procedure. <i>The presence of bacterial infection was an indication for the use of antibiotics.</i>
litmus test	The act of testing something.
measure	Measuring instrument having a sequence of marks at regular intervals used as a reference in making measurements. <i>Cost cutting measures.</i>

page proof	In medieval times a youth acting as a knight's attendant as the first stage in training for knighthood.
photo	A photo finish.
photograph	A representation of a person or scene in the form of a print or transparent slide; recorded by a camera on light-sensitive material. <i>A photograph of her father.</i>
picture	A graphic or vivid verbal description. <i>I m going to the pictures with my mates.</i>
pull	The force used in pulling. <i>The pull of the moon.</i>
shot	A ball of stone or metal used as a missile shot from a large gun or cannon. <i>Steamed milk with a shot of espresso.</i>
slip	A reduction in the movement of a pulley or other mechanism due to slipping of the belt rope etc. <i>A slip plane.</i>
snap	A card game in which cards from two piles are turned over simultaneously and players call snap as quickly as possible when two similar cards are exposed. <i>Servants appeared at the snap of his fingers.</i>
snapshot	A record of the contents of a storage location or data file at a given time. <i>My snapshots haven t been developed yet.</i>
standard	Something used as a measure, norm, or model in comparative evaluations. <i>A decline in moral standards.</i>
substantiation	The act of validating; finding or testing the truth of something.
test copy	A hard outer covering as of some amoebas and sea urchins.
testament	Something that serves as a sign or evidence of a specified fact, event, or quality. <i>Growing attendance figures are a testament to the event s popularity.</i>
touchstone	A piece of fine-grained dark schist or jasper formerly used for testing alloys of gold by observing the colour of the mark which they made on it. <i>They tend to regard grammar as the touchstone of all language performance.</i>
trial impression	A preliminary competition to determine qualifications.
trial print	The determination of a person's innocence or guilt by due process of law.

validation	The act of validating; finding or testing the truth of something. <i>The technique requires validation in controlled trials.</i>
verification	The process of establishing the truth, accuracy, or validity of something. <i>The verification of official documents.</i>
witness	(law) a person who testifies under oath in a court of law. <i>They will be able to give witness of their faith and confidence in God.</i>
yardstick	A standard used for comparison. <i>League tables are not the only yardstick of schools performance.</i>

evidence	Give evidence. <i>The quality of the bracelet as evidenced by the workmanship is exceptional.</i>

<u>excuse</u>	Defend explain clear away or make excuses for by reasoning. <i>It will not be possible to excuse you from attendance.</i>

<u>substantiate</u>	Establish or strengthen as with new evidence or facts. <i>They had found nothing to substantiate the allegations.</i>
substantiation	The act of validating; finding or testing the truth of something.

testament	Something that serves as a sign or evidence of a specified fact, event, or quality. <i>He stated his political testament.</i>
testify	Give testimony in a court of law. <i>The bleak lines testify to inner torment.</i>
testimony	A public recounting of a religious conversion or experience. <i>His blackened finger was testimony to the fact that he had played in pain.</i>
validate	Demonstrate or support the truth or value of. <i>Without Patti to validate my feelings they seemed not to exist.</i>
validation	The cognitive process of establishing a valid proof. <i>The technique requires validation in controlled trials.</i>
verification	An affidavit attached to a statement confirming the truth of that statement. <i>The verification principle.</i>
vindicate	Show or prove to be right, reasonable, or justified. <i>Hospital staff were vindicated by the inquest verdict.</i>
witness	Be a witness to. <i>One of the purposes of his coming was to nerve the disciples to witness to Jesus.</i>
