Definitions of "Proprietor" as a noun

According to the [Oxford Dictionary of English](#), “proprietor” as a noun can have the following definitions:

- *(law) someone who owns (is legal possessor of) a business.*
- *The owner of a business, or a holder of property.*
- *Someone who owns (is legal possessor of) a business.*

Synonyms of "Proprietor" as a noun (12 Words)

freeholder	A person who owns the freehold to a piece of land or property. <i>Freeholders are usually responsible for the repair and maintenance of the exterior of the building.</i>
holder	A smallholder. <i>I replaced the phone in its holder.</i>
keeper	An animal attendant employed in a zoo. <i>These lakes consistently give up healthy pound size keepers.</i>
landlady	A landlord who is a woman.
landlord	A landowner who leases to others.
landowner	A holder or proprietor of land.

master	Someone who holds a master s degree from academic institution. <i>He was master of the situation.</i>
mistress	A female head of a household. <i>He asked for the mistress of the house.</i>
owner	(law) someone who owns (is legal possessor of) a business. <i>Who is the owner of that friendly smile.</i>
possessor	A person who owns something or has a particular quality. <i>His father was the possessor of a considerable fortune.</i>
proprietress	A female proprietor.
squire	Young nobleman attendant on a knight. <i>The squire of Radbourne Hall.</i>

Usage Examples of "Proprietor" as a noun

- *Chinese restaurant proprietors.*
- *By 1640 he was himself the proprietor of a three-hundred-acre tract.*

Associations of "Proprietor" (30 Words)

aristocrat	A member of the aristocracy. <i>An aristocrat by birth.</i>
chancellor	The British cabinet minister responsible for finance. <i>The Lord chancellor and the judges will consider the application.</i>
chattel	An item of property other than freehold land including tangible goods chattels personal and leasehold interests chattels real.
duke	A nobleman (in various countries) of high rank.
estate	A class or order regarded as forming part of the body politic in particular in Britain one of the three groups constituting Parliament now the Lords spiritual the heads of the Church the Lords temporal the peerage and the Commons They are also known as the three estates. <i>An industrial estate.</i>
fief	A piece of land held under the feudal system.
founder	Break down, literally or metaphorically. <i>The horses foundered.</i>
holder	A smallholder. <i>A British passport holder.</i>

holding	Books, periodicals, magazines, and other material in a library. <i>Commercial property holdings.</i>
host	A person who acts as host at formal occasions makes an introductory speech and introduces other speakers. <i>Atlanta was chosen to be host for the Olympic Games.</i>
hostess	A woman who presents a television or radio programme. <i>The perfect dinner party hostess.</i>
landed	Consisting of or relating to land owned through inheritance. <i>The decline of landed estates.</i>
landholder	A holder or proprietor of land.
landlady	A woman who keeps lodgings, a boarding house, or a pub.
landlord	A man who keeps lodgings, a boarding house, or a pub.
liege	A feudal lord entitled to allegiance and service. <i>One s liege lord.</i>
lord	Make a lord of someone. <i>Our lord the king.</i>
master	Someone who holds a master s degree from academic institution. <i>I m a master of disguise.</i>
nobleman	A man who belongs by rank, title, or birth to the aristocracy; a peer.
overlord	A ruler, especially a feudal lord. <i>The Jews rebelled against their Roman overlords.</i>
own	Have something as one s own possess. <i>Do your own thing.</i>
owner	(law) someone who owns (is legal possessor of) a business. <i>He is the owner of a chain of restaurants.</i>
possessor	A person who owns something. <i>His father was the possessor of a considerable fortune.</i>
property	Shares or investments in property. <i>She wanted Oliver and his property out of her flat.</i>
proprietorship	A business or property, etc., owned by a proprietor. <i>Plenty of new firms especially sole proprietorships don t make money in their first few years of operation.</i>
rancher	A ranch house.
rent	Hold under a lease or rental agreement of goods and services. <i>Let s rent a car.</i>
tenant	Occupy property as a tenant. <i>The landlord can evict a tenant who doesn t pay the rent.</i>

vassal A person or country in a subordinate position to another.
*A **vassal** state of the Ottoman Empire.*

wealthy Having an abundant supply of money or possessions of value.
*The burden of taxation on the **wealthy**.*
