Associations of "Referred" (30 Words)

advert	An advertisement.
aforementioned	Being the one previously mentioned or spoken of. <i>Works of all the aforementioned authors.</i>
aforesaid	Being the one previously mentioned or spoken of.
<u>allude</u>	Mention without discussing at length. <i>We will allude briefly to the main points.</i>
<u>allusion</u>	The practice of making allusions. <i>An allusion to Shakespeare.</i>
<u>annotate</u>	Add explanatory notes to or supply with critical comments. <i>He annotated on what his teacher had written.</i>
annotation	A note by way of explanation or comment added to a text or diagram. <i>Annotation of prescribed texts.</i>
ascribe	Regard something as being due to (a cause). <i>He ascribed Jane's short temper to her upset stomach.</i>
citation	A mention of a praiseworthy act in an official report, especially that of a member of the armed forces in wartime. <i>The citation described him as an officer of extreme gallantry.</i>
<u>cite</u>	Mention as an example. <i>The writ cited only four of the signatories of the petition.</i>
consultation	The act of referring or consulting. <i>They improved standards in consultation with consumer representatives.</i>
declaim	Speak against in an impassioned manner. <i>He declaimed against the wasteful ways of modern society.</i>
<u>denote</u>	Be a sign or indication of. <i>Her smile denoted that she agreed.</i>

<u>descriptive</u>	Describing or classifying in an objective and non-judgemental way. <i>The text contains some good descriptive passages.</i>
enunciation	The articulation of speech regarded from the point of view of its intelligibility to the audience.
fact	A piece of information about circumstances that exist or events that have occurred. <i>There was a question of fact as to whether they had received the letter.</i>
<u>foregoing</u>	Just mentioned or stated; preceding. <i>The foregoing analysis of the economic class structure.</i>
<u>imply</u>	Suggest that someone is guilty. <i>Salesmen who use jargon to imply superior knowledge.</i>
impute	Ascribe (righteousness, guilt, etc.) to someone by virtue of a similar quality in another. <i>The teacher imputed the student s failure to his nervousness.</i>
<u>maxim</u>	A short, pithy statement expressing a general truth or rule of conduct. <i>The maxim that actions speak louder than words.</i>
mention	An instance of being mentioned in dispatches. <i>There was no mention of it.</i>
notation	A note or annotation. <i>Algebraic notation.</i>
note	Make a written note of. <i>She noted that someone was following her.</i>
<u>observe</u>	Observe with care or pay close attention to. <i>A tribunal must observe the principles of natural justice.</i>
ostensive	Denoting a way of defining by direct demonstration, e.g. pointing.
quotation	A formal statement setting out the estimated cost for a particular job or service. <i>Since he lacks originality he must rely on quotation.</i>
<u>quote</u>	Put quote marks around. <i>A quote from Wordsworth.</i>
reference	The relation between a word or phrase and the object or idea it refers to. <i>Popular works of reference.</i>
remark	Notice or comment. <i>He remarked the man s inflamed eyelids.</i>
<u>specify</u>	Specify as a condition or requirement in a contract or agreement make an express demand or provision in an agreement. <i>The agency failed to specify that the workers were not their employees.</i>
