Associations of "Referring" (30 Words)

advert	An advertisement.
aforementioned	Being the one previously mentioned or spoken of. <i>Works of all the aforementioned authors.</i>
aforesaid	Being the one previously mentioned or spoken of.
<u>allude</u>	Mention without discussing at length. <i>He alluded to the problem but did not mention it.</i>
<u>allusion</u>	The practice of making allusions. <i>The use of allusion.</i>
<u>annotate</u>	Add notes to (a text or diagram) giving explanation or comment. <i>He annotated on what his teacher had written.</i>
annotation	The action of annotating a text or diagram. <i>Annotation of prescribed texts.</i>
ascribe	Regard a quality as belonging to. <i>He ascribed Jane's short temper to her upset stomach.</i>
citation	A mention of a praiseworthy act in an official report, especially that of a member of the armed forces in wartime. <i>A Nobel citation.</i>
<u>cite</u>	A short note recognizing a source of information or of a quoted passage. <i>Authors who are highly regarded by their peers tend to be cited.</i>
consultation	A meeting with an expert, such as a medical doctor, in order to seek advice. <i>A consultation of several medical specialists.</i>
declaim	Speak against in an impassioned manner. <i>An opportunity to declaim against the evils of society.</i>
<u>denote</u>	Be a sign of; indicate. <i>Her smile denoted that she agreed.</i>

<u>descriptive</u>	Of or relating to an approach to linguistic analysis that aims at the description of a language's forms, structures and usage. Descriptive grammar.
enunciation	The articulation of speech regarded from the point of view of its intelligibility to the audience.
fact	A piece of information about circumstances that exist or events that have occurred. <i>First you must collect all the facts of the case.</i>
<u>foregoing</u>	The things just mentioned or stated. <i>The foregoing analysis of the economic class structure.</i>
<u>imply</u>	Express or state indirectly. <i>Salesmen who use jargon to imply superior knowledge.</i>
impute	Attribute or credit to. <i>The crimes imputed to Richard.</i>
<u>maxim</u>	A saying that is widely accepted on its own merits. <i>The maxim that actions speak louder than words.</i>
mention	Make mention of. <i>The unit was awarded fifteen mentions.</i>
notation	A note or annotation. <i>New terminologies and notations.</i>
note	A written sign representing the pitch and duration of a musical note. <i>She noted everything the teacher said that morning.</i>
<u>observe</u>	Observe with care or pay close attention to. <i>She observed that all the chairs were already occupied.</i>
ostensive	Denoting a way of defining by direct demonstration, e.g. pointing.
quotation	A statement of the current market price of a security or commodity. <i>The company is being refused a quotation on the New York Stock Exchange.</i>
<u>quote</u>	A passage or expression that is quoted or cited. <i>He quoted the Bible to her.</i>
reference	A publication (or a passage from a publication) that is referred to. Reference to an encyclopedia produced the answer.
remark	Regard with attention; notice. <i>The landscape familiar since childhood was not worthy of remark.</i>
<u>specify</u>	Specify as a condition or requirement in a contract or agreement make an express demand or provision in an agreement. Specify the parameters.
