## Revenue as a Noun

### Definitions of "Revenue" as a noun

According to the [Oxford Dictionary of English](#), “revenue” as a noun can have the following definitions:

- *Government income due to taxation.*
- *A state's annual income from which public expenses are met.*
- *Income, especially when of an organization and of a substantial nature.*
- *The department of the civil service collecting state revenue.*
- *The entire amount of income before any deductions are made.*



## Synonyms of "Revenue" as a noun (9 Words)

<b>earnings</b>	The excess of revenues over outlays in a given period of time (including depreciation and other non-cash expenses). <i>He claimed damages for loss of <b>earnings</b>.</i>
<b>gross</b>	A gross profit or income. <i>The box office <b>grosses</b> mounted.</i>
<a href="#"><u>income</u></a>	Money received, especially on a regular basis, for work or through investments. <i>He has a nice home and an adequate <b>income</b>.</i>
<b>proceeds</b>	Money obtained from an event or activity. <i><b>Proceeds</b> from the event will go to aid the work of the charity.</i>
<b>receipts</b>	The act of receiving.
<b>takings</b>	The act of someone who picks up or takes something.
<b>tax income</b>	Charge against a citizen's person or property or activity for the support of government.
<b>tax revenue</b>	Charge against a citizen's person or property or activity for the support of government.
<b>taxation</b>	Government income due to taxation. <i>Direct <b>taxation</b> was low.</i>



## Usage Examples of "Revenue" as a noun

- *The government's tax revenues.*
- *His priority was to raise government revenue and to lower expenditure.*
- *Traders have lost £10,000 in revenue since the traffic scheme was implemented.*
- *When the revenue makes a demand for tax, that demand is implicitly backed by the powers of the state.*



## Associations of "Revenue" (30 Words)

<b>acquire</b>	Come to have or undergo a change of (physical features and attributes). <i>I've <b>acquired</b> a taste for whisky.</i>
<b>bonus</b>	An extra dividend or issue paid to the shareholders of a company. <i>Good weather is an added <b>bonus</b> but the real appeal is the landscape.</i>
<b>boom</b>	Hit hard. <i>Thunder <b>boomed</b> in the sky.</i>
<b>buyer</b>	A person who buys.
<b>cash</b>	Exchange for cash. <i>The bank <b>cash</b>ed her cheque.</i>
<b>customs</b>	Money collected under a tariff. <i>From 1374 Chaucer worked as controller of <b>customs</b> on wool in the port of London.</i>
<b>dividend</b>	An individual's share of a dividend. <i>Buying a rail pass may still pay <b>dividends</b>.</i>

<b>duty</b>	The measure of an engine's effectiveness in units of work done per unit of fuel. <i>A 6 per cent <b>duty</b> on imports.</i>
<b>earn</b>	Earn on some commercial or business transaction earn as salary or wages. <i>The dollars can be placed on deposit and <b>earn</b> interest.</i>
<b>earnings</b>	Money obtained in return for labour or services. <i>Export <b>earnings</b>.</i>
<b>gain</b>	The advantageous quality of being beneficial. <i>The pursuit of personal <b>gain</b>.</i>
<b>gross</b>	A gross profit or income. <i>The <b>gross</b> details of the structure appear reasonable.</i>
<b>income</b>	Money received, especially on a regular basis, for work or through investments. <i>Figures showed an overall increase in <b>income</b> this year.</i>
<b>overpayment</b>	The act of paying too much. <i>He received 20 000 in benefit <b>overpayments</b>.</i>
<b>paycheck</b>	A check issued in payment of wages or salary.
<b>payroll</b>	The total amount of wages paid by a company. <i>The company had a large <b>payroll</b>.</i>
<b>procure</b>	Arrange for sexual partners for others. <i>He persuaded a friend to <b>procure</b> him a ticket.</i>
<b>profitability</b>	The degree to which a business or activity yields profit or financial gain. <i><b>Profitability</b> may not improve until well into next year.</i>
<b>purchaser</b>	A person who buys something; a buyer. <i>One of the club s prospective <b>purchasers</b>.</i>
<b>rates</b>	A local tax on property (usually used in the plural).
<b>redistribute</b>	Distribute anew. <i>Their primary concern was to <b>redistribute</b> income from rich to poor.</i>
<b>redistribution</b>	Distributing again. <i>The revolution resulted in a <b>redistribution</b> of wealth.</i>
<b>sales</b>	Income (at invoice values) received for goods and services over some given period of time.
<b>spending</b>	The act of spending or disbursing money.
<b>tariff</b>	A list of import or export tariffs. <i>The reduction of trade barriers and import <b>tariffs</b>.</i>
<b>tax</b>	Pay tax on something especially a vehicle. <i>Why are you <b>taxing</b> me with these preposterous allegations.</i>

- taxation** Government income due to taxation.  
*It should be financed out of **taxation**.*
- turnover** The act of upsetting something.  
*The team were sitting on their lead and taking care to avoid **turnovers**.*
- vat** Place or treat in a vat.  
*A **vat** of hot tar.*
- wage** Carry on (a war or campaign).  
*Napoleon and Hitler **waged** war against all of Europe.*
