### Definitions of "Revoke" as a verb

definitions:

- (in bridge, whist, and other card games) fail to follow suit despite being able to do so.
- Fail to follow suit when able and required to do so.
- Cancel officially.
- Officially cancel (a decree, decision, or promise).

<b>abolish</b>	Formally put an end to (a system, practice, or institution). <i>Slavery was <b>abolished</b> in the mid 19th century in America and in Russia.</i>
<b>abrogate</b>	Revoke formally. <i>A proposal to <b>abrogate</b> temporarily the right to strike.</i>
<b>annul</b>	Cancel officially. <i>The contract was <b>annulled</b>.</i>
<b><u>cancel</u></b>	Delete (an equal factor) from both sides of an equation or from the numerator and denominator of a fraction. <i><b>Cancel</b> cheques or tickets.</i>
<b>countermand</b>	Cancel officially. <i>He was already <b>countermanding</b> her.</i>
<b>declare null and void</b>	Declare to be.
<b><u>invalidate</u></b>	Declare invalid. <i><b>Invalidate</b> a contract.</i>
<b>lift</b>	Fly people or goods to or from places not accessible by other means. <i>A helicopter <b>lifted</b> 11 crew to safety from the ship.</i>
<b>make void</b>	Give certain properties to something.
<b><u>nullify</u></b>	Make legally null and void; invalidate. <i>Insulin can block the release of the hormone and thereby <b>nullify</b> the effects of training.</i>
<b><u>override</u></b>	Rule against. <i>The external rendering should not <b>override</b> the damp proof membrane.</i>
<b>overrule</b>	Reject or disallow by exercising one's superior authority. <i>Welfare staff <b>overruled</b> an experienced detective.</i>
<b><u>overturn</u></b>	Cause to overturn from an upright or normal position. <i>The big vase <b>overturned</b>.</i>

<b>quash</b>	Reject as invalid, especially by legal procedure. <i>His conviction was <b>quashed</b> on appeal.</i>
<b>render invalid</b>	Restate (words) from one language into another language.
<b>repeal</b>	Cancel officially. <i>The legislation was <b>repealed</b> five months later.</i>
<b>rescind</b>	Cancel officially. <i>The government eventually <b>rescinded</b> the directive.</i>
<b>retract</b>	Pull inward or towards a center. <i>The cat <b>retracted</b> his claws.</i>
<b>reverse</b>	Reverse the position order relation or condition of. <i>The court <b>reversed</b> his conviction.</i>
<b>set aside</b>	Become gelatinous.
<b>vacate</b>	Give up (a position or employment). <i>She <b>vacated</b> the position when she got pregnant.</i>
<b>void</b>	Declare invalid. <i>The chemist <b>voided</b> the glass bottle.</i>
<b>withdraw</b>	Withdraw from active participation. <i>Patients were <b>withdrawn</b> from therapy when they had been depression free for a month.</i>

<b>counterbalance</b>	A factor having the opposite effect to that of another and so preventing it from exercising a disproportionate influence. <i>The extra cost of mail order may be <b>counterbalanced</b> by its convenience.</i>
<b>countermand</b>	Revoke or cancel (an order). <i>He was already <b>countermanding</b> her.</i>
<b>delete</b>	A command or key on a computer which erases text. <i>Please <b>delete</b> my name from your list.</i>
<b>empty</b>	Make void or empty of contents. <i><b>Empty</b> bellied children.</i>
<b>exterminate</b>	Kill (a pest). <i>Hitler wanted to <b>exterminate</b> the Jews Gypsies Communists and homosexuals of Europe.</i>
<b>invalidate</b>	Make invalid for use. <i><b>Invalidate</b> a contract.</i>
<b>negate</b>	Deny the truth of. <i>This action will <b>negate</b> the effect of my efforts.</i>
<b>neutralize</b>	Make incapable of military action. <i>Her optimism <b>neutralizes</b> his gloom.</i>
<b>null</b>	Combine a signal with another in order to create a null cancel out. <i><b>Null</b> and void.</i>
<b>nullify</b>	Make ineffective by counterbalancing the effect of. <i>Judges were unwilling to <b>nullify</b> government decisions.</i>
<b>override</b>	A device for suspending an automatic function on a machine. <i>This commitment should <b>override</b> all other considerations.</i>
<b>reject</b>	The person or thing that is rejected or set aside as inferior in quality. <i>His body could begin to <b>reject</b> the implanted heart.</i>
<b>remove</b>	Remove from a position or an office. <i>The death of her mother <b>removed</b> the last obstacle to their marriage.</i>
<b>repeal</b>	The action of revoking or annulling a law or act of parliament. <i>The House voted in favour of <b>repeal</b>.</i>
<b>repel</b>	Be repellent to cause aversion in. <i>The alleged right of lien led by the bankrupt s solicitor was <b>repelled</b>.</i>
<b>repudiation</b>	Rejecting or disowning or disclaiming as invalid. <i>The <b>repudiation</b> of the debt by the city.</i>

<b>rescind</b>	Cancel officially. <i>The government eventually <b>rescinded</b> the directive.</i>
<b>rescission</b>	The act of rescinding; the cancellation of a contract and the return of the parties to the positions they would have had if the contract had not been made. <i>The plaintiff agreed to the <b>rescission</b> of the agreement.</i>
<b>reversible</b>	(of a reaction) occurring together with its converse, and so yielding an equilibrium mixture of reactants and products. <i>The entropy change is zero only in the limiting case of a <b>reversible</b> process.</i>
<b>revocable</b>	Capable of being revoked or cancelled. <i>A <b>revocable</b> order.</i>
<b>revocation</b>	The state of being cancelled or annulled. <i>The <b>revocation</b> of a law.</i>
<b>terminate</b>	Terminate the employment of discharge from an office or position. <i>Adamson s putting pressure on me to <b>terminate</b> you.</i>
<u><a href="#">vacate</a></u>	Give up (a position or employment). <i>She <b>vacated</b> the position when she got pregnant.</i>
<u><a href="#">veto</a></u>	A rejection by right of veto. <i>Mother <b>vetoed</b> the trip to the chocolate store.</i>
