<b>earnings</b>	Money obtained in return for labour or services. <i>Export <b>earnings</b>.</i>
<b>emolument</b>	Compensation received by virtue of holding an office or having employment (usually in the form of wages or fees). <i>A clause in the U S constitution prevents sitting legislators from receiving <b>emoluments</b> from their own votes.</i>

<b>fee</b>	An interest in land capable of being inherited. <i>They were faced with legal <b>fees</b> of 3000.</i>
<b>fees</b>	A fixed charge for a privilege or for professional services.
<b>gross pay</b>	Twelve dozen.

<b>hire</b>	A newly hired employee. <i>The new <b>hires</b> need special training.</i>
<b>honorarium</b>	A payment given for professional services that are rendered nominally without charge.
<b>pay</b>	Something that remunerates. <i>He wasted his <b>pay</b> on drink.</i>
<b>payment</b>	The act of paying money. <i>A suit with a velvet collar that I got as <b>payment</b> for being in the show.</i>
<b>remuneration</b>	Something that remunerates. <i>Adequate <b>remuneration</b> for his work.</i>
<u><b>stipend</b></u>	A sum of money allotted on a regular basis; usually for some specific purpose.
<b>wage</b>	The part of total production that is the return to labour as earned income as distinct from the remuneration received by capital as unearned income. <i>An income of less than half the average <b>wage</b>.</i>
<u><b>wages</b></u>	A recompense for worthy acts or retribution for wrongdoing. <i>The <b>wages</b> of sin is death.</i>



## Usage Examples of "Salary" as a noun

- *He received a salary of £24,000.*
- *A 15 per cent salary increase.*





## Associations of "Salary" (30 Words)

<b>annuitant</b>	A person who receives an annuity.
<b>bonus</b>	Anything that tends to arouse. <i>Good weather is an added <b>bonus</b> but the real appeal is the landscape.</i>
<b>cash</b>	Exchange for cash. <i>The staff were paid in <b>cash</b>.</i>
<b>compensate</b>	Make payment to compensate. <i>He will be richly <b>compensated</b> for his efforts.</i>
<b>compensation</b>	The action or process of awarding compensation. <i>A <b>compensation</b> claim.</i>

<b>cost</b>	Require to lose, suffer, or sacrifice. <i>The government succeeded in diverting resources away from consumption at considerable <b>cost</b> to its political popularity.</i>
<b><u>deposit</u></b>	The natural process of laying down a deposit of something. <i>Cash funds which are an alternative to bank or building society <b>deposits</b>.</i>
<b>earnings</b>	The excess of revenues over outlays in a given period of time (including depreciation and other non-cash expenses). <i>They saved a quarter of all their <b>earnings</b>.</i>
<b>emolument</b>	A salary, fee, or profit from employment or office. <i>The directors <b>emoluments</b>.</i>
<b>incentive</b>	An additional payment (or other remuneration) to employees as a means of increasing output. <i>Give farmers an <b>incentive</b> to improve their land.</i>
<b><u>income</u></b>	The financial gain (earned or unearned) accruing over a given period of time. <i>Figures showed an overall increase in <b>income</b> this year.</i>
<b>increment</b>	A regular increase in salary on an incremental scale. <i>All sizes from 4 30 mm in 1 mm <b>increments</b>.</i>
<b>need</b>	A fitting reward. <i>He must extract from her some <b>need</b> of approbation.</i>
<b>pay</b>	Make a compensation for. <i>It was his way of <b>paying</b> out Maguire for giving him the push.</i>
<b>payment</b>	Something given as a reward or in recompense for something done. <i>A compensation <b>payment</b> of 2500.</i>
<b>recompense</b>	Compensation or reward given for loss or harm suffered or effort made. <i>Substantial damages were paid in <b>recompense</b>.</i>
<b>refund</b>	Pay back (money), typically to a customer who is not satisfied with goods or services bought. <i>I ll <b>refund</b> you for the apples and any other damage.</i>
<b>reimburse</b>	Reimburse or compensate someone as for a loss. <i>Your expenses will be <b>reimbursed</b>.</i>
<b>reimbursement</b>	A sum paid to cover money that has been spent or lost. <i>He received <b>reimbursement</b> for his travel expenses.</i>
<b>remunerate</b>	Make payment to; compensate. <i>My efforts were not <b>remunerated</b>.</i>
<b>remuneration</b>	Something that remunerates. <i>Adequate <b>remuneration</b> for his work.</i>

<u>reparation</u>	The act of putting something in working order again. <i>Germany was unable to pay the <b>reparations</b> demanded after World War I.</i>
<u>restitution</u>	The resumption of an object's original shape or position through elastic recoil. <i><b>Restitution</b> of the damaged mucosa.</i>
reward	Strengthen and support with rewards. <i>Reaping the <b>rewards</b> of generosity.</i>
<u>subsidy</u>	A sum of money granted to support an undertaking held to be in the public interest. <i>She was anxious about her Arts Council <b>subsidy</b>.</i>
tariff	Charge a tariff. <i>The reduction of trade barriers and import <b>tariffs</b>.</i>
taxable	(of goods or funds) subject to taxation. <i><b>Taxable</b> income.</i>
taxation	Government income due to taxation. <i>A <b>taxation</b> system.</i>
unremunerative	Not yielding profit or recompense. <i>An <b>unremunerative</b> occupation.</i>
wage	Something that remunerates. <i>Disasters are the <b>wages</b> of sin.</i>
