- *Accept or yield to a superior force or to the authority or will of another person.*
- *(especially in judicial contexts) suggest; argue.*

- *Yield to the control of another.*
- *Yield to another's wish or opinion.*
- *Put before.*
- *Consent to undergo a certain treatment.*
- *Agree to refer a matter to a third party for decision or adjudication.*
- *Make an application as for a job or funding.*
- *Accept or undergo, often unwillingly.*
- *Refer to another person for decision or judgment.*

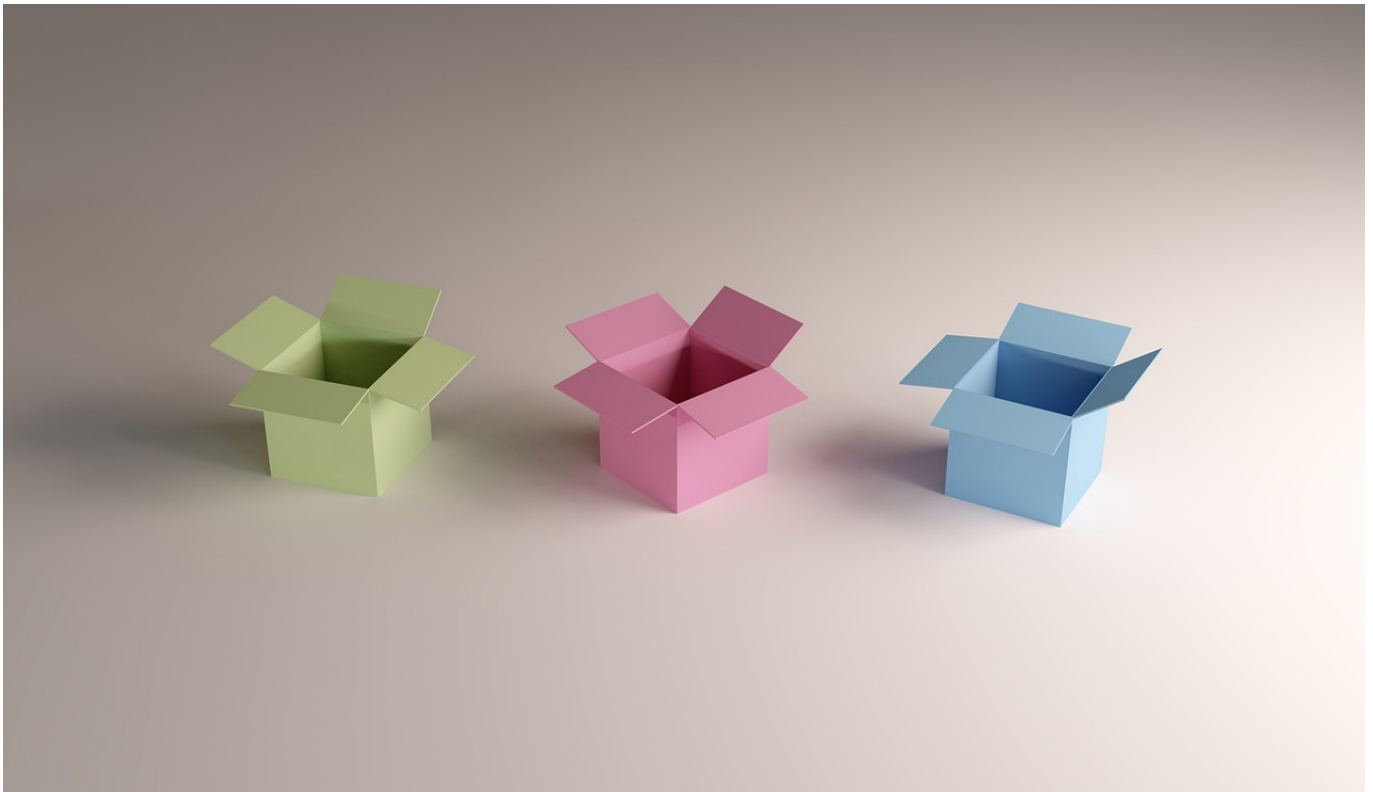
<b>accept</b>	Make use of or accept for some purpose. <i>What if Elizabeth <b>accepted</b> Darcy the first time.</i>
<b>acquiesce</b>	Accept something reluctantly but without protest. <i>Sara <b>acquiesced</b> in his decision.</i>
<b>adduce</b>	Advance evidence for. <i>A number of factors are <b>adduced</b> to explain the situation.</i>
<b>adhere to</b>	Come or be in close contact with; stick or hold together and resist separation.
<b>advance</b>	Pay in advance. <i><b>Advance</b> an argument.</i>
<b>advocate</b>	Publicly recommend or support. <i>Voters supported candidates who <b>advocated</b> an Assembly.</i>

<b>assert</b>	Postulate positively and assertively. <i>He <b>asserted</b> his innocence.</i>
<b>aver</b>	Allege as a fact in support of a plea. <i>The defendant does not <b>aver</b> any performance by himself.</i>
<b>back down</b>	Give support or one's approval to.
<b>be governed by</b>	Have life, be alive.
<b>be regulated by</b>	Work in a specific place, with a specific subject, or in a specific function.
<b>be subject to</b>	Have an existence, be extant.
<b>bow</b>	Play on a stringed instrument with a bow. <i>The government <b>bowed</b> to the military pressure.</i>
<b>brook</b>	Put up with something or somebody unpleasant.
<b>capitulate</b>	Cease to resist an opponent or an unwelcome demand; yield. <i>The patriots had to <b>capitulate</b> to the enemy forces.</i>
<b>cave in</b>	Hollow out as if making a cave or opening.
<b>claim</b>	Lay claim to as of an idea. <i>The attacks <b>claimed</b> the lives of five people.</i>
<b>come up with</b>	Reach a destination; arrive by movement or progress.

<b><u>contend</u></b>	Succeed in doing, achieving, or producing (something) with the limited or inadequate means available. <i>He <b>contended</b> that Communism had no future.</i>
<b>defer</b>	Hold back to a later time. <i>He was no longer <b>deferred</b> from the draft.</i>
<b><u>endure</u></b>	Continue to live and avoid dying. <i>The legend of Elvis <b>endures</b>.</i>
<b>give in</b>	Organize or be responsible for.
<b>give way</b>	Bestow.
<b>heed</b>	Pay close attention to give heed to. <i>He should have <b>heeded</b> the warnings.</i>
<b>introduce</b>	Introduce. <i><b>Introduce</b> the new neighbors to the community.</i>
<b>lodge</b>	Be a lodger stay temporarily. <i>The money is <b>lodged</b> in a bank.</i>
<b><u>moot</u></b>	Think about carefully; weigh. <i>The scheme was first <b>mooted</b> last October.</i>
<b>move</b>	Move so as to change position perform a nontranslational motion. <i>The director <b>moved</b> more responsibilities onto his new assistant.</i>
<b><u>observe</u></b>	Observe with care or pay close attention to. <i>A minute s silence will be <b>observed</b>.</i>
<b>offer</b>	Present or proffer something for someone to accept or reject as desired. <i>He <b>offered</b> to fix the gate.</i>
<b>pass on</b>	Allow to go without comment or censure.
<b><u>posit</u></b>	Put in position place. <i><b>Deposit</b> the suitcase on the bench.</i>

<b><u>postulate</u></b>	Take as a given assume as a postulate or axiom. <i>The chapter was then allowed to <b>postulate</b> the bishop of Bath.</i>
<b>present</b>	Present somebody with something usually to accuse or criticize. <i>We <b>presented</b> the arguments to him.</i>
<b>proffer</b>	Hold out or put forward (something) to someone for acceptance. <i>He <b>proffered</b> his resignation.</i>

<b>resign</b>	Accept that something undesirable cannot be avoided. <i>The chairman <b>resigned</b> over the financial scandal.</i>
<b>set forth</b>	Apply or start.
<b>state</b>	Indicate through a symbol, formula, etc. <i>The report <b>stated</b> that more than 51 per cent of voters failed to participate.</i>
<b>stomach</b>	Endure or accept (an obnoxious thing or person). <i>He cannot <b>stomach</b> raw fish.</i>
<b><u>suggest</u></b>	Suggest the necessity of an intervention in medicine. <i>The seduction scenes <b>suggest</b> his guilt and her loneliness.</i>

<b>take</b>	Be designed to hold or take. <i>An exclusive island hideaway that <b>takes</b> just twenty guests.</i>
<b>tender</b>	Make a tender of in legal settlements. <i><b>Tenderize</b> meat.</i>
<b>tolerate</b>	Put up with something or somebody unpleasant. <i>We must <b>tolerate</b> the religions of others.</i>
<b>treat with</b>	Regard or consider in a specific way.
<b>venture</b>	Undertake a risky or daring journey or course of action. <i>He <b>ventured</b> the opinion that Putt was insane.</i>
<b>volunteer</b>	Do volunteer work. <i>He <b>volunteered</b> his services as a driver for the convoy.</i>
<b>yield</b>	Produce or provide (a natural, agricultural, or industrial product). <i>I <b>yielded</b> the point.</i>

<b>petition</b>	Write a petition for something to somebody request formally and in writing. <i>A steady stream of <b>petitions</b> to Allah were audible.</i>
<b>pose</b>	A posture assumed by models for photographic or artistic purposes. <i>An armed gang <b>posed</b> as policemen to ambush a postman.</i>
<b>posit</b>	Logic a proposition that is accepted as true in order to provide a basis for logical reasoning. <i>He <b>posited</b> three basic laws of nature.</i>
<b>presentation</b>	A visual representation of something. <i>The <b>presentation</b> of foods is designed to stimulate your appetite.</i>
<b>proffer</b>	An offer or proposal. <i>He <b>proffered</b> his resignation.</i>
<b>proposal</b>	The act of making a proposal. <i>A set of <b>proposals</b> for a major new high speed rail link.</i>
<b>propose</b>	Propose or intend. <i>I have already <b>proposed</b> to Sarah.</i>
<b>proposition</b>	A statement or assertion that expresses a judgement or opinion. <i>Needless to say she refused his frank sexual <b>proposition</b>.</i>
<b>propound</b>	Put forward, as of an idea. <i>He began to <b>propound</b> the idea of a social monarchy as an alternative to Franco.</i>

<b>recommend</b>	Push for something. <i>The travel agent <b>recommended</b> strongly that we not travel on Thanksgiving Day.</i>
<b>recommendation</b>	Any quality or characteristic that gains a person a favorable reception or acceptance or admission. <i>The committee put forward forty <b>recommendations</b> for change.</i>
<b>resignation</b>	A document conveying someone's intention of resigning. <i>He submitted his <b>resignation</b> as of next month.</i>
<b>subpoena</b>	Summon someone with a subpoena. <i>A <b>subpoena</b> may be issued to compel their attendance.</i>
<b>suggest</b>	Suggest the necessity of an intervention in medicine. <i>A simpler explanation <b>suggested</b> itself to me.</i>
<b>suggestion</b>	Persuasion formulated as a suggestion. <i>The power of <b>suggestion</b>.</i>
<b>supplicant</b>	A person making a humble or earnest plea to someone in power or authority. <i><b>Supplicants</b> prostrate themselves on the floor.</i>
<b>testimonial</b>	Of or relating to or constituting testimony. <i>A <b>testimonial</b> match.</i>
<b>tribute</b>	Denoting or relating to a group or musician that performs the music of a more famous one and typically imitates them in appearance and style of performance. <i>A <b>tribute</b> show.</i>
<b>yield</b>	Consent reluctantly. <i>They are forced to <b>yield</b> ground.</i>
