- *A grant paid by a government to an enterprise that benefits the public.*
- *A sum of money granted by the state or a public body to help an industry or business keep the price of a commodity or service low.*
- *A grant or contribution of money.*
- *A parliamentary grant to the sovereign for state needs.*
- *A tax levied on a particular occasion.*

- assets** Anything of material value or usefulness that is owned by a person or company.
- benefaction** A donation or gift.
*Take official receipt of such **benefaction**.*

capital	The city or town that functions as the seat of government and administrative centre of a country or region. <i>The drug capital of Columbia.</i>
cash	Money in coins or notes, as distinct from cheques, money orders, or credit. <i>The staff were paid in cash.</i>
contribution	The part played by a person or thing in bringing about a result or helping something to advance. <i>Local historians are requesting contributions for a forthcoming book on the history of the community.</i>
donation	The action of donating something. <i>The donation of carpets chairs and cutlery.</i>
endowment	The action of endowing something or someone. <i>He tried to promote the endowment of a Chair of Psychiatry.</i>
funds	Assets in the form of money.
gift	An act of giving something as a present. <i>He has a gift for comedy.</i>
grant	The action of granting something. <i>A research grant.</i>
handout	A quantity of financial or other material aid given to a person or organization. <i>Dependence on central government handouts.</i>
income	The financial gain (earned or unearned) accruing over a given period of time. <i>Figures showed an overall increase in income this year.</i>
investment	A thing that is worth buying because it may be profitable or useful in the future. <i>A total investment of 50 000.</i>
money	Sums of money. <i>The college is very short of money.</i>
present	A present tense. <i>He lives in the present with no thought of tomorrow.</i>
reserves	Civilians trained as soldiers but not part of the regular army.
resources	A source of aid or support that may be drawn upon when needed. <i>The local library is a valuable resource.</i>
revenue	The department of the civil service collecting state revenue. <i>The government s tax revenues.</i>

- stock** Farm animals such as cattle pigs and sheep bred and kept for their meat or milk livestock.
*Government gilt edged **stock**.*
- wealth** The state of being rich; material prosperity.
*Great **wealth** is not a sign of great intelligence.*
- wherewithal** The necessary means (especially financial means).
*They lacked the **wherewithal** to pay.*

annuity	Income from capital investment paid in a series of regular payments. <i>He left her an annuity of 1 000 in his will.</i>
behalf	For someone s benefit usually expressed as in behalf rather than on behalf and usually with a possessive. <i>In your behalf.</i>
benefit	Derive a benefit from. <i>Part time jobs supplemented by means tested benefits.</i>
buyer	A person who makes a purchase.
duty	Performance of prescribed church services by a priest or minister. <i>A strong sense of duty.</i>
earnings	Money obtained in return for labour or services. <i>Export earnings.</i>
emolument	Compensation received by virtue of holding an office or having employment (usually in the form of wages or fees). <i>The directors emoluments.</i>
expenditure	The use of energy, time, or other resources. <i>The expenditure of taxpayers money.</i>
fund	Provide a fund for the redemption of principal or payment of interest. <i>A concert to raise funds for the church.</i>

income	Money received, especially on a regular basis, for work or through investments. <i>Figures showed an overall increase in income this year.</i>
lucre	Informal terms for money. <i>Officials getting their hands grubby with filthy lucre.</i>
overpay	Pay (money) in excess of what is due. <i>If with hindsight you have overpaid, all is not lost.</i>
payable	A liability account showing how much is owed for goods and services purchased on credit. <i>Accounts payable excluding customer refunds and construction payables.</i>
payment	Something given as a reward or in recompense for something done. <i>A compensation payment of 2500.</i>
pension	Dismiss someone from employment typically because of age or ill health and pay them a pension. <i>Garden sheds were raided to bring out machines long since pensioned off.</i>
perquisite	A benefit which one enjoys or is entitled to on account of one's job or position. <i>The perquisites of celebrity are intoxicating.</i>
proceeds	Money obtained from an event or activity. <i>Proceeds from the event will go to aid the work of the charity.</i>
profit	Make a profit gain money or materially. <i>It would profit us to change our plans.</i>
profitability	The quality of affording gain or benefit or profit. <i>Profitability may not improve until well into next year.</i>
receivable	Awaiting payment. <i>Accounts receivable.</i>
remuneration	The act of paying for goods or services or to recompense for losses. <i>Adequate remuneration for his work.</i>
revenue	The department of the civil service collecting state revenue. <i>His priority was to raise government revenue and to lower expenditure.</i>
salary	Pay a salary to. <i>The Chinese system salary the doctor and stop his pay when you get ill.</i>
tariff	Fix the price of something according to a tariff. <i>The reduction of trade barriers and import tariffs.</i>
tax	Impose a tax on someone or something. <i>A tax on fuel.</i>

taxable	Subject to taxation. <i>Taxable income.</i>
taxation	Government income due to taxation. <i>Direct taxation was low.</i>
taxpayer	A person who pays taxes. <i>A waste of taxpayers money.</i>
vat	Place or treat in a vat. <i>The grapes are vatted for between 15 and 21 days and then aged in small barrels.</i>
wage	Carry on (wars, battles, or campaigns). <i>An income of less than half the average wage.</i>
