acquire	Win something through one’s efforts. <i>I ve acquired a taste for whisky.</i>
acquisition	An ability that has been acquired by training. <i>The acquisition of self control.</i>
annuitant	A person who receives an annuity.
bank	An elevation in the seabed or a riverbed a mudbank or sandbank. <i>I banked the eight ball off two cushions.</i>
bill	Send a bill to someone. <i>We were billed for 4 nights in the hotel although we stayed only 3 nights.</i>
compensation	The action or process of awarding compensation. <i>He is seeking compensation for injuries suffered at work.</i>
confiscation	The action of taking or seizing someone’s property with authority; seizure. <i>A court ordered the confiscation of her property.</i>
contribution	The part played by a person in bringing about a result. <i>Local historians are requesting contributions for a forthcoming book on the history of the community.</i>
debit	Enter as debit. <i>10 000 was debited from their account.</i>
due	A payment that is due e g as the price of membership. <i>Talks are due to adjourn tomorrow.</i>
<u>expenditure</u>	The use of energy, time, or other resources. <i>Cuts in public expenditure.</i>
fee	Money paid as part of a special transaction, for example for a privilege or for admission to something. <i>They were faced with legal fees of 3000.</i>

forfeiture	Something that is lost or surrendered as a penalty. <i>Magistrates ordered the forfeiture of his computer.</i>
holder	A smallholder. <i>An umbrella holder.</i>
income	The financial gain (earned or unearned) accruing over a given period of time. <i>Figures showed an overall increase in income this year.</i>
installment	A part of a published serial.
levy	An act of levying a tax fee or fine. <i>There were no goods to levy upon.</i>
outlay	Money paid out; an amount spent. <i>A modest outlay on local advertising.</i>
pay	Convey, as of a compliment, regards, attention, etc.; bestow. <i>Pay a call.</i>
payable	A liability account showing how much is owed for goods and services purchased on credit. <i>Interest is payable on the money owing.</i>
property	Shares or investments in property. <i>Rights of property.</i>
purchase	Something acquired by purchase. <i>She made her purchases carefully.</i>
receivable	Awaiting payment. <i>Accounts receivable.</i>
resignedly	With resignation and acceptance; in a resigned manner.
sequesterate	Set apart from others. <i>The power of courts to sequesterate the assets of unions.</i>
tax	Impose a tax on someone or something. <i>They will have to pay tax on interest earned by savings.</i>
taxable	(of goods or funds) subject to taxation. <i>Taxable income.</i>
tithe	Exact a tithe from. <i>He tithed his income to the Church.</i>
vat	Place or treat in a vat. <i>A vat of hot tar.</i>
