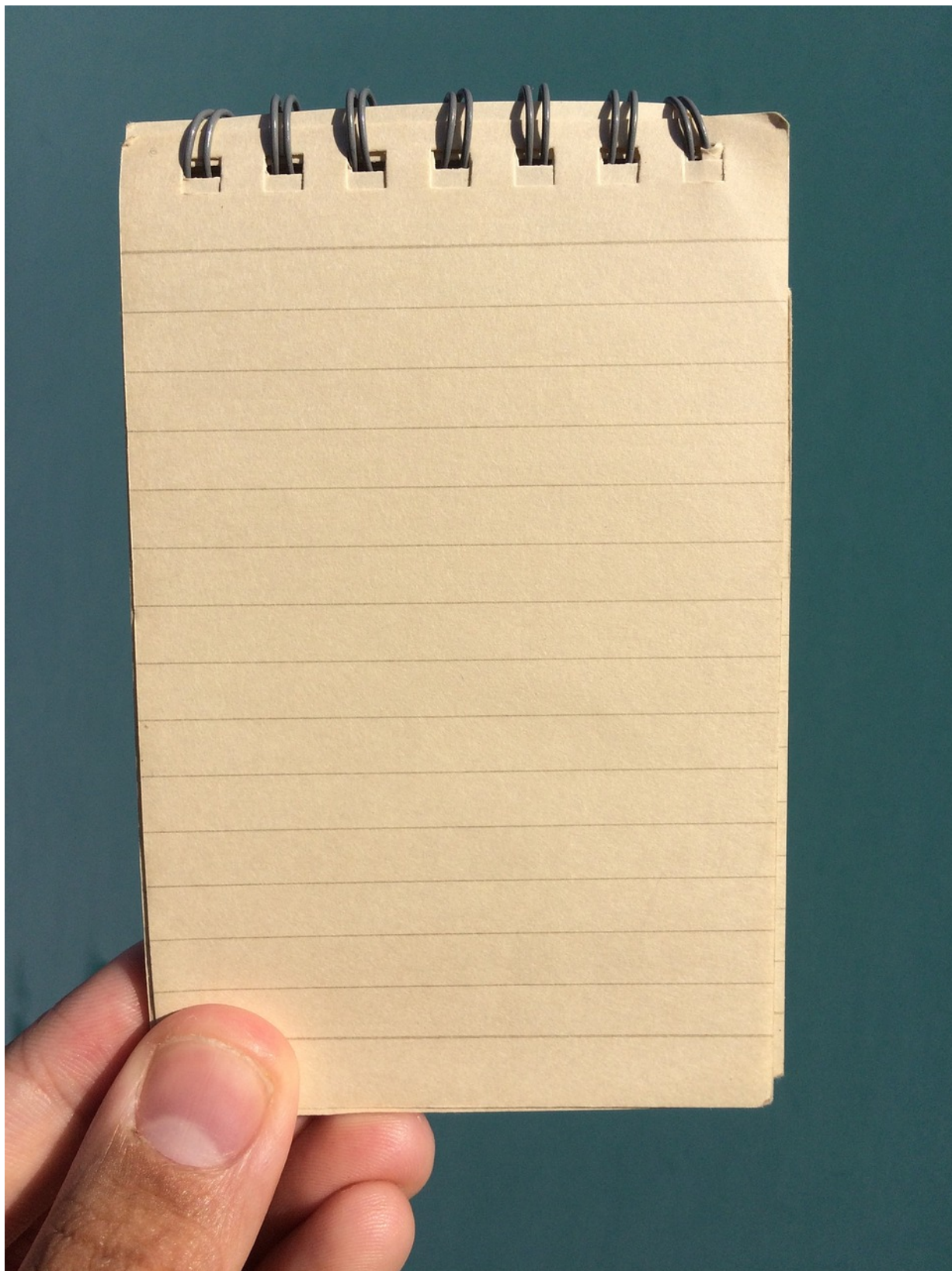

## Testimony as a Noun

### Definitions of "Testimony" as a noun

According to the [Oxford Dictionary of English](#), “testimony” as a noun can have the following definitions:

- *A solemn protest or declaration.*
- *Evidence or proof of something.*
- *A solemn statement made under oath.*
- *An assertion offering firsthand authentication of a fact.*
- *Something that serves as evidence.*
- *A public recounting of a religious conversion or experience.*
- *A formal written or spoken statement, especially one given in a court of law.*



## Synonyms of "Testimony" as a noun (7 Words)

<b><u>affidavit</u></b>	A written statement confirmed by oath or affirmation, for use as evidence in court. <i>A former employee swore an <b>affidavit</b> relating to his claim for unfair dismissal.</i>
<b><u>attestation</u></b>	The action of bearing witness. <i>All employees must provide a written <b>attestation</b> that they have read and abided by this code.</i>
<b>evidence</b>	Signs or indications of something. <i>His trembling was <b>evidence</b> of his fear.</i>
<b><u>proof</u></b>	The strength of distilled alcoholic spirits relative to proof spirit taken as a standard of 100. <i>This is not a <b>proof</b> for the existence of God.</i>
<b><u>testament</u></b>	A profession of belief. <i>He stated his political <b>testament</b>.</i>
<b><u>testimonial</u></b>	A formal statement testifying to someone's character and qualifications. <i>A <b>testimonial</b> match.</i>
<b>witness</b>	A person who testifies under oath in a court of law. <i>Oral evidence set down in <b>witness</b> statements.</i>







## Usage Examples of "Testimony" as a noun

- *His blackened finger was testimony to the fact that he had played in pain.*
- *His effort was testimony to his devotion.*
- *According to his own testimony he can't do it.*
- *The testimony of an eyewitness.*



## Associations of "Testimony" (30 Words)

### [accomplice](#)

A person who joins with another in carrying out some plan (especially an unethical or illegal plan).

An ***accomplice*** in the murder.

<b>accuser</b>	A person who claims that someone has committed an offence or done something wrong. <i>I dislike any law that puts the burden of proof on the accused rather than the <b>accuser</b>.</i>
<b>adduce</b>	Advance evidence for. <i>A number of factors are <b>adduced</b> to explain the situation.</i>
<b><u>alibi</u></b>	Exonerate by means of an alibi. <i>Every day he had a new <b>alibi</b> for not getting a job.</i>
<b>allege</b>	Report or maintain. <i>He <b>alleged</b> that he had been assaulted.</i>
<b><u>attest</u></b>	Provide evidence for; stand as proof of; show by one's behavior, attitude, or external attributes. <i>The witnesses must <b>attest</b> and sign the will in the testator's presence.</i>
<b>certification</b>	Validating the authenticity of something or someone. <i>The <b>certification</b> of teachers.</i>
<b>complicity</b>	Guilt as an accomplice in a crime or offense. <i>They were accused of <b>complicity</b> in the attempt to overthrow the government.</i>
<b>conspirator</b>	A person who takes part in a conspiracy. <i><b>Conspirators</b> had planned to seize the state.</i>
<b>corroboration</b>	Evidence which confirms or supports a statement, theory, or finding; confirmation. <i>There is no independent <b>corroboration</b> for this.</i>
<b>corroborative</b>	Serving to support or corroborate.
<b>court</b>	A room in which a lawcourt sits. <i>The emperor is shown with his <b>court</b>.</i>
<b>courtroom</b>	A room in which a lawcourt sits. <i>Television cameras were admitted in the <b>courtroom</b>.</i>
<b>demonstrate</b>	Establish the validity of something, as by an example, explanation or experiment. <i>Their shameful silence <b>demonstrates</b> their ineptitude.</i>
<b>evidence</b>	Provide evidence for. <i>The <b>evidence</b> that smoking causes lung cancer is very compelling.</i>
<b>eyewitness</b>	Be present at an event and see it with one's own eyes. <i><b>Eyewitness</b> accounts of the London blitz.</i>
<b><u>implicate</u></b>	Show (someone) to be involved in a crime. <i>Viruses are known to be <b>implicated</b> in the development of certain cancers.</i>

<b>inquest</b>	<p>A discussion or investigation into something that has happened, especially something undesirable.</p> <p>An <b>inquest</b> by New York newspapers into a subway fire.</p>
<b><u>justify</u></b>	<p>Adjust (a line of type or piece of text) so that the print fills a space evenly or forms a straight edge at the margin.</p> <p>The situation was grave enough to <b>justify</b> further investigation.</p>
<b><u>liability</u></b>	<p>A thing for which someone is responsible, especially an amount of money owed.</p> <p>She said the party had become a <b>liability</b> to green politics.</p>
<b>perjure</b>	<p>Knowingly tell an untruth in a legal court and render oneself guilty of perjury.</p> <p>She admitted that she had <b>perjured</b> herself.</p>
<b>probate</b>	<p>Put a convicted person on probation by suspending his sentence.</p> <p>She has been granted a <b>probate</b> to execute her late father's estate.</p>
<b><u>proof</u></b>	<p>Proofread a text.</p> <p><b>Proof</b> the materials against shrinking in the dryer.</p>
<b>prosecution</b>	<p>The institution and conduct of legal proceedings against a defendant for criminal behavior.</p> <p>The main witness for the <b>prosecution</b>.</p>
<b>prove</b>	<p>Prove formally demonstrate by a mathematical formal proof.</p> <p>If they are <b>proved</b> guilty we won't trade with them.</p>
<b>sue</b>	<p>French writer whose novels described the sordid side of city life (1804-1857).</p> <p>I <b>sued</b> for breach of contract.</p>
<b>testify</b>	<p>Serve as evidence or proof that something exists or is the case.</p> <p>The bleak lines <b>testify</b> to inner torment.</p>
<b>validate</b>	<p>Give evidence for.</p> <p><b>Validate</b> a ticket.</p>
<b>verification</b>	<p>Additional proof that something that was believed (some fact or hypothesis or theory) is correct.</p> <p>The <b>verification</b> principle.</p>
<b>witness</b>	<p>Be a witness to.</p> <p>She <b>witnessed</b> the accident and had to testify in court.</p>
